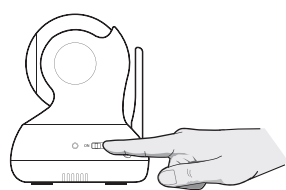
Step 1: Plug in*



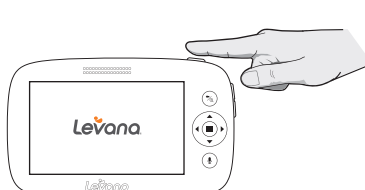
NOTE: Fully charge monitor battery before 1st use & charge daily. The monitor may take up to 4 hours to charge.

**Additional power adapter for monitor included.*

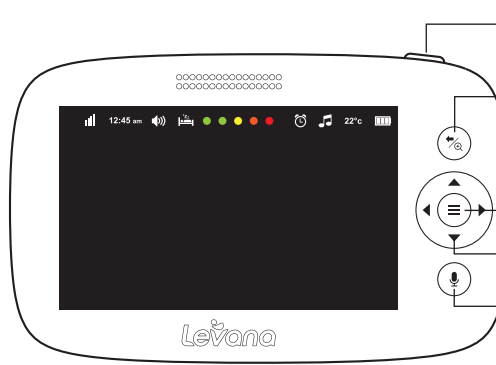
Step 2: Power ON Camera

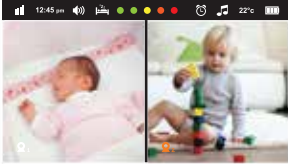

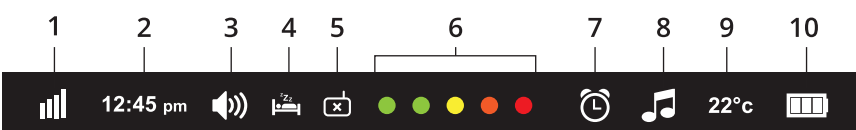

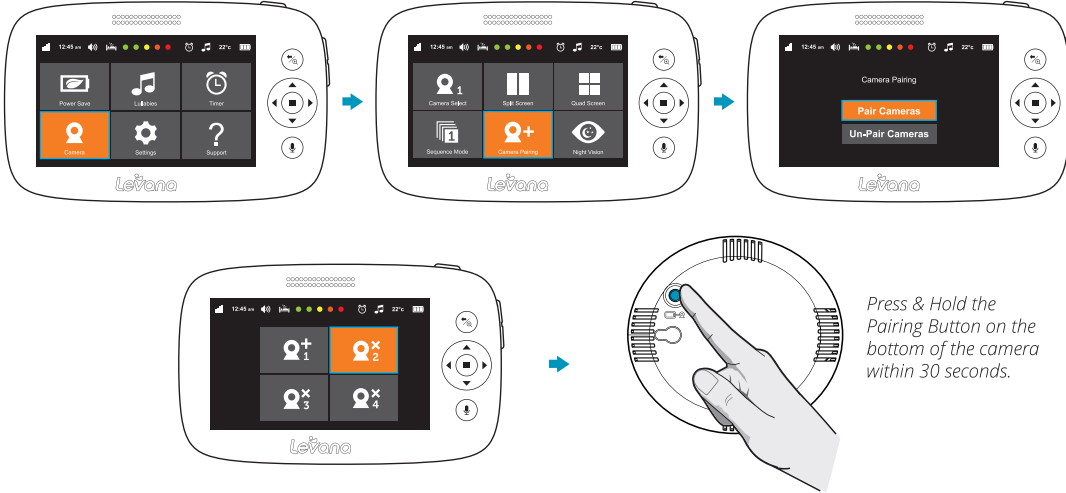

Étape 1: branchez le cordon d'alimentation* / Paso 1: Enchufe el cable de alimentación*

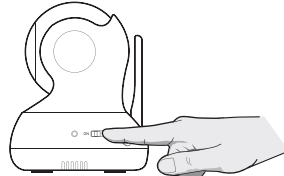

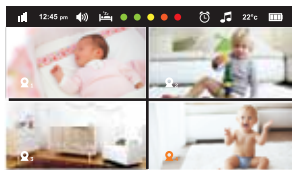
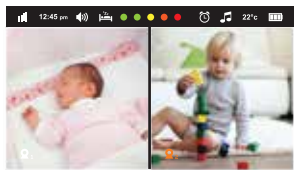
Étape 3: Moniteur d'alimentation (maintenez enfoncé pendant 2 secondes)

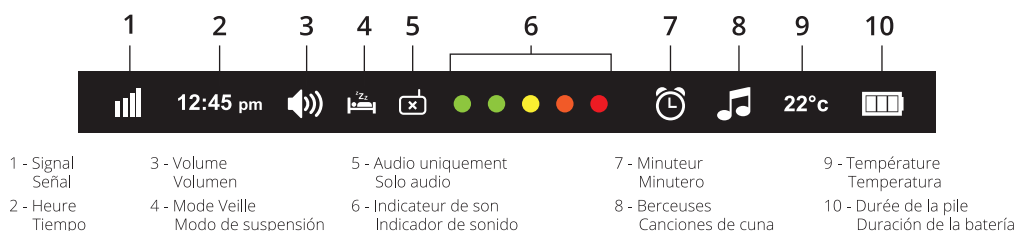

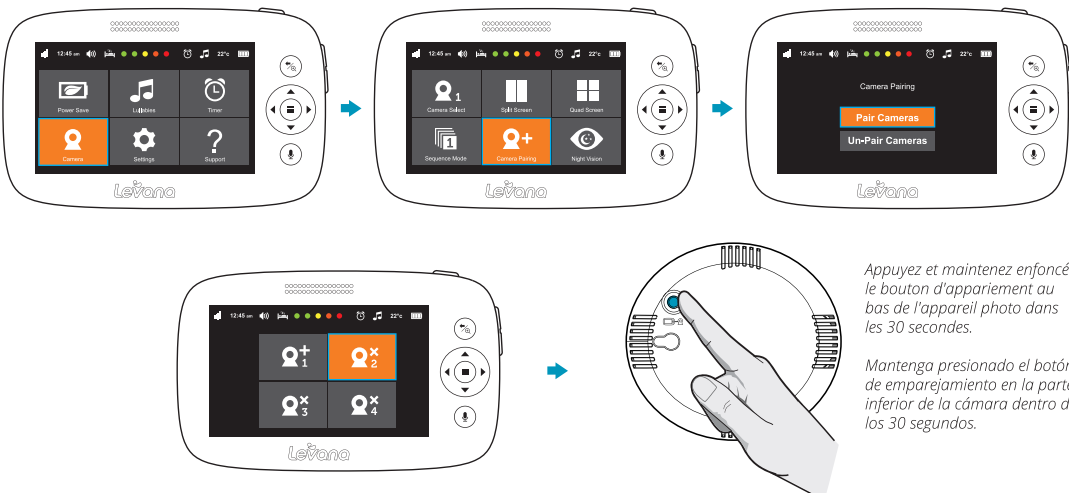

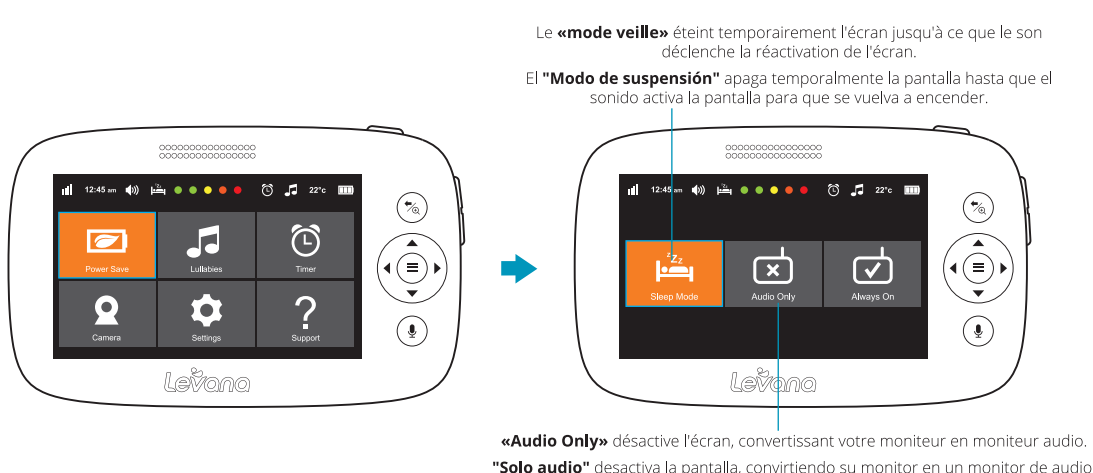
