7.2. The Requirement For Section 15.247(e)

Section 15.247(e): For digitally modulated systems, the power spectral density conducted from the intentional radiator to the antenna shall not be greater than 8 dBm in any 3 kHz band during any time interval of continuous transmission.

8.1.Block Diagram of Test Setup



8.2. The Requirement For Section 15.247(d)

Section 15.247(d): In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph (b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB. Attenuation below the general limits specified in Section 15.209(a) is not required. In addition, radiated emissions which fall in the restricted bands, as defined in Section 15.205(a), must also comply with the radiated emission limits specified in Section 15.209(a).

- 8.5.3. The EUT is placed on a turntable, which is 0.1m above the ground plane and worked at highest radiated power.
- 8.5.4. The turntable was rotated for 360 degrees to determine the position of maximum emission level.
- 8.5.5.EUT is set 3m away from the receiving antenna, which is varied from 1m to 4m to find out the highest emission.





9.1.1.Block diagram of connection between the EUT and peripherals




Setup: Transmitting mode

(B)Radiated Emission Test Set-Up, Frequency 30MHz-1GHz



9.2. The Limit For Section 15.247(d)

Section 15.247(d): In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph (b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB. The antenna can be moved up and down between 1.0 meter and 4 meters to find out the maximum emission level. Broadband antenna (calibrated bi-log antenna) is used as receiving antenna. Both horizontal and vertical polarizations of the antenna are set on measurement. In order to find the maximum emission levels, all of the EUT location must be manipulated according to ANSI C63.10:2013 on radiated emission measurement. This EUT was tested in 3 orthogonal positions and the worst case position data was reported.

The bandwidth of test receiver is set at 9 kHz in below 30MHz. and set at 120 kHz in 30-1000MHz, and 1MHz in above 1000MHz.

The final measurement in band 9-90 kHz, 110-490 kHz and above 1000MHz is performed with Average detector. Except those frequency bands mention above, the final measurement for frequencies below 1000MHz is performed with Quasi Peak detector. The field strength is calculated by adding the antenna factor, and cable loss, and subtracting the amplifier gain from the measured reading.

The EUT is put on the plane 0.8m high above the ground by insulating support and is connected to the power mains through a line impedance stabilization network (L.I.S.N.). This provides a 50ohm coupling impedance for the EUT system. Please refer the block diagram of the test setup and photographs. Both sides of AC lines are checked to find out the maximum conducted emission. In order to find the maximum emission levels, the relative positions of equipment and all of the interface cables shall be changed according to ANSI C63.10: 2013 on Conducted Emission Measurement.

The bandwidth of test receiver is set at 9kHz.

The frequency range from 150kHz to 30MHz is checked.


11.ANTENNA REQUIREMENT
