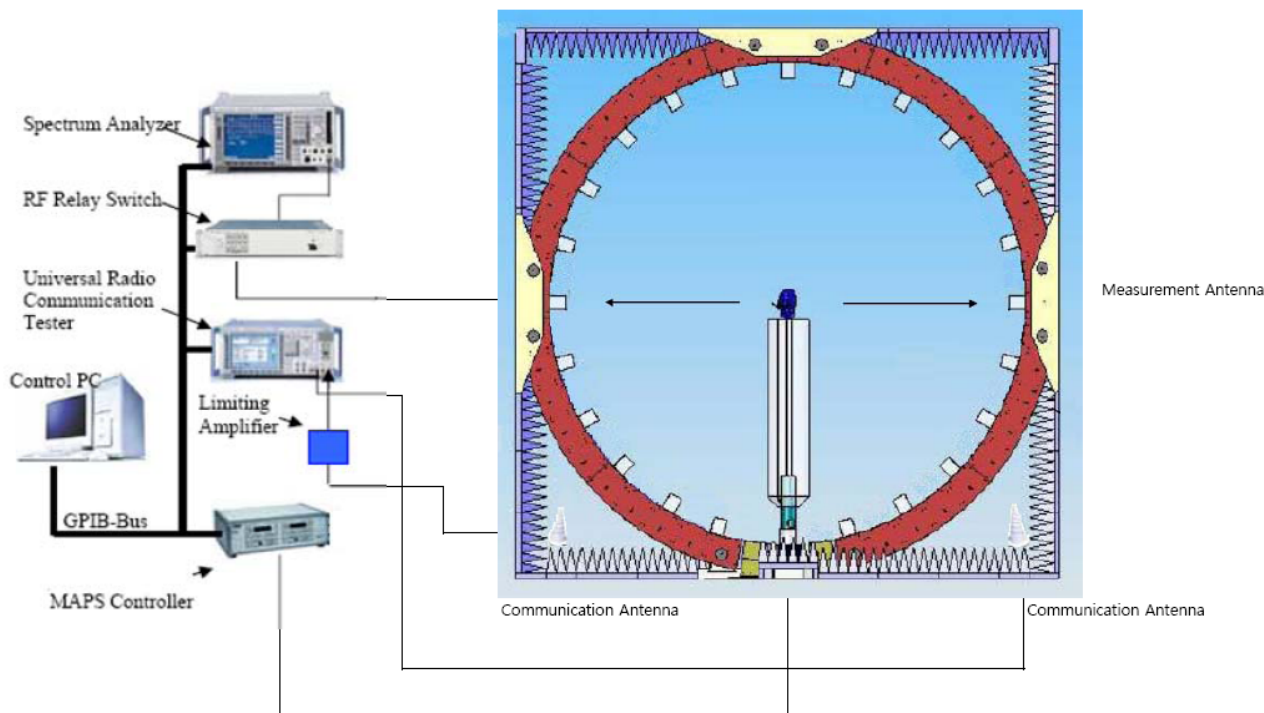

## 8 3-D Antenna Pattern



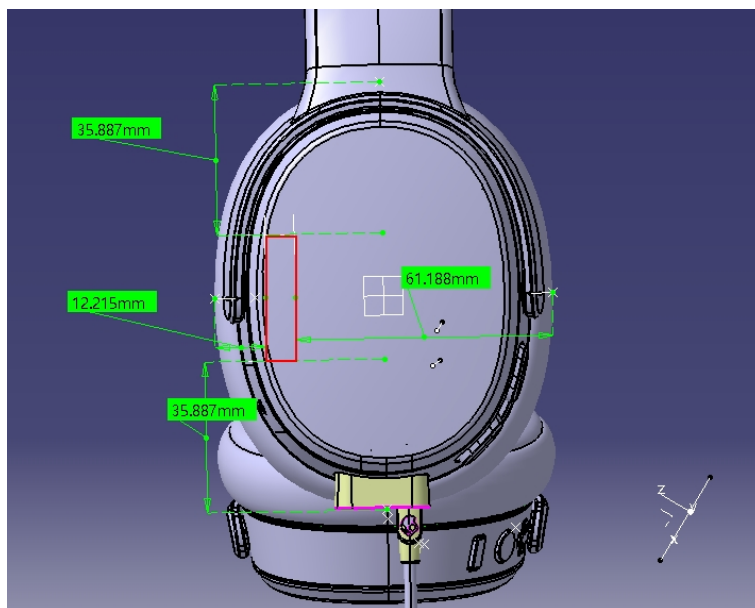
