Chapter 2

Device Care

This section describes the basic handling precaution of the device.

IP Specification	Description
IP67	Allows your device to withstand adverse field conditions such as being submersed in water between 15 cm and 1 m for 30 minutes or dust tight for 2–8 hours.

- If your device has been submersed in water, shake your device and wired earpiece well to remove any water that may be trapped inside the speaker and microphone port. Trapped water could cause decreased audio performance.
- Never poke the vent (hole) located on the device back casing on top of the battery compartment. This vent allows for pressure equalization in the device. Doing so may create a leak path into your device, and your device's submersibility may be lost.
- · Never obstruct or cover the vent, even with a label.
- Ensure that no oily substances come in contact with the vent.
- Your device is designed to be submersible to a maximum depth of 1 m (3.28 ft) and a maximum submersion time of 30 minutes. Exceeding either maximum limit or use may result in damage to your device.
- When cleaning your device, do not use a high-pressure jet spray on device as this will exceed the 1 m depth pressure and may cause water to leak into your device.

Cleaning Your Device

Prerequisites: Ensure that you have the following items:

- Gloves or other PPE as applicable
- Detergent
- Water
- Dish cloths
- Stiff, non-metallic, and short bristled brush
- · Soft, absorbent, and lint-free cloths

Procedure:

1 Mix a 0.5 % detergent-water solution.

- 2 Apply the detergent-water solution with a dish cloth and wipe down and clean your device.
- 3 Using a stiff, non-metallic, and short bristled brush, remove any loose dirt from your device.
- 4 Using a soft, absorbent, and lint-free cloths, wipe away the solution and dry your device.
- 5 Ensure that there are no solutions left in or near any connectors, cracks, or crevices.

Disinfecting Your Device

Prerequisites: Ensure that you have the following items:

- Gloves or other PPE as applicable
- Over-the-counter isopropyl alcohol (rubbing alcohol) with at least 70% alcohol concentration
- Dish cloths
- Soft, absorbent, and lint-free cloths

Procedure:

1 Apply the rubbing alcohol to a dish cloth and wipe down your device.



Never apply alcohol directly to your device.

Getting Started

This chapter provides instructions on how to prepare your device for use.

4.1 Charging the Device

Procedure:

Perform one of the following actions:

Option	Action
Using the USB-C charger	Plug the charging cable to USB power source.

For ongoing charging, your device shows the following indications:

- The bar LED blinks rapidly for three minutes.
- The top and bottom crescent red LED illuminates.

If there is an error during charging, your device shows the following indications:

- For MUC charging, the top and bottom red crescent LED blinks.
- For USB charging, the bottom red crescent LED blinks.

4.2 **Turning the Device On or Off**

Turning the Device On

Procedure:

Press and hold the **Power** button.

If your device turns on successfully, your device shows the following indications:

- · The device vibrates.
- The two-bar LED illuminates and scrolls.

If your device fails to turn on, your device shows the following indications:

- The device vibrates.
- The top and bottom red crescent LED illuminates.

NOTE: Contact your dealer or administrator for more information regarding power on issue.

Turning the Device Off

Procedure:

Press and hold the **Power** button.

If your device turns off, your device shows the following indications:

- The device vibrates.
- The top and bottom red crescent LED illuminates.
- The bar-LED turns off after countdown.

^{4.3} Adjusting the Volume

This settings allows you to adjust the device volume.

Procedure:

- 1 Perform one of the following actions:
 - To increase the volume, press the **Volume Up** button.
 - To decrease the volume, press the Volume Down button.



NOTE: Volume LED bar appears when you adjust the volume.



Twist the ear tip anticlockwise until you hear a click and detach the ear tip.





4.7 Wearing Your Device

The device is designed to be worn on the body. A set of accessories offer comfortable and secure wearing.




4.7.1 Attaching the Badge Clip

Procedure:

1 Slide the badge clip from downwards of the lanyard slot.



2 Buckle up the badge clip strap.




4.7.2 Attaching the Device to the Holster

Procedure:

1 Slide the bottom of the device into the holster until it snaps into place.



2 Secure the device by pressing the top of the device until you hear a "click" sound.



4.8 Activating the Preconfigured Wi-Fi Access Point (PWAP)

This feature provides a temporary Wi-Fi connection for the device to download the configurations from the portal. Instead of the manual configuration through the Maintenance Mode Web Server, you can use the preconfigured Wi-Fi access point for initial Wi-Fi connection.

Prerequisites: Ensure your device is in the User Mode and has no internet connection.

Procedure:

To connect to the PWAP, press the **Power** button and **Volume Up** button simultaneously.

Basic Device Operation

This section explains the basic operations that you can perform on your device.

5.1

Navigating the Status and Menu List

This section shows you the operations available and instructions to navigate the Status and Menu List. **When and where to use:** To identify the device Menu features.

Menu Feature	Description
Instant Personal Alert (IPA) List	Listen to all Instant Personal Alerts until cleared.
Battery Level Status	Listen to device battery level.
Talkgroup List	Change the Talkgroup.
Contact List	Select a contact.
Do Not Disturb (DND)	Turn the Do Not Disturb feature on or off.
PTT Lock	Turn the PTT Lock feature on or off.
Bluetooth	Turn the Bluetooth on or off.

Procedure:

- 1 To enter Status and Menu Mode, press the **Power** button.
- 2 To navigate through the Status and Menu List, press the **Power** button again within the 5 second timeout period.

The device sounds the current selected value or item through Voice Announcement as the user scrolls through the list. A wrap tone sounds when the user reaches the end of the list.

3 To toggle the Menu feature, press the Volume Up or Volume Down button.

The device sounds the current selected value or item through Voice Announcement as the user toggles the options.

- 4 To exit the Status and Menu List, do one of the following actions:
 - Wait for the 5 second timer to expire and for the device to sound a positive tone.
 - Press a button that overrides the Status and Menu Mode, such as the **PTT** or the **Voice Assistant** button.

5.2 Initiating Voice Assistant

Voice Assistant allows you to manage your device and perform information lookups using voice commands.



NOTE: This feature can only be used with a wired or Bluetooth accessory.

Prerequisites: Ensure an accessory is connected.

Procedure:

- 1 Press the Voice Assistant button.
- 2 After you hear a tone, speak your command into the accessory microphone.

5.2.1 Voice Assistant Commands

The following commands are examples you can use to operate the device. There are no specific commands. You may speak your intended commands in approximate terms.



NOTE:

Locking and Unlocking PTT

The default setting for PTT Lock feature is "Unlock". When you power cycle your device, the PTT Lock settings is set to the default setting.

A voice announcement sounds to prompt the user if the PTT is locked for a certain amount of time. This feature is configurable through the WAVE PTX Portal.

Type of Calls

When you receive calls, your device shows the following indications:

- For private call only, the device vibrates.
- A tone sounds.
- The top crescent green LED blinks twice continuously.

The call ends if you press the **Voice Assistant** button or **Menu** button.

Supervisory Override

Supervisory Override allows a supervisor to interrupt an ongoing talkgroup call and immediately start a supervisory call. A supervisor is configured on the WAVE PTX Portal by selecting and configuring a user as a supervisor within a talkgroup.

When Supervisory Override is initiated, the the top crescent green LED blinks twice continuously on the receiving device until the supervisory call ends.

Any talkgroup call in progress may be interrupted by a supervisor. When the call is taken over by the supervisor, the receiving and transmitting devices unmutes automatically to the supervisory call with receiving call LED notification.

If a designated supervisor presses the **PTT** button while receiving a talkgroup call, the talkgroup call is overridden by a supervisory call.

When you are receiving a talkgroup call and a supervisory call is initiated, your device unmutes to the supervisory call and continues receiving the talkgroup call from the supervisor.

When you are transmitting in a talkgroup call and a supervisory call is initiated, your device unmutes to the supervisory call and displays the receiving call LED notification.

Chapter 8

Area-Based Talkgroup

When you enter a geographic area, you are able to hear the notifications for the talkgroup area in that geofence.

8.1 Entering And Exiting Area-Based Talkgroup

Entering Area-Based Talkgroup

When you are in the Area Talkgroup, your device sounds a tone.

After you are added to the Area Talkgroup, your device is able to receive calls from the Area Talkgroup even if Talkgroup Scanning is turned off.

When you are not in an active call, an area-based group call is received if there is any.

If there is an ongoing call, you begin to receive the call upon entering the area.

Exiting Area-Based Talkgroup

When you exit the Area Talkgroup, your device sounds a tone.



NOTE: If you are in a call when you exit the Area Talkgroup, the call continues without dropping. When the call ends, your device then exits the Area Talkgroup and returns to the default talkgroup.

Instant Personal Alert

Instant Personal Alert (IPA) is a notification that you can send to a contact that is busy or unable to reply to a group or private call.

9.1 Initiating IPA

Procedure:

- 1 Press the Voice Assistant button.
- 2 After you hear a tone, speak your command into the accessory microphone.

When you receive an IPA during a call, your device shows the following indications after the call:

- A tone sounds.
- The voice announcement sounds.
- The top crescent white LED blinks twice.
- There are no visible or audible indicators while the call is in progress.

When you receive an IPA when your device is in Do Not Disturb mode, your device shows the following indications:

- A tone sounds.
- The voice announcement sounds.
- The top crescent white LED blinks twice.



- NOTE:
- If you receive multiple IPAs from the same contact, there is only one entry in the IPA list with the latest IPA at the beginning.
- The IPA List can store up to nine alerts.
- · An IPA can be received from contacts outside your Contact List.

Ambient Listening

Ambient listening allows an authorized user to listen to the ambient audio of specific users' device during idle mode.

When ambient listening is initiated or restored, your device shows the following indications:

- The top crescent green LED illuminates.
- The voice announcement sounds.

Ambient listening stops when a call is initiated or received and is restored after the call ends.

NOTE: Ambient Listening during Emergency Mode is available, subject to the Wave PTX Server.

Do Not Disturb

Do Not Disturb (DND) allows you to change the status of the device from available to unavailable. When DND is enabled, you are not able to receive any calls, except broadcast calls.

Connectivity

You can connect your device to other devices, accessories, or network through different types of connectivity.

12.1 Bluetooth

This feature allows you to use your device with a Bluetooth-enabled accessory through a Bluetooth connection. Your device supports both Motorola Solutions and Commercially available Off-The-Shelf (COTS) Bluetooth-enabled accessory.

Bluetooth operates within a range of 10m (32ft) line of sight. This is an unobstructed path between your device and your Bluetooth-enabled accessory. For high degree of reliability, Motorola Solutions recommends to not separate the device and the accessory.

At the fringe areas of reception, both voice and tone quality start to sound "garbled" or "broken". To correct this problem, position your device and Bluetooth-enabled accessory closer to each other (within the 10m defined range) to re-establish clear audio reception. The Bluetooth function of your device has maximum power of 2.5mW (4dBm) at the 10m range.

- The top and bottom crescent aqua LED blinks.

If the Bluetooth device is connected to your device, your device shows the following indications:

- The top and bottom crescent aqua LED illuminates for 2 seconds.
- A delayed voice announcement sounds.



NOTE: If both wired earpiece and Bluetooth earpiece are connected to the device at the same time, the wired earpiece overrides the audio output.

Bluetooth Connection Failure

When the Bluetooth accessory is out of the Bluetooth connection range or removed, the device is disconnected and experience signal interference.

Your device shows the following indication while reconnecting to the same Bluetooth accessory within an allocated time:

- A tone sounds.
- The top and bottom aqua crescent LED blinks twice.

After timeout, your device starts searching for a wired earpiece.

If your device is not connected to a wired earpiece and you are not charging your device, the device shows the following indications:

- The device vibrates.
- The top and bottom red crescent LED blinks alternately with the purple crescent LED.

12.1.4 Checking Bluetooth Status

Procedure:

1 Press the Voice Assistant button.

2 After you hear a tone, speak your command into the accessory microphone.

You can hear three different corresponding voice announcement sounds depending on the status:

- When your device is connected to a Bluetooth accessory.
- When the Bluetooth connection is on but not connected to any Bluetooth accessory.
- When the Bluetooth connection is off. You can speak your command into the accessory microphone to turn it on.

12.2 Wi-Fi

Wi-Fi® is a registered trademark of Wi-Fi Alliance®. You can set up and connect Wi-Fi network to update your device firmware, codeplug, and Voice Announcement.

12.2.1 Turning the Wi-Fi On or Off

Procedure:

- 1 Press the Voice Assistant button.
- 2 After you hear a tone, speak your command into the accessory microphone.

If the Wi-Fi is turned on or off, the voice announcement sounds.

12.2.2 Wi-Fi Status

Initiating the voice command for Wi-Fi status allows you to get the Wi-Fi status for your device as shows in the following table.

Emergency Operations

Emergency Alerts are used to indicate critical situations. You can initiate an Emergency Alert at any time even when there is activity on the current Talkgroup.

During the Emergency mode, any call launched is declared as Emergency Call.

13.1 Declaring Emergency

Procedure:

To declare emergency locally, press and hold the **Emergency** button.

Your device shows the following indications:

- · The device vibrates.
- The Emergency Alert tone sounds.
- · The voice announcement sounds.
- The bar LED shows six bars after countdown ends.
- The top and bottom crescent amber LED blinks twice.

You can release the Emergency button during the countdown to stop the process.



NOTE: You can also declare an Emergency remotely by an authorized user or a dispatcher, but there is no countdown on the device LED bar if done remotely.

If Emergency is declared successfully, your device shows the following indications:

- The Emergency Alert tone sounds.
- The voice announcement sounds.
- · The top and bottom crescent amber LED illuminates.



NOTE: When the device is in Emergency mode, you are only allowed to control the volume make an emergency call and exit the emergency mode.

If Emergency fails to declare, your device shows the following indications:

- · The Emergency Declare Fail tone sounds.
- The voice announcement sounds.
- Returns to the previously selected talkgroup.

13.2 Canceling Emergency

Procedure:

To cancel emergency locally, press and hold the Emergency button.

Your device shows the following indications:

- The device vibrates.
- The voice announcement sounds.

• The bar LED shows six bars after countdown ends.

You can release the Emergency button during the countdown to stop the process.

NOTE: You can also cancel an Emergency remotely by an authorized user or a dispatcher, but there is no countdown on the device LED bar if done remotely.

If Emergency is canceled successfully, your device shows the following indications:

- The voice announcement sounds.
- · Returns to the previously selected talkgroup.

If Emergency cancellation fails, your device shows the following indications:

- A tone sounds.
- The top and bottom crescent amber LED illuminates.

13.3 Receiving Emergency Alerts

When you receive a Declared-Emergency Alert, your device shows the following indications:

- The Emergency Alert tone sounds.
- The top and bottom crescent amber LED blinks until the Emergency Alert is cleared.
- The voice announcement sounds the Declared-Emergency Alert and the initiator's alias.

NOTE: The Emergency Alert tone can be configured or disabled through the WAVE PTX Portal.

When you receive a Cancelled-Emergency Alert, your device shows the following indications:

- The Emergency Alert tone sounds.
- The top and bottom crescent amber LED blinks until the Emergency Alert is cleared.
- The voice announcement sounds the Cancelled-Emergency Alert and the initiator's alias.

NOTE: The Emergency Alert has higher priority than making or receiving calls.

Receiving and Responding to Emergency Calls

When you receive an Emergency Call, your device shows the following indications:

- For Private Call, the device vibrates.
- For Group and Private Call, the Emergency Call tone sounds.
- For Group and Private Call, the top crescent amber LED blinks twice throughout the call.

NOTE: The Emergency Call has higher priority than Group and Private Call.

Procedure:

- 1 To respond to the Emergency Call, press and hold the **PTT** button.

Scan

Scan allows your device to monitor multiple Talkgroups in the programmed scan list to look for an active Talkgroup.

When in the scan mode, the system preempts an ongoing low-priority talkgroup call. Your device unmutes to the high-priority talkgroup call. You respond to the active talkgroup when you press the **PTT** button during the programmed period (hang time) of an ongoing call from your scan list.

Pressing the **PTT** button when the device is not in a call causes the device to start a call on the last selected talkgroup.

14.1 Turning Scan On or Off

Procedure:

- 1 Press the Voice Assistant button.
- 2 Speak your command into the accessory microphone.

If the scan feature is on, your device shows the following indications:

- The voice announcement sounds.
- The top and bottom crescent yellow LED blinks twice.

If the scan feature is off, the voice announcement sounds.

If the scan feature fails, your device shows the following indications:

- The voice announcement sounds.
- The top and bottom crescent red LED blinks twice.

NOTE: If no Talkgroup is assigned to your device, the scan feature automatically turns on.

Device Stun

Device Stun indicates that your device is disabled.

When Device Stun is initiated, the voice announcement sounds. When you press any button, the same voice announcement is sounds.

When your device is in Device Stun mode, all the buttons, except for **Power**, **Volume Up**, and **Volume Down** buttons, are disabled. All voice announcement and LED indications are also disabled. Only the volume LED bar shows momentarily.

If you press any buttons when the device is in Stun Mode, the voice announcement indicates that the device is in Stun Mode.

When Device Stun is initiated while your device is in charging mode, the device continues charging but the battery capacity LED bar indicator is not shown. But you can still see the charging LED during the following situations:

- The battery level increases.
- You unplug and replug the charging the USB cable.

When your device is in Stun mode, the following activities occur:

- Scan feature is disabled.
- DND feature is disabled.
- Instant Personal Alert List is cleared.
- Emergency Alert List is cleared.

User Disabled or Suspended

User Disabled or Suspended indicates that your account is disabled or suspended. When your account is disabled or suspended, you are not able to log in to the PTT server.

Your account can be disabled through the WAVE PTX Portal or by an authorized user.

If your account is disabled or suspended, your device shows the following indications:

- A tone sounds.
- The voice announcement sounds.
- The top and bottom crescent red LED blinks.

The Power, Volume Up, and Volume Down buttons continue to work normally.

If you press the **PTT** button, your device attempts to log in to the PTT server. If your device is able to connect to the PTT server, you encounter the normal login screen, else, your device sounds the voice announcement.

Device Kill

Device Kill indicates that your device is permanently disabled.

When your device receives a Kill command when in normal operation mode, your device turns off.

While in Kill mode, User Interface (UI) is not available on your device and you are not able to turn on your device. Your device can only be reactivated by Motorola Solutions.

Contact your dealer for more information.

Firmware Over the Air (FOTA)

Firmware Over The Air (FOTA) feature allows your device to be updated with latest firmware over the internet.

When the firmware updates are ready for your device, the device shows the following indications:

- A voice announcement sounds that prompts you to restart the device for the firmware installation.
- The two white crescent LED blink twice.

NOTE: If your device battery power is low, the device does install the firmware updates.

Your device continues to show the firmware updates indications until you have restarted the device for every three hours for eight times. You can also use the voice assistant feature to check the firmware updates for your device.

If you have not restart your device after the eighth firmware updates indications, the device shows the following indications:

 A voice announcement sounds that prompts you to press any button to cancel the auto restart for the firmware installation.

• 10 seconds auto restart countdown. The countdown is indicated by the LED bar.

NOTE: If your device battery power is low, the device does not auto restart. Instead, your device continues to show you the firmware updates indications.
