SAFETY INSTRUCTIONS

- **Strangulation Hazard**—Children have **STRANGLED** in cords. Keep this cord out of the reach of children (more than 5 ft (1.9 m) away).



- **NEVER** place the camera or cord in or near the crib or playpen.
- **NEVER** mount the camera directly above the crib or playpen to avoid the risk of injury.
- Only use the AC adapters provided.
- Never use the unit near water, including near a bathtub, sink, laundry machine, tub, wet basement, etc.
- Do not install near the product heat sources such as radiators, heat registers, stoves, or other devices that produce heat.
- Only use attachments and accessories specified by the manufacturer.
- Unplug this device when unused for long periods of time.

CAUTION

- NOT toys. Do not allow children to play with them.
- This product is NOT intended to replace adult supervision. You MUST check your child's activity regularly.
- This product is not intended for use as a medical camera and its use should not replace adult supervision.
- Unplug the product during lightning storms.
- Please check the operating range and condition of the camera carefully at the initial installation, and on a regular basis after that.
- Check the reception regularly. Test the camera before use and after changing the camera's location.
- For indoor use only.
- Clean the camera with a dry cloth only.
- Do not block any ventilation openings.

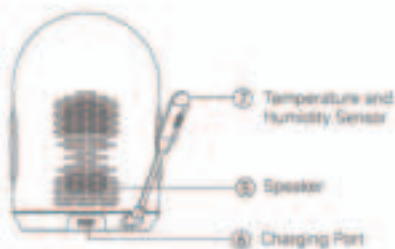
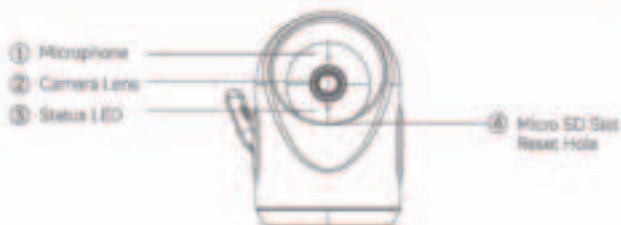

HOW TO USE

1 Get the APP and account

Download and install the MamaPro app from the App Store (iOS devices) or Google Play (Android devices), and sign up for an account.



HOW TO USE

② Power On the Baby Camera

Connect the Baby Camera to the power adapter (5W1A), then plug the adapter into a power outlet.



NOTE: 1) Only use the power adapters included in the package.

2) Do not place the camera and power cord within the reach of your baby.

HOW TO USE

1 Set up your camera

Follow the app instructions and tap "Get Started" or the "+" in the top right corner to add a device.



HOW TO USE

Remember: The baby camera transmits video and audio over a securely encrypted 2.4GHz/5GHz Wi-Fi connection. Connect it only to a private network that requires a secure password.

HOW TO USE

④ Place or mount your camera

The camera can be placed on a table or shelf, or can be installed on a wall or crib. Select a location and height that achieves your desired view and is within reach of a power outlet. Use the monitor to test the viewing angle from your desired mounting spot.
