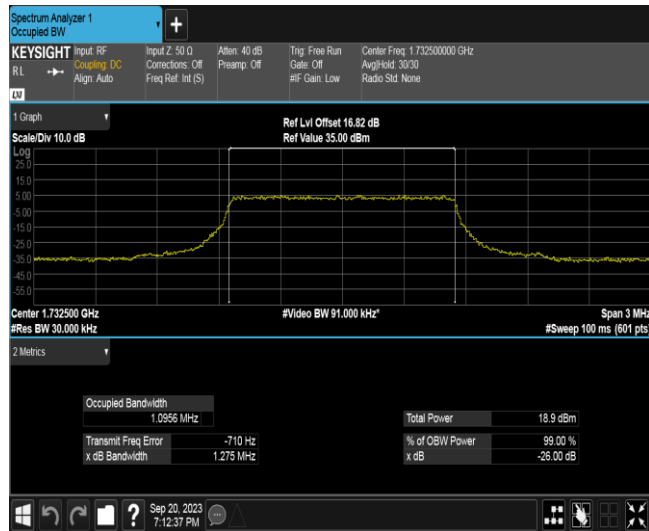

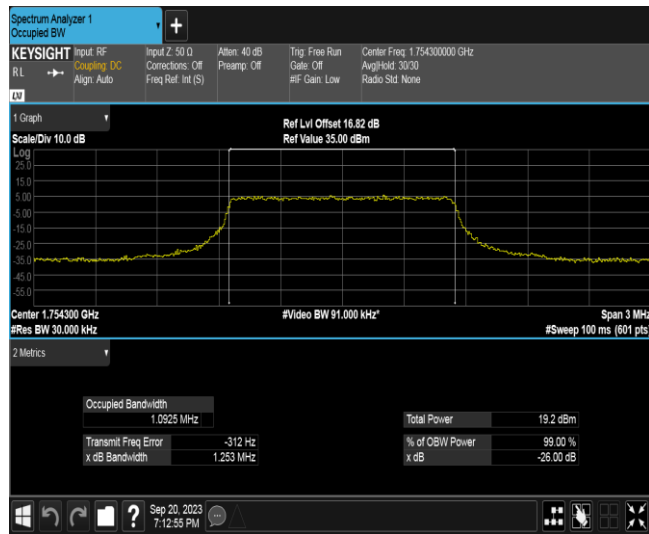


Band4-1.4MHz-QPSK-20175-6RB#0

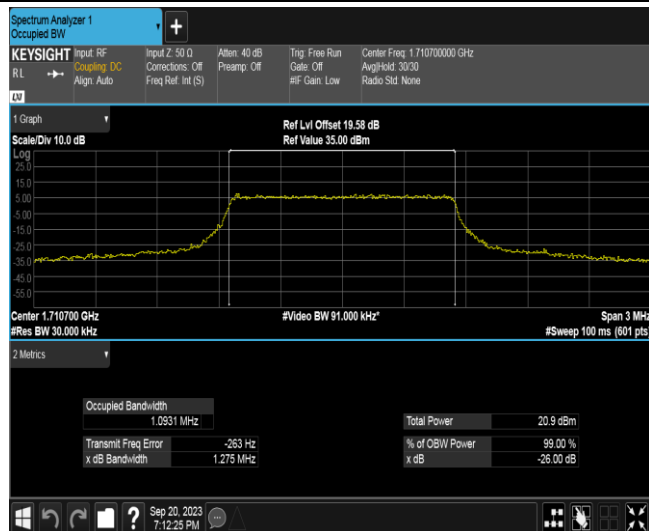

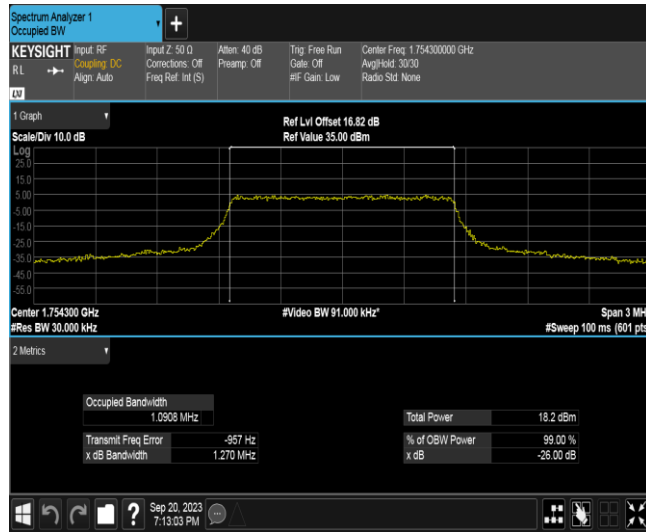

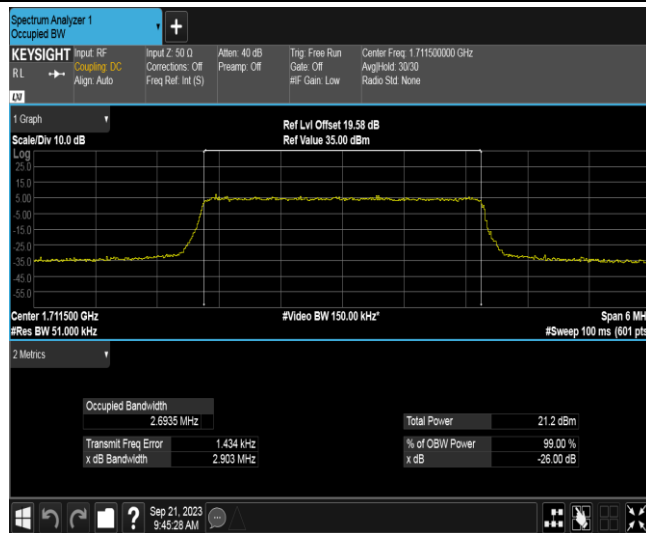
