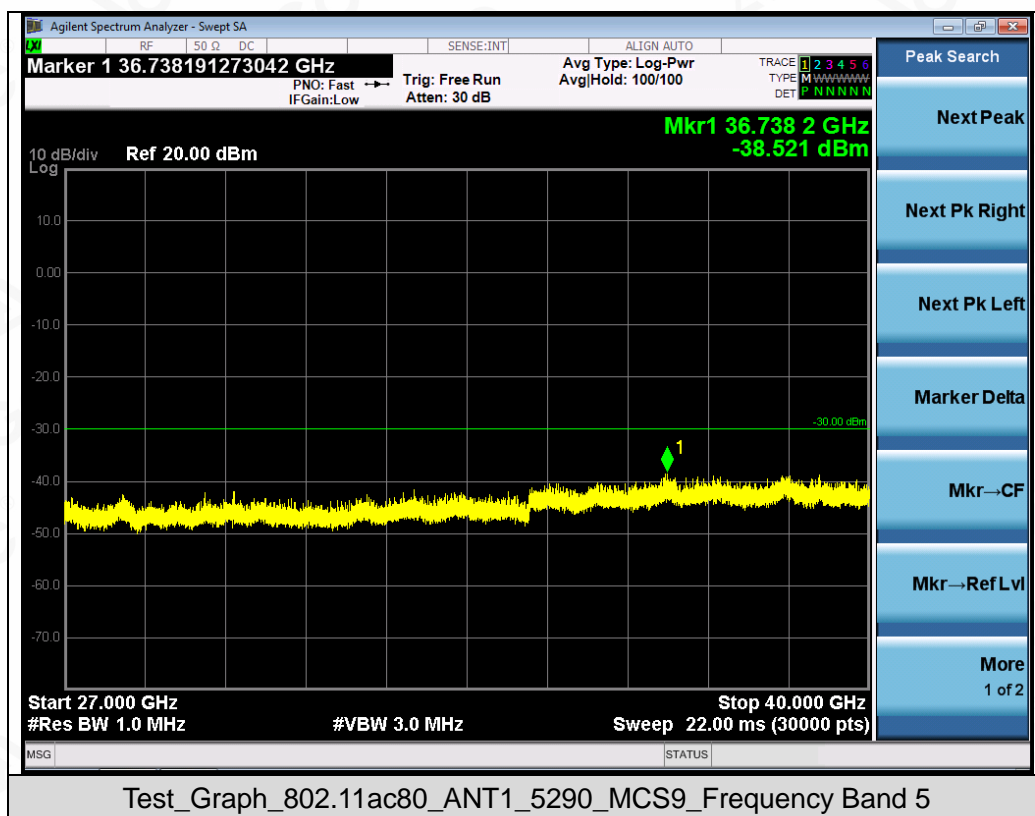

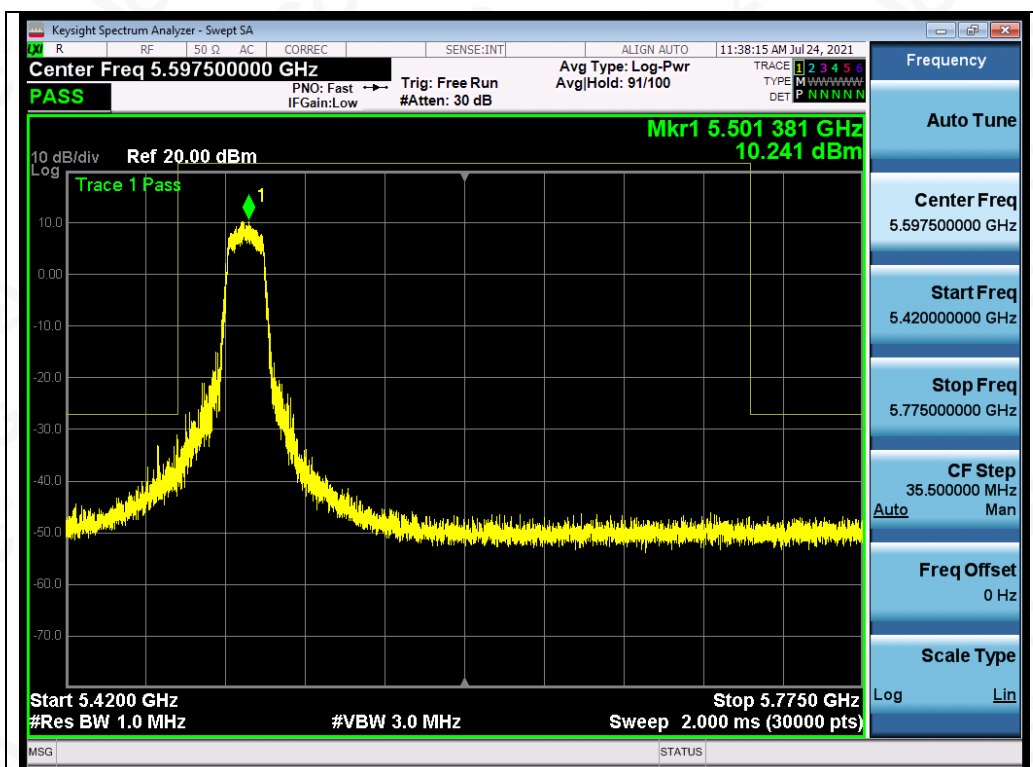

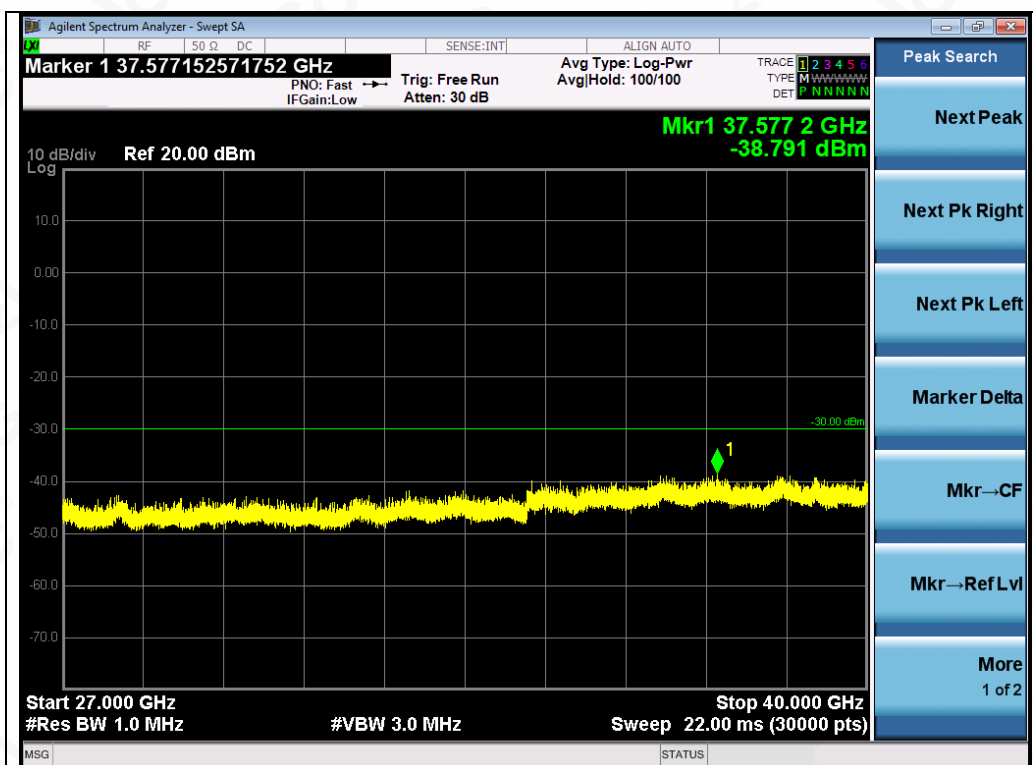

Test Graphs of Spurious Emissions outside of the 5.725-5.85 GHz band for transmitters operating in the 5.725-5.85 GHz band



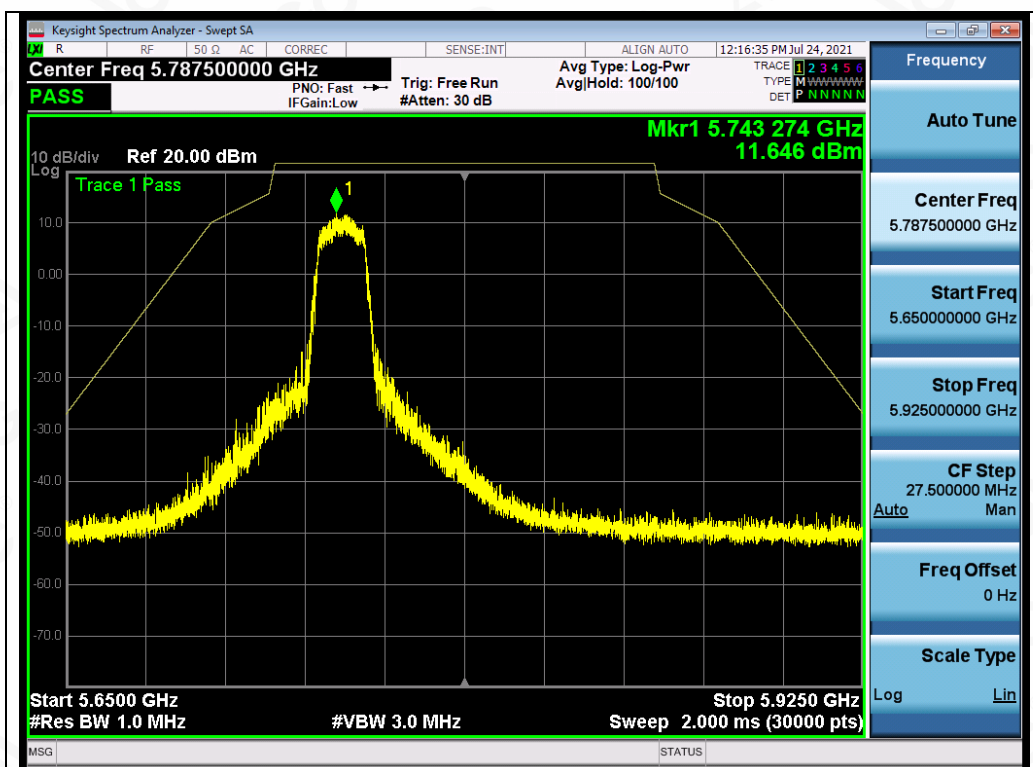

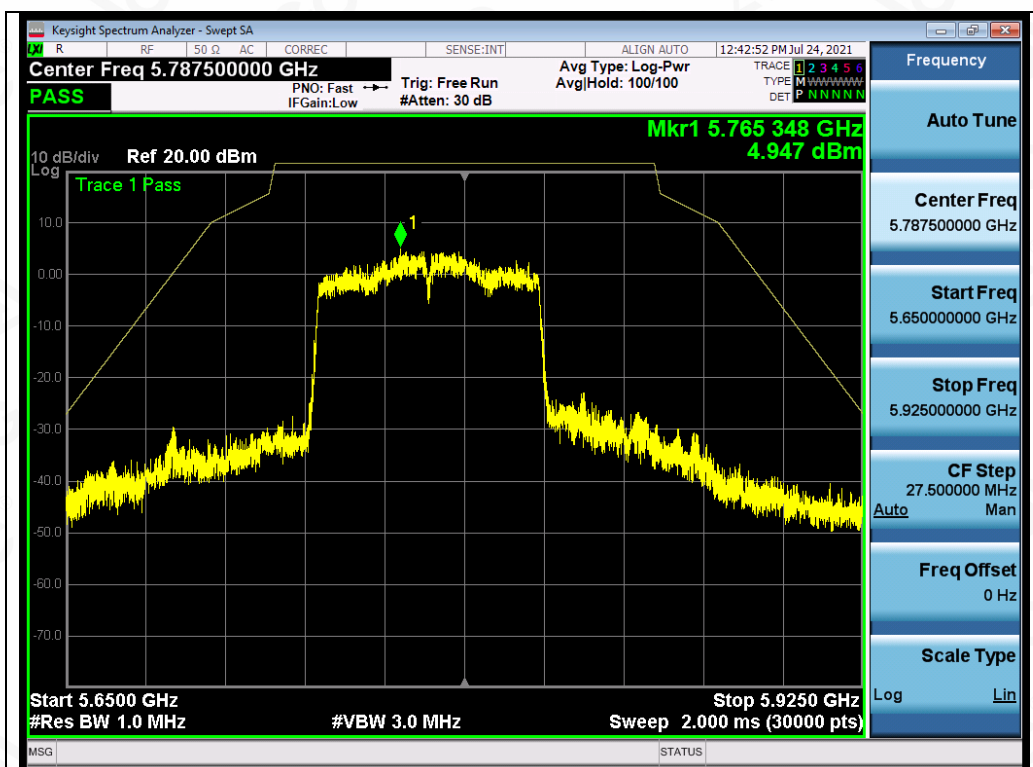
