Enclosed on behalf of Rockwell International is an Application for Type Acceptance on Form 731. The application seeks only a change in FCC identification for the Rockwell VHF-700A Transceiver. The new FCC ID for this product is AJKPN822-0693; the previous FCC ID was AJK9URPN622-5219, granted originally on June 29, 1981 and subsequently modified on August 27, 1982. The change in the equipment necessitating a new FCC ID is a Class I permissive change and the change in the FCC identifier is requested in order to maintain continuity between the Rockwell part numbers and FCC identifiers. Pursuant to Section 2.933 of the Commission's Rules we have enclosed a completed FCC Form 731, a statement pursuant to Sub-Section 2.933(b) and the required drawings/photograph of the nameplate that bears the new FCC ID and its relative size and position.

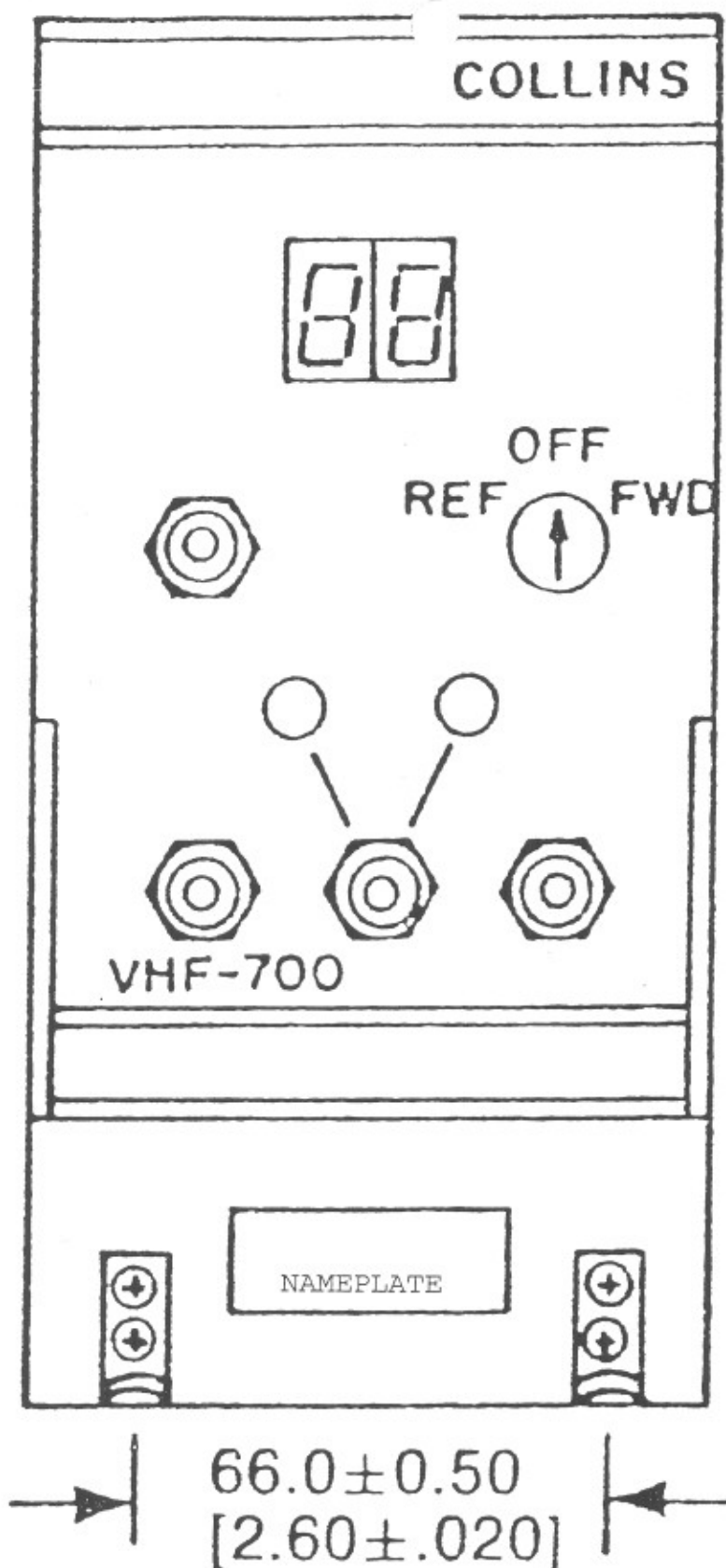
