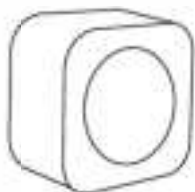
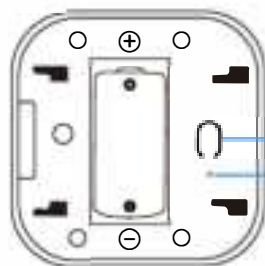

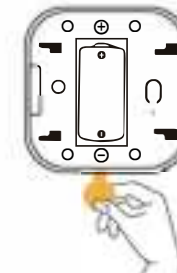
1.Power on the sensor

- 1 Open the battery cover

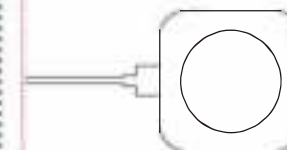

- 2 Remove the insulation sheet



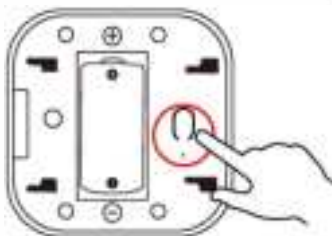
Option:It also can be supplied by USB DC5V,at this time the battery will be saved.

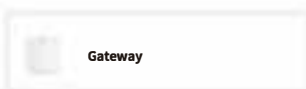
2.Make device to enter pairing mode

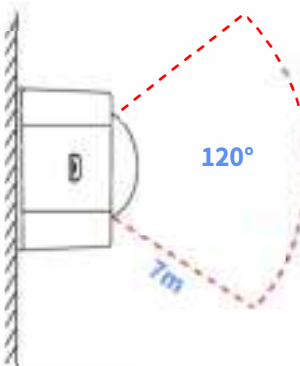

4.Device Installation

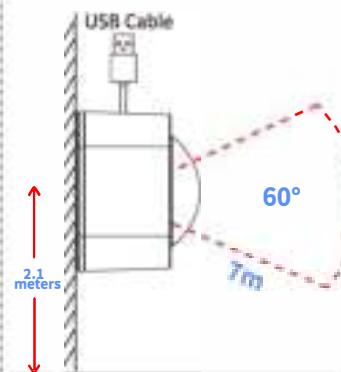
Close the battery cover then put it where you need it .For good detection range,the installation height should be 1.8~2.1 meters.Please refer to the view below to find out the installation place you need.

5.Battery Change

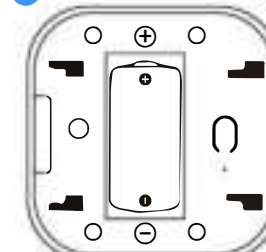
The sensor works with a replaceable CR123A 3.0V battery. If you received the low battery alarm on app, please replace the battery and ensure the new battery is installed in the right direction.

- 1 Open the Lid

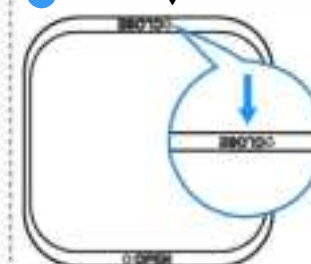
