**Our request is that the EU-TEC reflects both the new HW and SW versions.**

HW change

There are no hardware differences between ALAS5-AM Revision 1.1.4b and Revision 1.2. Rev. 1.1 was succeeded by Rev. 1.1.1, Rev. 1.1.2, Rev. 1.1.3, and Rev. 1.1.4b. Now, in order to release a formally correct set of production data, Revision 1.1.4b was simply cloned to Revision 1.2

SW change

SW to a new minor version.

This change has no impact on the operation, testing or certification of the product as shown in the release notes attached.

Model's ALAS5V-US hardware is based on ALAS5-AM thus the HW and SW version are the same.

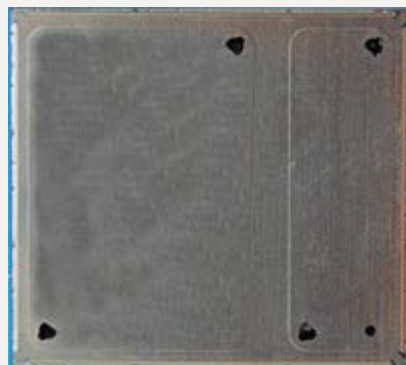

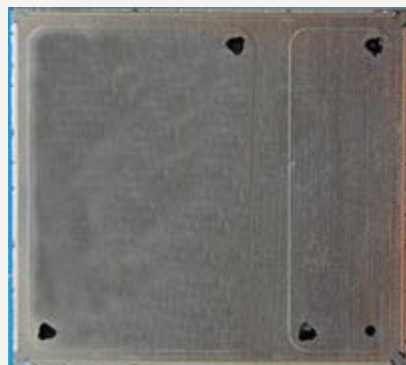

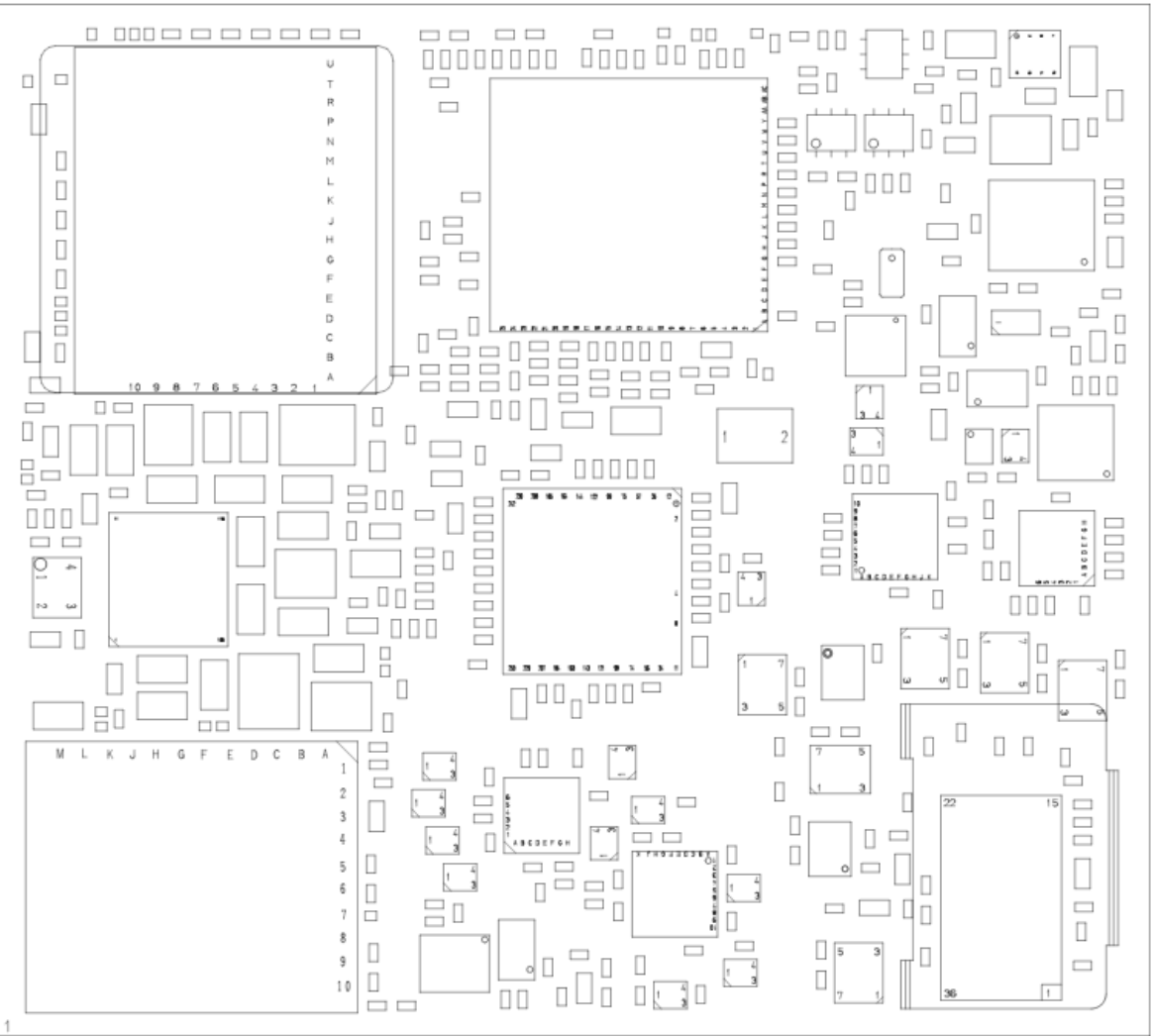


Figure 1: Floorplan ALAS5-AM

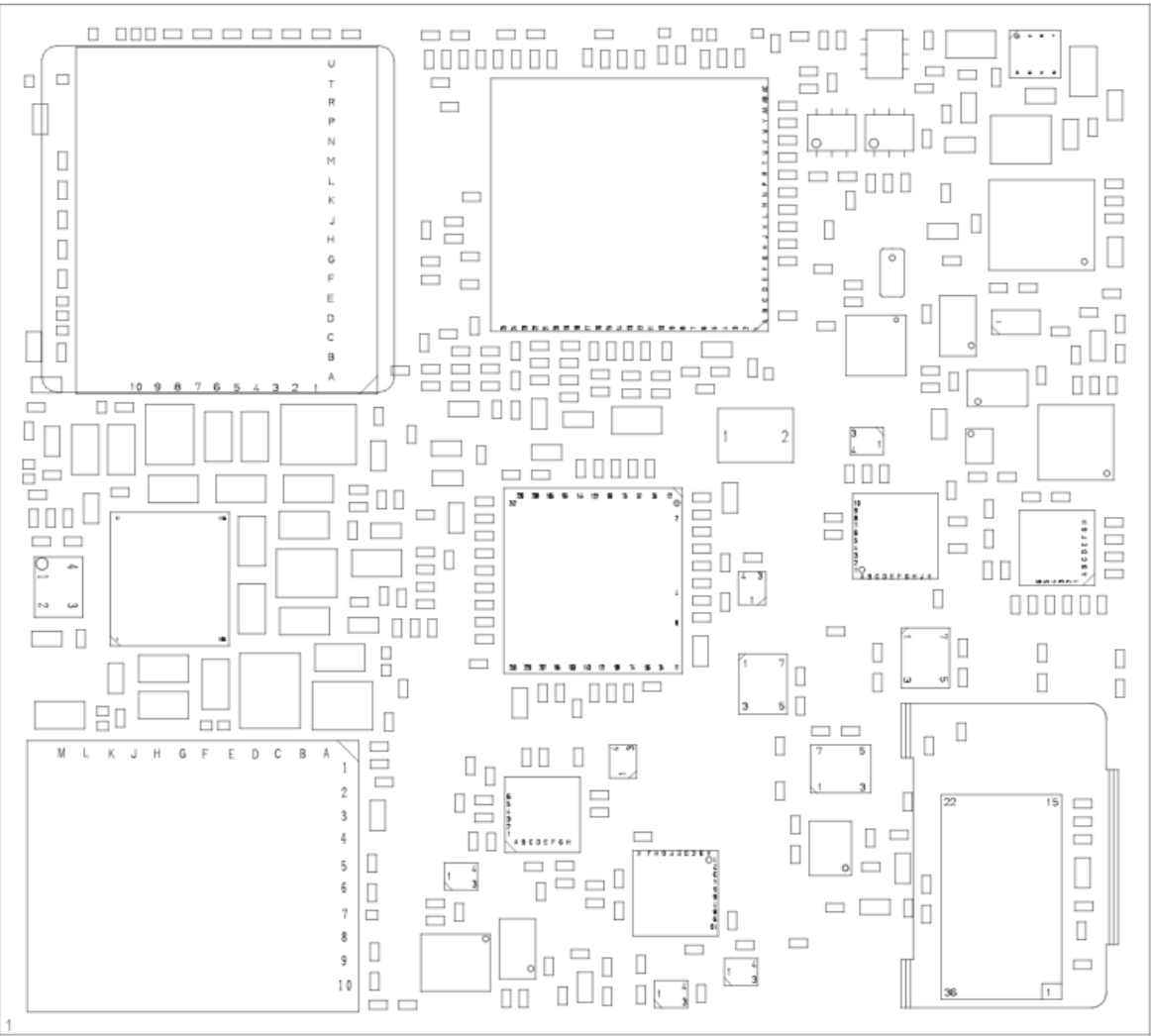


Figure 2: Floorplan ALAS5V-US

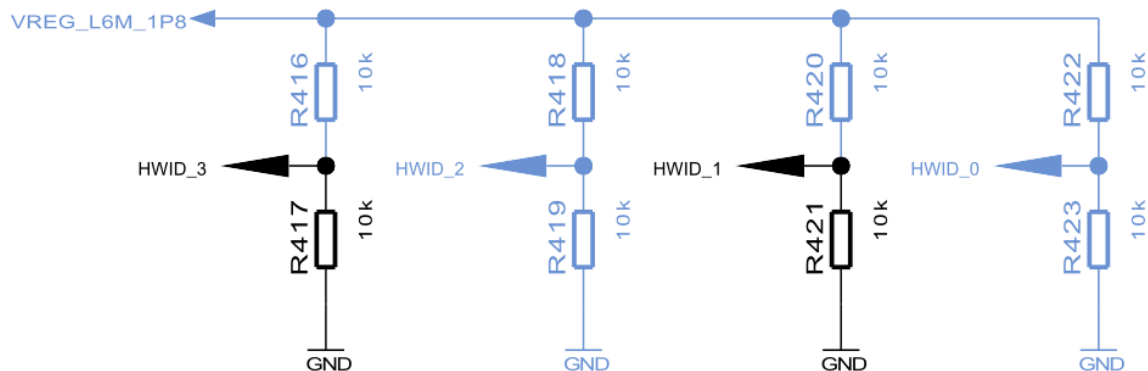
