

1. The modular transmitter must have its own RF shielding.	The module has its own RF shielding. Please see external photo.pdf
2. The modular transmitter must have buffered modulation/data inputs.	The modular has buffered data inputs, it is integrated in chip-on-chip. Please see schematic.pdf
3. The modular transmitter must have its own power supply regulation.	All power lines derived from the host device are regulated before energizing other circuits internal to the chip-on-chip. Please see schematic.pdf
4. The modular transmitter must comply with the antenna requirements of Section 15.203 and 15.204(c).	The ESP8685-WROOM-04 meet the FCC antenna requirements.
5. The modular transmitter must be tested in a stand-alone configuration, i.e., the module must not be inside another device during testing.	The ESP8685-WROOM-04 was tested in a stand-alone configuration via com serial interface. Please see test set-up photo.pdf

A copy of these instructions must be included in the application for equipment authorization.	The ESP8685-WROOM-04 is compliant with all applicable FCC rules. Detail instructions are given in the Users Manual. Please see user manual.pdf
8. The modular transmitter must comply with any applicable RF exposure requirements.
