The following formula was used to calculate the Power Density:

$$S=\frac{PG}{4\pi R^2}$$

Where: S = Power Density P = Output Power at Antenna Terminals G = Gain of Transmit Antenna (linear gain) R = Distance from Transmitting Antenna
