# Charging

To charge the devices plug them into the USB C slot using a USB C cable.

#### **LED** status

The LED mode on the Gateway can change based on the battery, charging and internal states. The battery and charging related LED modes can be seen in the next table.

State of device	Corresponding LED behavior
Low battery (<10%)	Short red blink with 1s period
Charging	Green pulsating light with 1s period
Fully charged	Short green blink with 1s period

# Turning on/off

- The sensor can be switched on by connecting the sensor to a power source through the USB C connector (as if to charge the batteries).
- The sensor can also be switched on by holding the button next to the power icon for 3s, until the LED starts to alternate between red and green.
- 3. To turn off the Gateway hold the button for 3s, until the LED turns red, then release it.

## **Restart**

In case of restart the devices will lose any connection and ongoing measurement.

Hard reset - upon connecting the device to a power source through the USB C connector the device will reset.



## Long-term storage guidelines

Follow the recommended guidelines to preserve the battery life of the devices:

- Operating temperature: 0°C 50°C.
- Storage temperature: 25°C±10°C.

If the devices will be stored for a prolonged period, charge all devices up to at least 90%.
