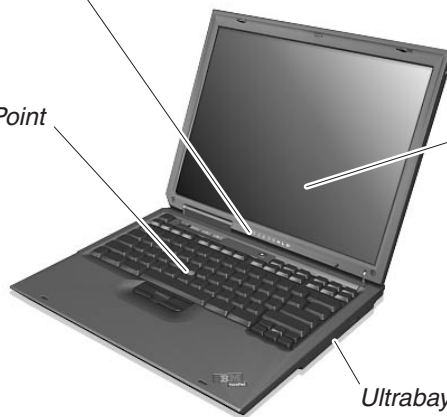

Caring for your ThinkPad computer

Though your computer is designed to function reliably in normal work environments, you need to use common sense when handling it. By following these important tips, you will get the most use and enjoyment out of your computer.

Important tips:

Be careful about where and how you work

- Do not leave the base of your computer in contact with your lap or any part of your body for an extended period when the computer is functioning or when the battery is charging. Your computer dissipates some heat during normal operation. This heat is a function of the level of system activity and battery charge level. Extended contact with your body, even through clothing, could cause discomfort or, eventually, a skin burn.
- Place liquids away from your computer to avoid spills, and keep your computer away from water (to avoid the danger of electrical shock).
- Store packing materials safely out of the reach of children to prevent the risk of suffocation from plastic bags.
- Keep your computer away from magnets, activated cellular phones, electrical appliances, or speakers (within 13cm/5 in).
- Avoid subjecting your computer to extreme temperatures (below 5°C/41°F or above 35°C/95°F).

Be gentle with your computer

- Avoid placing any objects (including paper) between the display and the keyboard or under the keyboard.
- Do not drop, bump, scratch, twist, hit, vibrate, push or place heavy objects on your computer, display, or external devices.
- Your computer display is designed to be opened and used at an angle slightly greater than 90 degrees. Do not open the display beyond 135 degrees, as this might damage the computer hinge.

Carry your computer properly

- Before moving your computer, be sure to remove any media, turn off attached devices, and disconnect cords and cables.
- Be sure your computer is in standby or hibernation mode, or turned off, before moving it. This will prevent damage to the hard disk drive and data loss.
- When picking up your open computer, hold it by the bottom. Do not pick up or hold your computer by the display.

Caring for your ThinkPad computer

- Use a quality carrying case that provides adequate cushion and protection. Do not pack your computer in a tightly packed suitcase or bag.

Handle storage media and drives properly

- If your computer comes with a diskette drive, avoid inserting diskettes at an angle and attaching multiple or loose diskette labels, as these can lodge in the drive.
- Do not touch the surface of a CD or DVD, or the lens on the CD or DVD tray.
- Wait until you hear the CD or DVD click into the center pivot of the CD or DVD drive before closing the CD or DVD tray.
- If your computer comes with a CD-RW or DVD/CD-RW drive, make sure your computer is protected from vibration when writing CDs. Vibration may result in errors or damaged CDs. Even typing on the computer will cause vibration.
- When installing your hard disk, CD or DVD drive, or installing an external diskette drive, follow the instructions shipped with your hardware, and apply pressure only where needed on the device. See Access ThinkPad, your on-board help system, for information on replacing your hard disk drive (open Access ThinkPad by pressing the ThinkPad button).

Take care in setting passwords

- Remember your passwords. If you forget a supervisor or hard disk password, IBM will not reset it, and you may have to replace your system board or hard disk drive.
- If you are an administrator, remember that setting a setup password can prevent unauthorized initialization.

Other important tips

- Your computer modem may use only an analog telephone network, or public-switched telephone network (PSTN). Do not connect the modem to a PBX (private branch exchange) or any other digital telephone extension line because this could damage your modem. Analog phone lines are often used in homes, while digital phone lines are often used in hotels or office buildings. If you are not sure which kind of phone line you are using, contact your telephone company.
- Your computer might have both an Ethernet connector and a modem connector. If so, be sure to connect your communication cable to the correct one, so your connector is not damaged. See Access ThinkPad, your on-board help system, for information on the location of these connectors (press the ThinkPad button to open Access ThinkPad).
- Register your ThinkPad products with IBM (refer to the Web page: www.pc.ibm.com/register). This can help authorities return your computer

to you if it is lost or stolen. Registering your computer also enables IBM to notify you about possible technical information and upgrades.

- Only an authorized IBM ThinkPad repair technician should disassemble and repair your computer.
- Do not modify or tape the latches to keep the display open or closed.
- Take care not to turn your computer over while the ac adapter is plugged in. This could break the adapter plug.
- Turn off your computer if you are replacing a device in a device bay, or else verify that the device is warm- or hot-swappable.
- If you exchange drives in your computer, reinstall the plastic bezel faces (if supplied).
- Store your external and removable hard disk, diskette, CD and DVD drives in the appropriate containers or packaging when they are not being used.

Cleaning your computer

Occasionally clean your computer as follows:

- Use a soft cloth moistened with nonalkaline detergent to wipe the exterior of the computer.
- Avoid spraying cleaner directly on the display or the keyboard.
- Gently wipe the display with a dry, soft cloth.

Using your on-board help

Your computer contains comprehensive on-board help and information. You no longer need to carry heavy manuals or other reference books.

On-board help is provided by Access ThinkPad and ThinkPad Assistant. Press the computer's unique ThinkPad button to open Access ThinkPad. There, you can do a Quick Search or click on topics that take you to ThinkPad Assistant. You can also go directly to ThinkPad Assistant by clicking **Start → Programs → ThinkPad → ThinkPad Assistant**.

ThinkPad Assistant contains information within the following categories:

- About your computer
- Everyday use
- Communicate
- Home and travel
- Enhancements
- Maintenance and updates
- Security
- Problem solving
- How to reach IBM

Diagnosing problems

If you have a problem with your computer, you can test it by using PC-Doctor® for Windows®. To run PC-Doctor for Windows, do as follows:

1. Click **Start**.
2. Move the cursor to **Programs** and then to **PC-Doctor for Windows**.
3. Click **PC-Doctor for Windows**.
4. Choose either the **Quick Test** or the **Standard Test**.

Attention

Running the Quick Test set can take 10 minutes or longer. Make sure you have time to run the entire test; do not interrupt the test while it is running.

The Quick Test set runs many tests of critical hardware components, but it does not run all of the diagnostic test in PC-Doctor for Windows. If PC-Doctor for Windows reports that all of the tests in the Quick Test set have been run and that it has found no problems, consider running additional tests.

If you are preparing to contact IBM for support, be sure to print the test log so that you can rapidly provide information to the help technician.

Troubleshooting

If you do not find your problem here, refer to access ThinkPad, your on-board help system. Open Access ThinkPad by pressing the ThinkPad button. The following section only describes problems that might prevent you from accessing this help system.

Error codes or messages

Note:

1. In the descriptions below, x can represent any character.
2. The version of PC-Doctor referred to here is PC-Doctor for Windows.

Message:006 (Equipment Configuration Error)

Solution:Restart the computer. If the problem persists, have the computer serviced.

Message:070 (Real Time Clock Error) —or— 071 (CMOS Battery Bad)

Solution:Have the computer serviced.

Message:072 (CMOS Checksum Error)

Solution:Do as follows:

1. Enter the BIOS Setup Utility.
2. Load default settings and exit the BIOS Setup Utility.

If the problem persists, have the computer serviced.

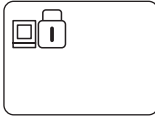
Message:110 (Incorrect password specified, system halted)

Solution:Turn off the computer; then turn it on again. Type in the correct password. You cannot access the computer without the correct password. If you forget your password, have the computer serviced.

Message:252 (VPD checksum error)

Solution:Have the computer serviced.

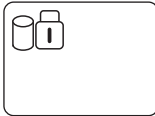
Message:The power-on password or supervisor password prompt



Solution:If the power-on password prompt appears when you turn on your computer, a power-on password is set. If the supervisor password prompt appears when you press F1 to access the IBM BIOS Setup Utility, the supervisor password is set. Type the correct password and press Enter to use the computer (see the onboard help, Access ThinkPad).

Attention: If you still have a problem, have the computer serviced.If you forget your supervisor password, IBM will not reset it. You must take the computer to an IBM reseller or a marketing representative to replace the system board. Proof of purchase is required, and a fee will be charged for service.

Message:The hard disk password prompt



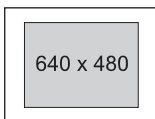
Solution:If the hard disk password prompt appears, a hard disk password is set.

Type the correct password and press Enter to use the computer (see the onboard help, Access ThinkPad).

Attention: If you forget your hard disk password, you can no longer access the hard disk. The password cannot be reset and you will lose all data and files on the hard disk. To use the computer, you will need to replace the hard disk. This replacement will incur expenses for parts and labor.

If you still have a problem, have the computer serviced.

Message:The DOS full-screen looks smaller.



Solution:When you use a DOS application that supports only the 640x480 resolution (VGA mode), the screen image might look slightly distorted or smaller than the display size. This is to maintain compatibility with other DOS applications and is not a defect.

To expand the screen image to the same size as the actual screen, start the ThinkPad Configuration program and click **LCD**; then select the **Screen Expansion** function. (The image might look slightly distorted.) See the on-board help, Access ThinkPad for more details.

Message:The Windows startup screen does not fill the screen.

Solution:When you enable the **Screen Expansion** function in the ThinkPad Configuration program, the Windows startup screen expands but does not fill the entire screen. This is not a defect. (The image might look slightly distorted.) See the on-board help, Access ThinkPad for more details.

Message:Hibernation error

Solution:The system configuration changed between the time your computer entered hibernation mode and the time it left this mode, and your computer cannot resume normal operation.

- Restore the system configuration to what it was before your computer entered hibernation mode.
- If the memory size has been changed, re-create the hibernation file.

Message:Operating system not found.

Solution:Verify the following:

- The hard disk drive is correctly installed.
- A startable diskette is in the diskette drive

If you still see the same error message, check the boot sequence, using IBM BIOS Setup Utility.

Errors without codes or messages

Problem: When I turn on the machine, nothing appears on the screen and the machine does not beep while starting up.

Note: If you are not sure whether you heard any beeps, turn off the computer; then turn it on again and listen. If you are using an external monitor, refer to External monitor problems.

Solution: If a power-on password is set, press any key to display the power-on password prompt, and then type the correct password and press **Enter**.

Solving computer problems

If the power-on password prompt does not appear, the brightness control might be set to minimum brightness. Adjust the brightness level by pressing Fn+Home.

If the screen still remains blank, make sure that:

- The battery is installed correctly.
- The ac adapter is connected to the computer and the power cord is plugged into a working electrical outlet.
- The computer power is on. (Turn on the power switch again for confirmation.)

If these items are properly set, and the screen remains blank, have the computer serviced.

Problem: When I turn on the machine, nothing appears on the screen, but I hear two or more beeps or a continuous beep while starting up.

Solution: If you are using Ethernet:

- Make sure that the Ethernet cable is connected firmly.
- Contact your network administrator.

If the screen is still blank, and beeps are not stopped, have the computer serviced.

Problem: When I turn on the machine, only a white cursor appears on a blank screen.

Solution: First, reboot your system by pressing Ctrl+Alt+Del. If that does not work, hold down the power switch for more than 4 seconds. If this does not resolve the problem, you may need to reinstall your operating system.

Problem: My screen goes blank while the computer is on.

Solution: Your screen saver or power management may be enabled. Move the TrackPoint or press a key to exit the screen saver, or press the power switch to resume from standby or hibernation.

Problem: The computer cannot boot-up.

The message "Insert system diskette and press Enter key to reboot" appears.

Solution: Have in hand a bootable diskette, such as the Windows startup diskette, and do as follows:

1. Turn off the computer.

2. Connect the external diskette drive.
3. Insert the bootable diskette into the diskette drive.

The Windows startup diskette can help diagnose the problem. If the problem remains, have the computer serviced.

Password problems

Problem: I forgot my password.

Solution: If you forgot your power-on password, you have to take your computer to an IBM reseller or marketing representative to have the password canceled.

If you forgot your hard disk password, IBM will not reset your password or recover data from the hard disk. You must take your computer to an IBM reseller or an IBM marketing representative to have the hard disk drive replaced. Proof of purchase is required, and an additional charge might be required for the service.

If you forgot your supervisor password, IBM will not reset your password. You must take your computer to an IBM reseller or IBM marketing representative to have the system board replaced. Proof of purchase is required, and an additional charge might be required for the service.

A power switch problem

Problem: The system does not respond, and you cannot turn off the computer.

Solution: Turn off the computer by pressing and holding the power switch for 4 seconds or more. If the system is still not reset, remove the ac adapter and the battery.

Keyboard problems

Problem: All or some keys on the keyboard do not work.

Solution: If the problem occurred immediately after the computer returned from standby mode, enter the power-on password if one has been set.

If an external keyboard is connected, the numeric keypad on your computer does not work. Use the numeric keypad on the external keyboard.

If an external numeric keypad or a mouse is connected:

1. Turn off the computer.
2. Remove the external numeric keypad or the mouse.
3. Turn on the computer and try using the keyboard again.

Solving computer problems

If the keyboard problem is resolved, carefully reconnect the external numeric keypad, external keyboard, or mouse, making sure that you have seated the connectors properly.

If keys on the keyboard still do not work, have the computer serviced.

Problem: A number appears when you type a letter.

Solution: The numeric lock function is on. To disable it, press and hold **Shift**; then press **NumLk**.

Problem: All or some keys on the external numeric keypad do not work.

Solution: Make sure that the external numeric keypad is correctly connected to the computer.

Problem: All or some keys on the external keyboard do not work.

Solution: To use an external keyboard, you need to attach it to the computer directly or through the keyboard/mouse cable. Make sure that:

- The keyboard cable is correctly connected to the computer (if the keyboard is connected directly to the computer).
- The keyboard/mouse cable is correctly connected to the computer.
- The keyboard cable is connected to the correct side of the keyboard/mouse cable.

If these connections are correct, disconnect the keyboard/mouse cable from the computer and make sure that the keyboard operates properly. If the built-in keyboard works, there is a problem with either the cable or with the keyboard. Try using a different keyboard/mouse cable or external keyboard.

Problem: The internal numeric keypad does not work.

Solution: If you connect an external numeric keypad or an external keyboard with a numeric keypad, the internal numeric keypad is disabled. Use the external numeric keypad instead.

TrackPoint problems

Problem: The cursor drifts when the computer is turned on or after it resumes normal operation.

Solution: The cursor might drift when you are not using the TrackPoint during normal operation. This is a normal characteristic of the TrackPoint and is not a defect. Drift might last for several seconds under the following conditions:

- When the computer is turned on.
- When the computer resumes normal operation.
- When the TrackPoint is pressed for a long time.
- When the temperature changes.

Problem: The mouse or pointing device does not work.

Solution: Make sure that the pointing-device is enabled in the Device Manager.

Make sure that the mouse or pointing-device cable is securely connected to the computer.

Try using the TrackPoint. If the TrackPoint works, the error might be due to the mouse.

Note: For more information, see the manual supplied with the mouse.

Problem: The mouse buttons do not work.

Solution: Change the mouse driver to **Standard PS/2 Port Mouse**, and then reinstall **IBM PS/2 TrackPoint**. Drivers are provided in the C:\IBMTOOLS\DRIVERS directory on your hard disk drive. If your hard disk drive does not contain device drivers, refer to the ThinkPad Service & Support Web site. To access this Web site, open Access ThinkPad by pressing the ThinkPad button, then click the Service & Support image on the right of the screen.

Problem: The scrolling or magnifying glass function does not work.

Solution: Check the mouse driver in the Device Manager window, and make sure that the **IBM PS/2 TrackPoint** driver is installed.

Problem: The cursor does not move after the computer awakens from one of the power management modes.

Solution: Make sure you followed the instructions in the on-board help, Access ThinkPad correctly if you reinstalled Windows with the Advanced Power Management (APM) option.

Infrared port problems

Problem: Your computer cannot communicate with other devices through the infrared port.

Solution: Make sure that the communication speeds are the same.

Solving computer problems

Make sure that the infrared ports are clean.

Make sure that no objects are between the computer and the communicating device.

Make sure that the distance and angle between your computer and the device are within the specified ranges.

Make sure that you are not operating under direct sunlight.

Make sure that the infrared port is directly facing the other communication port.

Make sure that the communication application running on your computer is compatible with that running on the other computer. Refer to the application manuals for more information.

Problem: Incorrect data is sent between your computer and a communicating device.

Solution: Make sure that:

- The distance and angle between your computer and the device are within the ranges.
- The communication speeds are the same.
- There are no other devices that radiate infrared rays, such as remote-controlled devices or wireless headphones, near your computer or the communicating device.
- You are not operating under direct sunlight.
- No fluorescent lamps are near your computer or the communicating device.

Problem: You cannot use DMA channels for both the parallel connector and the infrared port.

Solution: If you enable ECP and choose DMA3 (the default value) for the parallel connector in the ThinkPad Configuration program, you might be asked whether you want to disable DMA for the infrared port. To use DMA channels for both the parallel and infrared ports, do the following:

1. Click **OK** to disable DMA for the infrared port.
2. Close a parallel port panel.
3. Click the **Infrared device** button to open the infrared panel.
4. Choose DMA0 or DMA1 for the infrared port on the panel.
5. If you see the panel asked whether you want to disable DMA for an audio device, click **OK**.

Standby or hibernation problems

Problem: The computer enters standby mode automatically.

Solution: If the processor reaches a temperature that is too high, the computer will automatically enter standby mode to allow the computer to cool and to protect the processor and other internal components.

Problem: The computer enters standby mode immediately after POST (the standby indicator turns on).

Solution: Make sure that:

- The battery is charged.
- The operating temperature is within the acceptable range. Refer to “Specifications” in this Guide.

If these items are correct, have the computer serviced.

Problem: The critical low-battery error appears, and the computer immediately turns off.

Solution: The battery power is getting low. Connect the ac adapter to the computer, or replace the battery with a fully charged one.

Problem: The computer display remains blank after you take action to return from a sleep mode.

Solution: Check if an external monitor was disconnected while the computer was in standby mode. **Do not disconnect the external monitor while the computer is in standby mode or hibernation mode. If no external monitor is attached when the computer resumes, the computer display remains blank and output is not displayed. This restriction does not depend on the resolution value.**

Problem: The computer does not return from standby mode, or the standby indicator stays on and the computer does not work.

Solution: The computer automatically enters standby or hibernation mode when the battery is depleted. Do one of the following:

- Replace the battery with a fully charged one and then press Fn.
- Connect the ac adapter to the computer; then press Fn.

Problem: Your computer does not enter standby or hibernation mode.

Solution: Check if any option has been selected to disable your computer from entering standby or hibernation mode.

Problem: When you are using the port replicator, resuming normal operation from hibernation or standby mode takes a long time.

Solution: If the Ethernet port is enabled, but the port replicator is not connected to a LAN, resuming operation can take a long time. The computer queries the Ethernet until the timeout timer stops the query. If you want to access an Ethernet, connect the network cable. If you are not using the network, disable the Ethernet port as follows:

For Windows XP:

1. Click **Start** → **Network Connections**.
2. Right-click the **Local Area Connection** icon for Intel 8255x-based PCI Ethernet Adapter (10/100); then click **Disable**.

For Windows 2000:

1. In the Control Panel, double-click the **System** icon.
2. Click the **Hardware** tab.
3. Click **Device Manager...**
4. Double-click **Network Adapter**.
5. Double-click **Intel 8255x-based PCI Ethernet Adapter (10/100)**.
6. Select **Do not use this device (disable)** in the Device usage list box.
7. Click **OK**.

For Windows 98 or Windows Millenium Edition (Me):

1. In the Control Panel, double-click the **System** icon.
2. Click the **Device Manager** tab.
3. Double-click **Network Adapter**.
4. Double-click **Intel EtherExpress PRO PCI Adapter**.
5. Select the **Disable in this hardware profile** check box.
6. Click **OK**.
7. Close all windows.
8. Restart the computer.

Problem: The computer does not enter standby mode as set by the timer under Windows 98.

For Windows 98:

The generic CD or DVD driver for Windows 98 accesses the internal CD or DVD drive every 3 seconds to see if a CD or DVD inserted in the CD or DVD drive. This prevents your computer from entering standby mode even after a timeout. To prevent this from occurring, do the following:

1. Click **Start**.
2. Move the cursor to **Settings** and **Control Panel**.
3. Click **Control Panel**, and then double-click **System**.

4. Click the **Device Manager** tab.
5. Click the + mark of **CD-ROM**.
6. Double-click the name of the CD or DVD drive.
7. Click the **Setting** tab.
8. Clear the **Auto insert notification** check box.

Windows 98 no longer detects the CD or DVD insertion automatically.

For Windows NT:

If you enable the CD-ROM AutoRun feature, the timer cannot trigger the computer to enter standby mode. To enable the timer in this situation, edit the configuration information in the registry as follows:

```
HKEY_LOCAL_MACHINE\SYSTEM\  
CurrentControlSet\Services\Cdrom\  
Autorun: 0x1 > Autorun: 0
```

Computer screen problems

Problem: The screen is blank.

Solution: Press Fn+Home to make the screen brighter. If you still have the problem persists, do the "Solution" in the problem below.

Problem: The screen is unreadable or distorted.

Solution: Make sure that:

- The display device driver is installed correctly.
- The display resolution and color depth are correctly set.
- The monitor type is correct.

To check these settings, do as follows:

For Windows XP:

1. Click **Start** → **Control Panel**.
2. Click **Appearance and Themes** in the Pick a category section.
3. Click **Display** in the Pick a Control Panel icon section.
4. Click the **Settings** tab.
5. Check whether the color depth and resolution are correctly set.
6. Click **Advanced**
7. Click the **Adapter** tab.
8. Make sure "Trident Video Accelerator CyberBlade-Ai1" is shown in the adapter information window.
9. Click the **Monitor** tab.
10. Make sure the information is correct.

For Windows 2000, Windows 98, or Windows Me:

1. Open the Display Properties window, by double-clicking the **Display** icon in the Control Panel.
2. Click the **Settings** tab.
3. Check whether the color depth and resolution are correctly set.
4. Click **Advanced...**
5. Click the **Adapter** tab.
6. Make sure "Trident Video Accelerator CyberBlade-Ai1 AGP" is shown in the adapter information window.
7. Click the **Monitor** tab.
8. Make sure the information is correct.

Problem: Incorrect characters appear on the screen.

Solution: Did you install the operating system or application program correctly? If they are installed and configured correctly, have the computer serviced.

Problem: The screen stays on even after you turn off your computer.

Solution: Press and hold the power switch for 4 seconds or over to turn off your computer; then turn it on again.

Problem: Missing, discolored, or bright dots appear on the screen every time you turn on your computer.

Solution: This is an intrinsic characteristic of the TFT technology. Your computer's display contains multiple thin-film transistors (TFTs). A small number of missing, discolored, or bright dots on the screen might exist all the time.

Problem: "Unable to create overlay window" message appears when you start DVD playback, *-or-* you may get poor playback or none at all while running video playback, DVD playback or game applications.

Solution: Do either of the following:

- If you are using the computer display and external monitor simultaneously with 32-bit color mode, change the color depth to 16-bit mode.
- If you are using a desktop size of 1280x1024 or larger, reduce the desktop size and the color depth.

Battery problems

Problem: The battery cannot be fully charged by the power-off method in the standard charge time for your computer.

Solution: The battery might be over-discharged. Do the following:

1. Turn off the computer.
2. Make sure that the over-discharged battery is in the computer.
3. Connect the ac adapter to the computer and let it charge.

If the optional Quick Charger is available, use it to charge the over-discharged battery.

If the battery cannot be fully charged in 24 hours, use a new battery.

Solving computer problems

Problem: Your computer shuts down before the battery status indicator shows empty, *-or-* Your computer operates after the battery status indicator shows empty.

Solution: Discharge and recharge the battery.

Problem: The operating time for a fully charged battery is short.

Solution: Discharge and recharge the battery. If your battery's operating time is still short, use a new battery.

Problem: The computer does not operate with a fully charged battery.

Solution: The surge protector in the battery might be active. Turn off the computer for one minute to reset the protector; then turn on the computer again.

Problem: The battery cannot be charged.

Solution: You cannot charge the battery when it is too hot. If the battery feels hot, remove it from the computer and allow it to cool to room temperature. After it cools, reinstall it and recharge the battery. If it still cannot be charged, have it serviced.

Hard disk drive problems

Problem: The hard disk drive makes a rattling noise intermittently.

Solution: The rattling noise might be heard when:

- The hard disk drive starts accessing the data or it stops.
- You carry the hard disk drive.
- You carry your computer.

This is a normal characteristic of a hard disk drive and is not a defect.

Problem: The hard disk drive does not work.

Solution: Use PC-Doctor to test the hard disk drive. If there are problems, have the hard disk drive serviced.

CD-ROM, DVD-ROM, CD-RW, DVD/CD-RW drive problems

Problem: The CD or DVD does not work.

Solution: Make sure that:

- The computer power is turned on and a CD or DVD is properly loaded on the center pivot of the CD or DVD drive. (You should hear a click.)

- The CD or DVD tray is firmly closed.
- The device drivers are correctly installed.

Problem: You hear a noise from the CD or DVD drive when the disc is spinning.

Solution: The CD or DVD drive cover might be bent. Have the computer serviced.

Problem: The CD or DVD tray does not open even if you press the CD or DVD drive eject button.

Solution: Insert a pin into the CD or DVD emergency eject hole and eject the CD or DVD tray.

Problem: The CD or DVD cannot be read.

Solution: Make sure that:

- The CD or DVD is not dirty. If it is, clean it with a CD or DVD cleaner kit.
- The CD or DVD is not defective. If it is, try another CD or DVD.
- The CD or DVD is placed in the tray with the label side up.
- The CD or DVD format conforms with one of the following:
 - Music CD
 - CD-ROM or CD-ROM XA
 - Multisession photo CD
 - Video CD
 - CD-R or CD-RW
 - DVD-ROM (DVD-video)

Note: You can only playback DVD movies if your computer has a DVD-ROM or DVD/CD-RW drive and the DVD movie playback software is installed.

Problem: The DVD movie does not play.

Solution: The region code of the DVD movie you inserted into the DVD-ROM or DVD/CD-RW drive must match the region code you set for the DVD Player software. You can set the region code a maximum of 5 times. If you have not reached the limit, a prompt appears and you change it to the region code of the inserted DVD movie. If not, you will only be able to play DVD movies of the last region you set.

Solving computer problems

Problem: The control buttons on the DVD movie playback software do not work.

Solution: The DVD movie playback software is reading the DVD. Wait for a few seconds before trying the buttons again.

Problem: A CD cannot be written.

Solution: Make sure the CD you placed in the CD-RW or DVD/CD-RW drive is either a CD-R or CD-RW. If you are writing to a CD-R, make sure it is blank.

Note: You can write CDs if your computer has a CD-RW or DVD/CD-RW drive and a CD recording software is installed.

Problem: A written CD has errors.

Solution: Make sure your computer is protected from vibration when writing to a CD. Even typing on the computer will cause vibration that may result in errors in the written CD or even a damaged and unreadable CD.

Note: You can write CDs if your computer has a CD-RW or DVD/CD-RW drive and a CD recording software is installed.

Software problems

Problem: An application does not run correctly.

Solution: Make sure that the problem is not being caused by the application by checking the following:

- Your computer has the minimum required memory to run the application. Refer to the manuals supplied with the application.
- The application is designed to operate with your operating system.
- Other applications run correctly on your computer.
- The necessary device drivers are installed.
- The application works when it is run on some other computer.

If an error message appears when you are using the application program, refer to the manuals supplied with the application.

If the application still does not run correctly, contact your place of purchase or a service representative for help.

Problem: The Windows Safe Mode screen appears.

Solution: Your computer may not have shut down properly the last time. In Safe Mode, shut down and restart your computer.

If you still have a problem, contact your place of purchase or the service representative for help.

Other problems

Problem: The computer locks or does not accept any input.

Solution: Your computer might lock when it enters standby mode during a communication operation. Disable the standby timer when you are working on the network.

To turn off the computer, press and hold the power switch for 4 seconds or more.

Problem: The computer does not turn off with the power switch.

Solution: If the standby indicator is on and you are working under battery power, replace the battery with a fully charged one or change your power source to ac power.

If you still have a problem, press and hold the power switch for 4 seconds or more; this forces the computer to turn off.

Problem: The computer does not start from a device you want, such as a diskette drive.

Solution: Refer to the Startup Configuration menu of the **IBM BIOS Setup Utility**. Make sure that the startup sequence in the IBM BIOS Setup Utility is set so that the computer starts from the device you want.

Starting BIOS Setup Utility

Your computer provides a program, called IBM BIOS Setup Utility, that enables you to select various setup parameters. The panels in this utility are as follows:

- **Config:** Set the configuration of your computer.
- **Date:** Set the date and time.
- **Password:** Set a password.
- **Startup:** Set the startup device.
- **Restart:** Restart the system.

Note: You can set some of these parameters more easily by using the ThinkPad Configuration Program. For more information on this program, refer to the on-board help.

To start IBM BIOS Setup Utility, do as follows:

1. To protect yourself against accidental loss of data, refer to “Backing up your registry” in Access ThinkPad. Open Access ThinkPad by pressing the ThinkPad button. Backing up your registry will save your computer’s current configuration.
2. Remove any diskette from the diskette drive, and remove any CD or DVD from the CD or DVD drive; then turn off the computer.
3. Turn on the computer; then, while the “ Press F1 for IBM BIOS Setup Utility ” message is displayed at the lower-left of the screen, press F1.

If you have set a supervisor password, the “IBM BIOS Setup Utility” menu appears after you enter the password. You can start the utility by pressing Enter instead of entering the supervisor password; then, however, you cannot change the parameters that are protected by the supervisor password. For more information, refer to the on-board help provided with your computer.

4. Using the cursor keys, move to an item you want to change. When the item you want is highlighted, press Enter. A submenu is displayed.
5. Change the items you want to change. To change the value of an item, use the F5 or F6 key. If the item has a submenu, you can display it by pressing Enter.
6. Press F3 or Esc to exit from the submenu.

If you are in a nested submenu, press Esc repeatedly until you reach the IBM BIOS Setup Utility menu.

7. Select **Restart**; then press Enter. Change the option you want; then press Enter. Your computer restarts.

Notes:

1. The Restart submenu offers you such options as loading the default settings or discarding the changes.
2. If you need to restore the settings to their original state as of the time of purchase, press the F9 key to load the default settings.

Recover pre-installed software

If the data on your hard disk drive is damaged or accidentally erased, you can restore the software that was shipped with your computer. This software includes your pre-installed operating system, applications, and device drivers.

To restore your pre-installed software, you can use either the Product Recovery program or a Recovery CD.

The Product Recovery program is in a section of your hard disk drive that is not displayed by Windows Explorer. You may use a Recovery CD if it was provided with your computer.

In case of a hard disk drive failure, or if the Product Recovery program is accidentally deleted or becomes damaged, you can order a Product Recovery CD from IBM.

Note: The recovery process might take up to 2 hours.

Attention

All of the files on the C:\ drive will be lost in the recovery process. Be sure to back up copies of the files you have saved on your C:\ drive before you begin.

Note: You might need to use a CD, DVD, or a diskette drive in the recovery process. Use a drive that is compatible with your computer.

To use the Product Recovery program to restore your pre-installed software, do the following:

1. Save all your files and shut down your desktop.
2. Turn off your computer.
3. Turn on your computer. Quickly press F11 when this message is displayed on the screen: "To start the Product Recovery program, press F11." This message is displayed for only a few seconds.

Note: If this message is not displayed, you can use a **Recovery Repair diskette** to get access to the Product Recovery program.

4. From the list displayed on the screen, select the operating system you want to recover.
5. Select the recovery options you want, and follow the instructions on the screen.
6. Restart the system. Your computer will restart with the pre-installed operating system, drivers, and software.

To use a Recovery CD to restore your pre-installed software, do the following:

1. Insert the Recovery CD into the CD or DVD drive.
2. Save all your files, and turn off your computer.
3. Change the boot sequence as follows:
 - a. Turn on your computer; then while the Press F1 for IBM BIOS Setup Utility message is displayed at the lower left of the screen, press the F1 key to start the BIOS Setup Utility.

Note: To start up your computer from the CD or DVD drive temporarily, press F12 instead of F1, then select CD-ROM Drive and press Enter.
 - b. With the cursor key, select Startup; then press Enter.
 - c. Select Boot; then press Enter.
 - d. Select CD-ROM Drive; then press F5 repeatedly until it is at the top of the list.
 - e. Press F10; then press Enter to save the changes and exit the IBM BIOS Setup Utility.
4. The Product Recovery program menu opens. From the list displayed on the screen, select the operating system you want to recover.
5. Select the recovery options you want, and follow the instructions on the screen.
6. Restart the system. Your computer will restart with the pre-installed operating system, drivers, and software.

To create a Recovery Repair diskette

If the prompt needed to access the Product Recovery Program is not displayed, use the Recovery Repair diskette to recover the prompt. Make a Recovery Repair diskette and save it for future use. To make a Recovery Repair diskette:

1. Shut down and restart your computer.
2. Attach the external diskette drive to the computer.
3. At the prompt, press F11. (The option to press F11 appears for only a few seconds. You must press F11 quickly.) The Product Recovery program main menu appears.
4. Select **System Utilities** from the main menu. Press Enter.
5. Select **Create a Recovery Repair** diskette. Press Enter.
6. Follow the on-screen instructions.
7. When the process is completed, label your diskette as the Recovery Repair diskette and save it for future use.

To use the Recovery Repair diskette:

1. Shut down and turn off your computer.
2. Attach the external diskette drive to the computer.
3. Insert the Recovery Repair diskette into the drive; then turn on the computer.
4. Follow the on-screen instructions.

Installing a new operating system and device drivers

If you install a new operating system on your computer, you need to install the ThinkPad[®] device drivers for it at the same time.

The device drivers are provided in the C:\IBMTTOOLS\DRIVERS directory on your hard disk drive. The software applications are provided in the C:\IBMTTOOLS\APPS directory on your hard disk drive. Operating system updates are provided in the C:\IBMTTOOLS\OSFIXES directory on your hard disk drive. These directories also contain text files explaining how to install the drivers.

Note: If you cannot find the device drivers you need on your hard disk drive, or if you want to receive updates and the latest information about them, refer to the ThinkPad Service & Support Web site. To access this Web site, open Access ThinkPad by pressing the ThinkPad button; then click the Service & Support image on the right of the screen.

For instructions on how to install a new operating system, see the on-board help, Access ThinkPad.

Backing up your system

Backing up your registry

When you add software applications or devices to your computer, the installation process may change your registry and configuration.

If your computer does not work properly after you add applications or devices, you need to restore the previous registry.

Before you make changes, backup the configuration. If something goes wrong, you can restore the system registry and configuration files.

You can use ConfigSafe (for Windows 98 and Windows 2000) or System Restore (for Windows XP and Windows Millenium Edition) to save the configuration before you make changes. Then if something goes wrong, use ConfigSafe or System Restore to restore the system registry and configuration files.

For Windows XP:

To capture a snapshot of your system configuration, or to restore your configuration to an earlier snapshot using Windows XP:

1. Click **Start** → **Control Panel**.
2. Click **Performance and Maintenance** in the Pick a category section.
3. Click **System Restore** in the Pick a task... section.
4. Follow the on-screen instructions.

If you need to restore a configuration snapshot, open ConfigSafe and follow the on-screen instructions.

For Windows 2000 or Windows 98:

To capture a snapshot of your system configuration with ConfigSafe:

1. Click **Start** → **Programs** → **ConfigSafe** → **ConfigSafe**
2. Double-click **ConfigSafe**. The window opens.
3. Click the **camera** icon.
4. Type a name for the snapshot. For example, before installing a word processor, you might type, "Before installing a word processor."
5. Click **OK**.

6. After a few moments, the main ConfigSafe window will return. The snapshot is complete.

If you need to restore a configuration snapshot, open ConfigSafe and follow the on-screen instructions.

For Windows Me:

To capture a snapshot of your system configuration, or to restore your configuration to an earlier snapshot using Windows Me, click **Start** → **Programs** → **Accessories** → **System Tools** → **System Restore** and follow the on-screen instructions.

Backing up data

Hard disks are reliable data storage devices. However, you should protect yourself against accidental data loss or the unlikely event of a hard disk malfunction by backing up your important files regularly.

For Windows XP:

To back up data, start the backup application as follows:

1. Click **Start** → **Control Panel**.
2. Click **Performance and Maintenance** in the Pick a category section.
3. Click **Back up my data** in the Pick a task... section.
4. Follow the on-screen instructions.

For Windows 2000 or Windows 98:

To back up data, start the backup application as follows:

1. Click **Start**.
2. Move the cursor to **Programs**, **Accessories**, **System Tools**, and **Backup**.
3. Click **Backup**.

Make sure that the **Create a new backup job** button is marked in the Microsoft Backup window.

4. Click **OK**. The Backup Wizard will guide you through backing up some or all of the files on your hard disk.

For Windows Me:

To back up data using Windows Me, copy your files to a diskette drive or another storage device on a regular basis.

Replacing the hard disk drive

You can increase the storage capacity of your computer by replacing the hard disk drive with one of greater capacity. You can purchase a new hard disk drive from your IBM reseller or IBM marketing representative.

Note: Replace the hard disk drive only if you upgrade it or have it repaired. The connectors and bay of the hard disk drive were not designed for frequent changes, or drive swapping.

Attention

Handling a hard disk drive

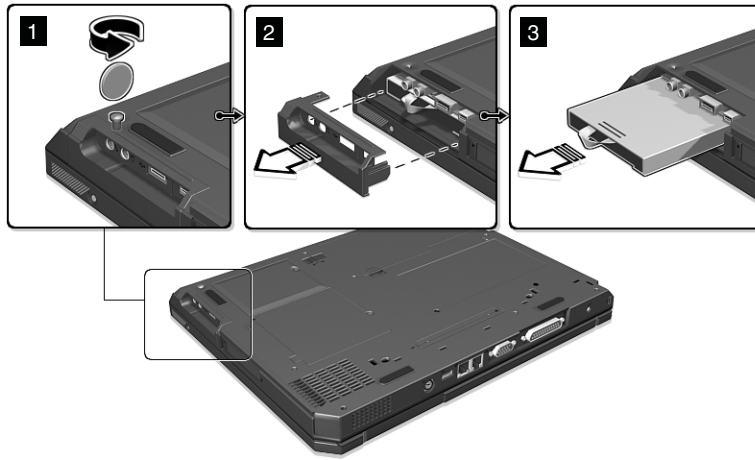
- Do not drop the drive or subject it to physical shocks. Put the drive on a material, such as soft cloth, that absorbs the physical shock.
- Do not apply pressure to the cover of the drive.
- Do not touch the connector.

The drive is very sensitive. Incorrect handling can cause damage and permanent loss of data on the hard disk. Before removing the hard disk drive, make a backup copy of all the information on the hard disk drive, and then turn the computer off. Never remove the drive while the system is operating, in standby mode, or in hibernation mode.

To replace the hard disk drive, do the following:

1. **Turn off the computer;** then disconnect the ac adapter and all cables from the computer.
2. Close the computer display, and turn the computer over.
3. Remove the battery.

4. Loosen the coin screw that secures the hard disk drive **1**. You can use a coin in the slot of the screw.



5. Remove the hard-disk-drive cover by pulling it away from the computer **2**.
6. Pull on the hard-disk-drive tab and pull out the hard disk drive **3**.
7. Insert the hard disk drive into the hard-disk-drive bay; then firmly re-install the hard-disk-drive cover and secure it with the coin-screw.
8. Reinstall the battery.
9. Turn the computer over. Connect the ac adapter and cables to the computer.

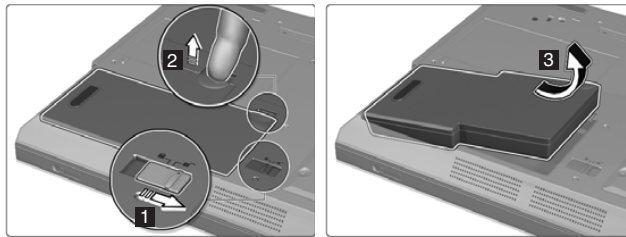
Replacing the battery

To replace the battery, do as follows:

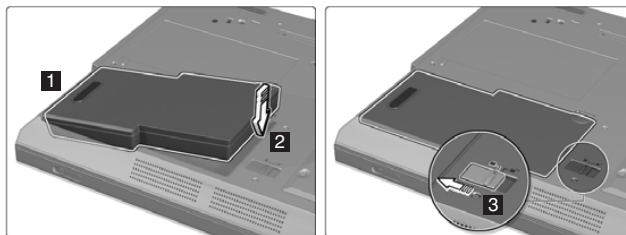
1. **Turn off the computer, or enter hibernation mode.** Then disconnect the ac adapter and all cables from the computer.

Note: If you are using a PC Card, the computer may not be able to enter hibernation mode. If this happens, turn off the computer.

2. Close the computer display, and turn the computer over.
3. Remove the battery.
 - a. Slide and hold the battery latch in the unlock position **1**.
 - b. Insert your finger in the notch and lift up the battery **2**.
 - c. Pull up and remove the battery **3**.



4. Reinstall the battery.
 - a. Insert the end of the battery (with the rubber feet) into the battery compartment **1**.
 - b. Let down the other end of the battery securely into the battery compartment **2**.
 - c. Slide the battery latch into the lock position **3**.



5. Turn the computer over again. Connect the ac adapter and the cables to the computer.

Getting help and service

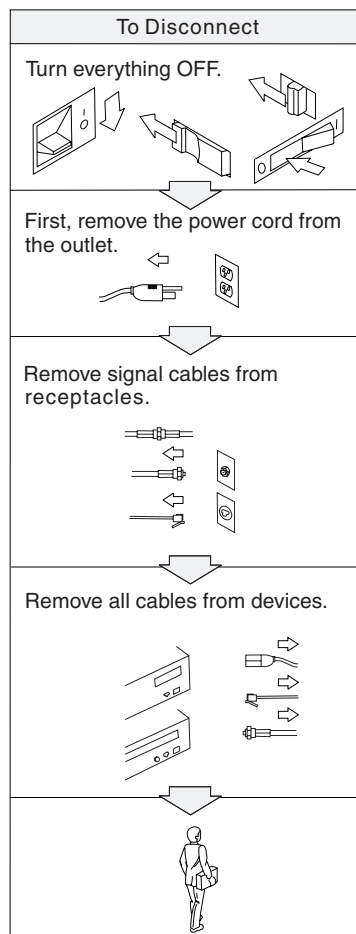
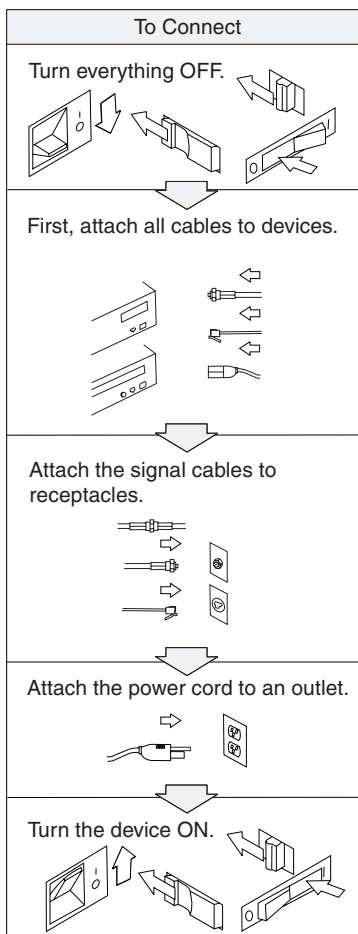

Appendix A. Important safety instructions



DANGER

Electric current from power, telephone, and communication cables is hazardous. 1. The warranties provided by IBM in this Statement of Limited Warranty apply only to Machines you purchase for your use, and not for resale, from IBM or your reseller. The term "Machine" means an IBM machine, its features, conversions, upgrades, elements, or accessories, or any combination of them. The term "Machine" does not include any software programs, whether pre-loaded with the Machine, installed subsequently or otherwise. Unless IBM specifies otherwise, the following warranties apply only in the country where you acquire the Machine. Nothing in this Statement of Limited Warranty affects any statutory rights of consumers that cannot be waived or limited by contract. If you have any questions, contact IBM or your reseller.

The IBM Warranty for Machines

IBM warrants that each Machine 1) is free from defects in materials and workmanship and 2) conforms to IBM's Official Published Specifications ("Specifications"). The warranty period for a Machine is a specified, fixed period commencing on its Date of Installation. The date on your sales receipt is the Date of Installation unless IBM or your reseller informs you otherwise.

If a Machine does not function as warranted during the warranty period, and IBM or your reseller are unable to either 1) make it do so or 2) replace it with one that is at least functionally equivalent, you may return it to your place of purchase and your money will be refunded.

Extent of Warranty

The warranty does not cover the repair or exchange of a Machine resulting from misuse, accident, modification, unsuitable physical or operating environment, improper maintenance by you, or failure caused by a product for which IBM is not responsible. The warranty is voided by removal or alteration of Machine or parts identification labels.

THESE WARRANTIES ARE YOUR EXCLUSIVE WARRANTIES AND REPLACE ALL OTHER WARRANTIES OR CONDITIONS, EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OR CONDITIONS OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. THESE WARRANTIES GIVE YOU SPECIFIC LEGAL RIGHTS AND YOU MAY ALSO HAVE OTHER RIGHTS WHICH VARY FROM JURISDICTION TO JURISDICTION. SOME JURISDICTIONS DO NOT ALLOW THE EXCLUSION OR LIMITATION OF EXPRESS OR IMPLIED WARRANTIES, SO THE ABOVE EXCLUSION OR LIMITATION MAY NOT APPLY TO YOU. IN THAT EVENT, SUCH WARRANTIES ARE LIMITED IN DURATION TO THE WARRANTY PERIOD. NO WARRANTIES APPLY AFTER THAT PERIOD.

Items Not Covered by Warranty

IBM does not warrant uninterrupted or error-free operation of a Machine.

Any technical or other support provided for a Machine under warranty, such as assistance via telephone with "how-to" questions and those regarding Machine set-up and installation, will be provided **WITHOUT WARRANTIES OF ANY KIND**.

Warranty Service

To obtain warranty service for a Machine, contact IBM or your reseller. If you do not register your Machine with IBM, you may be required to present proof of purchase.

During the warranty period, IBM or your reseller, if approved by IBM to provide warranty service, provides without charge certain types of repair and exchange service to keep Machines in, or restore them to, conformance with their Specifications. IBM or your reseller will inform you of the available types of service for a Machine based on its country of installation. At its discretion, IBM or your reseller will 1) either repair or exchange the failing Machine and 2) provide the service either at your location or a service center. IBM or your reseller will also manage and install selected engineering changes that apply to the Machine.

Some parts of IBM Machines are designated as Customer Replaceable Units (called "CRUs"), e.g., keyboards, memory, or hard disk drives. IBM ships CRUs to you for replacement by you. You must return all defective CRUs to IBM within 30 days of your receipt of the replacement CRU. You are responsible for downloading designated Machine Code and Licensed Internal Code updates from an IBM Internet Web site or from other electronic media, and following the instructions that IBM provides.

When warranty service involves the exchange of a Machine or part, the item IBM or your reseller replaces becomes its property and the replacement becomes yours. You represent that all removed items are genuine and unaltered. The replacement may not be new, but will be in good working order and at least functionally equivalent to the item replaced. The replacement assumes the warranty service status of the replaced item. Many features, conversions, or upgrades involve the removal of parts and their return to IBM. A part that replaces a removed part will assume the warranty service status of the removed part.

Before IBM or your reseller exchanges a Machine or part, you agree to remove all features, parts, options, alterations, and attachments not under warranty service.

You also agree to

1. ensure that the Machine is free of any legal obligations or restrictions that prevent its exchange;

2. obtain authorization from the owner to have IBM or your reseller service a Machine that you do not own; and
3. where applicable, before service is provided:
 - a. follow the problem determination, problem analysis, and service request procedures that IBM or your reseller provides;
 - b. secure all programs, data, and funds contained in a Machine;
 - c. provide IBM or your reseller with sufficient, free, and safe access to your facilities to permit them to fulfill their obligations; and
 - d. inform IBM or your reseller of changes in a Machine's location.

IBM is responsible for loss of, or damage to, your Machine while it is 1) in IBM's possession or 2) in transit in those cases where IBM is responsible for the transportation charges.

Neither IBM nor your reseller is responsible for any of your confidential, proprietary or personal information contained in a Machine which you return to IBM or your reseller for any reason. You should remove all such information from the Machine prior to its return.

Limitation of Liability

Circumstances may arise where, because of a default on IBM's part or other liability, you are entitled to recover damages from IBM. In each such instance, regardless of the basis on which you are entitled to claim damages from IBM (including fundamental breach, negligence, misrepresentation, or other contract or tort claim), except for any liability that cannot be waived or limited by applicable laws, IBM is liable for no more than

1. damages for bodily injury (including death) and damage to real property and tangible personal property; and
2. the amount of any other actual direct damages, up to the charges (if recurring, 12 months' charges apply) for the Machine that is subject of the claim. For purposes of this item, the term "Machine" includes Machine Code and Licensed Internal Code.

This limit also applies to IBM's suppliers and your reseller. It is the maximum for which IBM, its suppliers, and your reseller are collectively responsible.

UNDER NO CIRCUMSTANCES IS IBM LIABLE FOR ANY OF THE FOLLOWING: 1) THIRD-PARTY CLAIMS AGAINST YOU FOR DAMAGES (OTHER THAN THOSE UNDER THE FIRST ITEM LISTED ABOVE); 2) LOSS OF, OR DAMAGE TO, YOUR RECORDS OR DATA; OR 3) SPECIAL, INCIDENTAL, OR INDIRECT DAMAGES OR FOR ANY ECONOMIC CONSEQUENTIAL DAMAGES, LOST PROFITS OR LOST SAVINGS, EVEN IF IBM, ITS SUPPLIERS OR YOUR RESELLER IS INFORMED OF THEIR POSSIBILITY. SOME JURISDICTIONS DO NOT

ALLOW THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE LIMITATION OR EXCLUSION MAY NOT APPLY TO YOU.

Governing Law

Both you and IBM consent to the application of the laws of the country in which you acquired the Machine to govern, interpret, and enforce all of your and IBM's rights, duties, and obligations arising from, or relating in any manner to, the subject matter of this Agreement, without regard to conflict of law principles.

ASIA PACIFIC

AUSTRALIA

The IBM Warranty for Machines: *The following paragraph is added to this Section:*

The warranties specified in this Section are in addition to any rights you may

have under the Trade Practices Act 1974 or other similar legislation and are only limited to the extent permitted by the applicable legislation.

Limitation of Liability: *The following is added to this Section:*

Where IBM is in breach of a condition or warranty implied by the Trade Practices Act 1974 or other similar legislation, IBM's liability is limited to the repair or replacement of the goods or the supply of equivalent goods. The arbitrator or arbitrators designated in conformity with those rules shall have the power to rule on their own competence and on the validity of the Agreement to submit to arbitration. The arbitration award shall be final and binding for the parties without appeal and the arbitral award shall be in writing and set forth the findings of fact and the conclusions of law.

All proceedings shall be conducted, including all documents presented in such proceedings, in the English language. The number of arbitrators shall be three, with each side to the dispute being entitled to appoint one arbitrator.

The two arbitrators appointed by the parties shall appoint a third arbitrator before proceeding upon the reference. The third arbitrator shall act as chairman of the proceedings. If one of the parties refuses or otherwise fails to appoint an arbitrator within 30 days of the date the other party appoints its, the first appointed arbitrator shall be the sole arbitrator, provided that the arbitrator was validly and properly appointed.

The English language version of this Agreement prevails over any other language version.

INDIA

Any disputes arising from or in connection with this Agreement will first be resolved by friendly negotiations, failing which either of us has the right to submit the dispute to the China International Economic and Trade Arbitration Commission in Beijing, the PRC, for arbitration in accordance with its arbitration rules in force at the time. The arbitration tribunal will consist of three arbitrators. The language to be used therein will be English and Chinese. An arbitral award will be final and binding on all the parties, and will be enforceable under the Convention on the Recognition and Enforcement of Foreign Arbitral Awards (1958).

The arbitration fee will be borne by the losing party unless otherwise determined by the arbitral award.

During the course of arbitration, this Agreement will continue to be performed except for the part which the parties are disputing and which is undergoing arbitration.

If you purchase an IBM Machine in a Middle Eastern or African country, you may obtain warranty service for that Machine from the IBM entity within the country of purchase, if that IBM entity provides warranty service in that country, or from an IBM reseller, approved by IBM to perform warranty service on that Machine in that country. 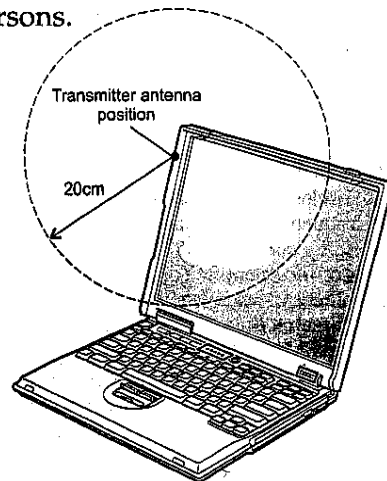
