No.	Item	Action & Function
1	Touch Screen	<ul style="list-style-type: none"> • Display phone's system status. • Tap to select and highlight touch-sensitive screen items.
2	Call Control Button	<ul style="list-style-type: none"> • Press to answer, reject, or end a call. • Hold 2 seconds to activate Cortana (this requires Microsoft's support). • Press to invoke the Teams client in the idle state.
3	Volume Up Button	Press to turn up volume.
4	Volume Down Button	Press to turn down volume.
