2.6 Transmit Power Control (TPC)




5. Test Procedure

5.1 DFS Measurement System

A complete DFS Measurement System consists of Radar signal generate system to generating the radar waveforms in Table 10, 11 and 12. The traffic monitoring system is specified to the type of unit under test (UUT).

Channel Loading

System testing will be performed with channel-loading using means appropriate to the data types that are used by the unlicensed device. The following requirements apply:


a)	The data file must be of a type that is typical for the device (i.e., MPEG-2, MPEG-4, WAV, MP3, MP4, AVI, etc.) and must generally be transmitting in a streaming mode.	
b)	Software to ping the client is permitted to simulate data transfer but must have random ping intervals.	
c)	Timing plots are required with calculations demonstrating a minimum channel loading of approximately 17% or greater.	√
d)	Unicast or Multicast protocols are preferable but other protocols may be used. The appropriate protocol used must be described in the test procedures.	



5.2 Calibration of DFS Detection Threshold Level

The measured channel is chosen from the operating channels of the UUT within the 5250-5350MHz or 5470-5725MHz and using the widest bandwidth mode available for the link. The radar signal was the same as transmitted channels, and injected into the antenna port of AP (master) or Client Device with Radar Detection, measured the channel closing transmission time and channel move time. The Master antenna gain is 2.24dBi and required detection threshold is -60.76dBm (= -64 +1 +2.24). The calibrated conducted detection threshold level is set to -60.76 dBm.




6.2 Test Results

6.2.1 Test Mode: Device Operating In Client without Radar Detection Mode.

The Required detection threshold is -60.76dBm (= -64 +1 +2.24). The conducted radar burst level is set lower than -60.76dBm.






6.2.2 Channel Closing Transmission and Channel Move Time






EUT (Client) links with master on 5570MHz

Client performed with channel-loading via master.










6.2.4 Non-Associated Test


