4. Portable Device Evaluation Method and Limit

Following FCC KDB 447498 D01 "General SAR test exclusion guidance" The corresponding SAR Exclusion Threshold condition, listed below:

- ◆ The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz at test separation distances ≤ 50 mm are determined by:
 - $[(\text{max. power of channel, including tune-up tolerance, mW})/(\text{min. test separation distance, mm})] [\sqrt{f(\text{GHz})}] \leq 3.0$ for 1-g SAR, and ≤ 7.5 for 10-g extremity SAR, where
 - $f(\text{GHz})$ is the RF channel transmit frequency in GHz.
 - Power and distance are rounded to the nearest mW and mm before calculation.
 - The result is rounded to one decimal place for comparison. The test exclusions are applicable only when the minimum test separation distance is ≤ 50 mm and for transmission frequencies between 100 MHz and 6 GHz. When the minimum test separation distance is < 5 mm, a distance of 5 mm is applied to determine SAR test exclusion.
- ◆ At 100 MHz to 6 GHz and for test separation distances > 50 mm, the SAR test exclusion threshold is determined according to the following:
 - [Threshold at 50 mm in step 1) + (test separation distance - 50mm) ($f(\text{MHz})/150$)] mW, at 100MHz to 1500 MHz;
 - [Threshold at 50 mm in step 1) + (test separation distance - 50 mm)-10] mW at > 1500 MHz and ≤ 6 GHz;
- ◆ At frequencies below 100 MHz, the following may be considered for SAR test exclusion.
 - The threshold at the corresponding test separation distance at 100 MHz in step 2) is multiplied by $[1 + \log(100/f(\text{MHz}))]$ for test separation distances > 50 mm and < 200 mm.
 - The threshold determined by the equation in a) for 50 mm and 100 MHz is multiplied by 1/2 for test separation distances ≤ 50 mm.
 - SAR measurement procedures are not established below 100 MHz. When SAR test exclusion cannot be applied, a KDB inquiry is required to determine SAR evaluation requirements for any test results to be acceptable.

According to KDB447498 D01 V06, threshold at which no SAR required is ≤3.0 for 1-g SAR, separation distance is 5mm, and no simultaneous SAR measurement is required.

- Max Output Power (dBm) = Field Strength of Fundamental (dBuV/m@3m)-95.23
- Max Output Power (mW) = $10^{(\text{Max power (dBm)}/10)}$
- The wireless function BT and NFC of the device can transmit at the same time, and the final exemption result is $0.55/3.0 + 0.0097/442.974 = 0.18335 < 1.0$.

Since Source-base time average power is below SAR test exclusion power thresholds, the SAR evaluation is not required.
