### Hopping Channel Number\_DH5\_2402

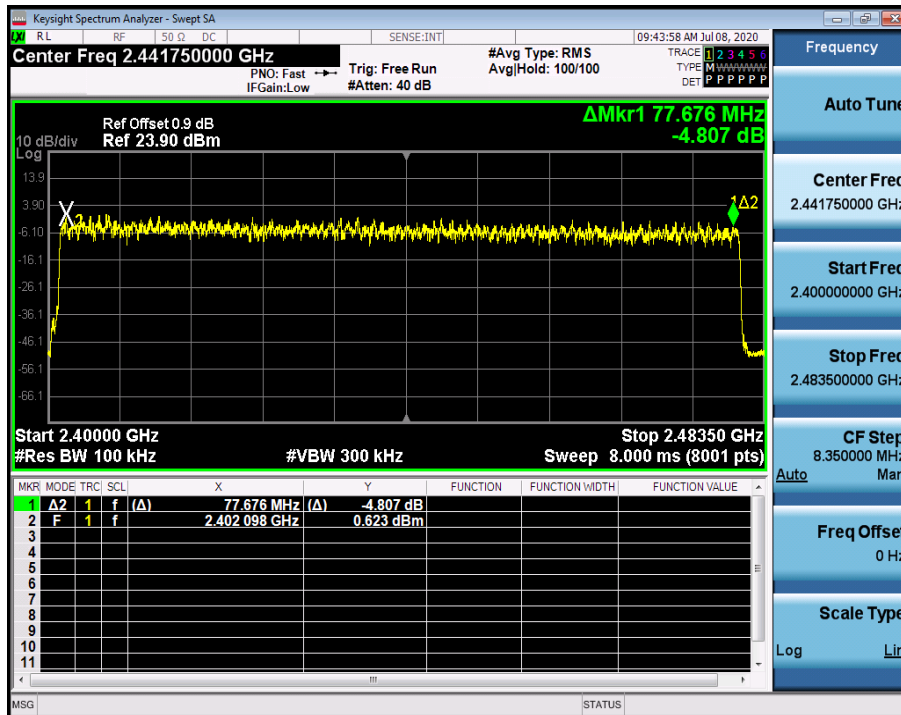
