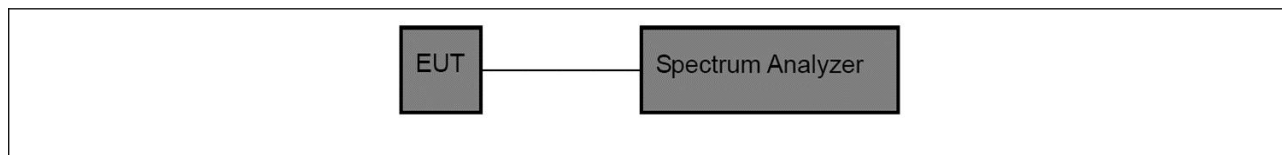
## 5. Maximum Conducted Output Power

Test Requirement:	47 CFR 15.247(b)(3)

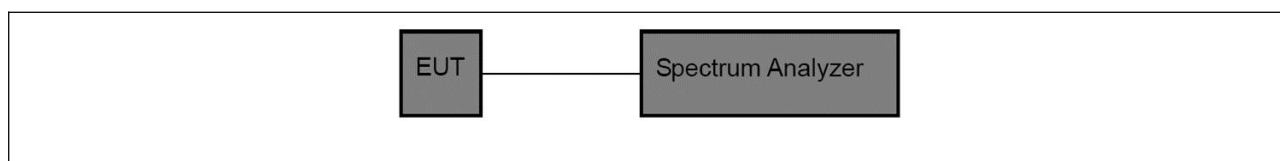

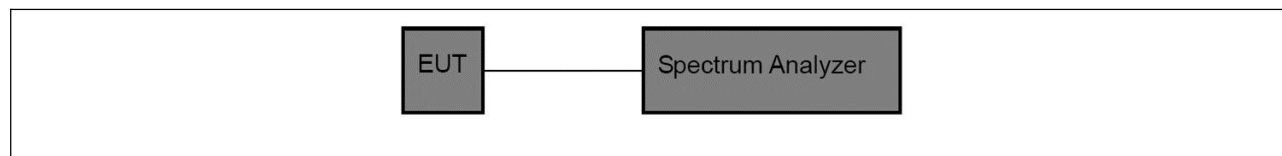
## 7. Emissions in non-restricted frequency bands
