
8.2 TEST PROCEDURE

- a. The measuring distance of at 3 m shall be used for measurements at frequency 0.009MHz up to 1GHz,and above 1GHz.
- b. The EUT was placed on the top of a rotating table 0.1 meters (above 1GHz is 0.8 m) above the ground at a 3 meter anechoic chamber test site. The table was rotated 360 degrees to determine the position of the highest radiation.



(A) Radiated Emission Test-Up Frequency Below 30MHz




(B) Radiated Emission Test-Up Frequency 30MHz~1GHz
