

 <p><b>EN</b></p> <p><b>Important Reminders</b></p> <ol style="list-style-type: none"><li>The charger only supports magnetic attachment with a caseless iPhone with MagSafe, an official MagSafe case, an ESR HaloLock™ case, or a standard case with a HaloLock™ Universal Ring. It may not attach to other magnetic cases. It will not attach to any other non-magnetic phones or cases. (Over time, the charger may leave a faint circular mark on the back of your phone that can be easily cleaned with an alcohol wipe.)</li><li>This charger supports an input of 9V - 2A. The output supported by iPhone is 7.5W.</li><li>Only use the cable provided with the charger.
