GENERAL INFORMATION

Product Description for Equipment Under Test (EUT)

The *SWAGTEK*'s product, model number: *LOGIC F3* (*FCC ID: 055183317*) (the "EUT") in this report was a *1.77 inch Feature Flip Phone*, which was measured approximately: 9.45 cm (L) x 4.7 cm (W) x 1.88 cm (H), DC3.7V from Battery or DC 5V from adapter. The highest operation frequency is 2480MHz.

Note: The series product, models UNONU U8,iSWAG FLIP are electrically identical with the model LOGIC F3, the difference between them is just the model name, we selected LOGIC F3 for fully testing. The detail was explained in the attached declaration letter.

Objective





Note: 1. Support units were connected to second LISN.

2. Both of LISNs (AMN) 80 cm from EUT and at the least 80 cm from other units and other metal planes support units.

The setup of EUT is according with per ANSI C63.4-2014 measurement procedure. The specification used was with the FCC Part 15 B Class B limits.

The external I/O cables were draped along the test table and formed a bundle 30 to 40 cm long in the middle.

The adapter was connected to the Main LISN with 120V/60Hz AC power source.

EMI Test Receiver Setup

The EMI test receiver was set to investigate the spectrum from 150 kHz to 30 MHz.

Maximizing procedure was performed on the six (6) highest emissions of the EUT.

All data was recorded in the Quasi-peak and average detection mode.



Test Procedure

During the radiated emissions, the adapter of laptop was connected to the first AC floor outlet and the other support equipments were connected to the second AC floor outlet.

Maximizing procedure was performed on the highest emissions to ensure that the EUT complied with all installation combinations.

The data was recorded in the Quasi-peak detection mode for below 1 GHz, peak and average detection mode above 1 GHz.
