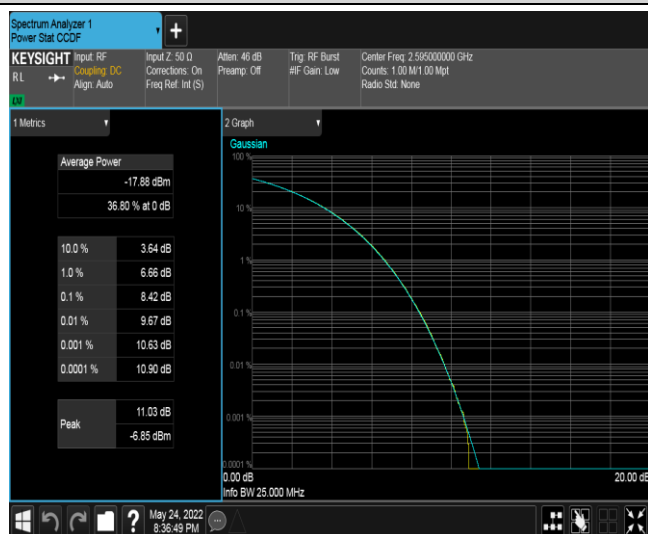




**Band38-5MHz-QPSK-38000-1RB#0**

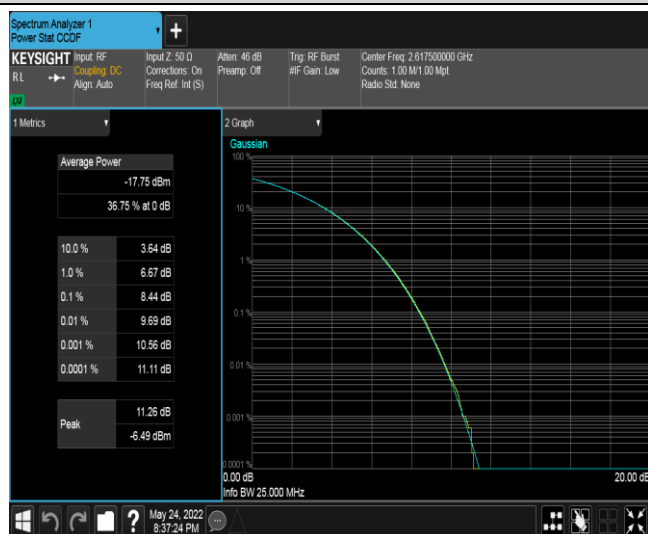
