3.5. Field Strength Calculation

The field strength is calculated by adding the Antenna Factor and Cable Factor and subtracting the Amplifier Gain and Duty Cycle Correction Factor (if any) from the measured reading. The basic equation with a sample calculation is as follows:

Test procedure:	1. The EUT was setup and tested according to ANSI C63.10.
	2. The EUT is placed on a turn table which is 0.8 meter above ground for below 1 GHz, and 1.5 m for above 1 GHz. The turn table is rotated 360 degrees to determine the position of the maximum emission level.
	 The EUT was set 3 meters from the receiving antenna, which was mounted on the top of a variable height antenna tower.
	4. For each suspected emission, the EUT was arranged to its worst case and then tune the Antenna tower (from 1 m to 4 m) and turntable (from 0 degree to 360 degrees) to find the maximum reading. - Average measurement was not performed if peak level is lower than average limit(54 dBuV/m) for above 1GHz.
- 4) This test was performed with EUT in X, Y, Z position and the worse case was found when EUT in X position.
- 5) The other emission levels were very low against the limit.




