



First Use:

Please connect your devices (for ex. Mobile phone and charger)with the cable.

Take greatest care that you do not plug the adapters by force.

This product is equipped with an internal overload protection (electronic fuse)that throttles or terminates the power supply if too many consumers or consuming is too high, The product has various connection ports: USB-A, USB-C, as well as 2 in 1 lightning and Micro.

Security advice:

- Do not disassemble the item
- If the product gets very hot, pls disconnect the item and do not use it.
- Never throw the item or parts of into fire.
- Never expose the item to high temperature changes Hot/Cold or huimidity or liquids.
- Keep away from children, no toy! Risk of strangulation!

-Do not use if the items or parts of it are damaged or the item gets hot due to inner defect!

-Never connect your devices by force!

-Always make sure, that there are no particles in the ports.

-Always use maximum 1 adapter!

-Plug in the adapters softly and never with force to avoid damage at the device ports or adapter. Make sure, you move it in the correct direction.

Please check carefully, if there are any objects in the port, which avoid a correct using of the adapter. If you plug the cable by force/with too much pressure or in the wrong direction, the cable as well as the adapter could be damaged (valid for all kinds of cables).For damages caused by this, the manufacturer will not bear any responsibility.

Disposal: Dispose the item according to local regulations.
