Method 1:Remove from the charging compartment, theheadset automatically turns on.
Method 2: Long touch the MF button of the headphones for 3s to turn on the headphones.

2. Power off
Method 1:Put the headphones into the charging case directly andclose the case to turn off.
Method 2: Long touch the MF button of the headphones for 5s to turn off the headphones.

3.Pairing to the BT device
Step 1: Open the upper cover of the charging compartment to removethe headphones, binaural automatic pairing;
Step 2: open the BT list of smart devices, search " HY-Y06 " andConnect (single ear use is supported).
