3. TEST METHODOLOGY

3.1 EUT CONFIGURATION

6.2 EQUIPMENT

Radiated emissions are measured with one or more of the following types of linearly polarized antennas: tuned dipole, biconical, log periodic, bi-log, and/or ridged waveguide, horn. Spectrum analyzers with pre-selectors and quasi-peak detectors are used to perform radiated measurements.

Conducted emissions are measured with Line Impedance Stabilization Networks and EMI Test Receivers.

Calibrated wideband preamplifiers, coaxial cables, and coaxial attenuators are also used for making measurements.

All receiving equipment conforms to CISPR Publication 16-1, "Radio Interference Measuring Apparatus and Measurement Methods."

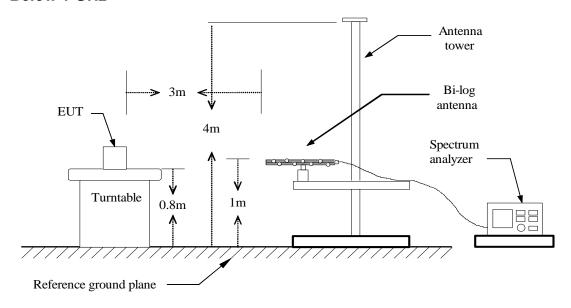

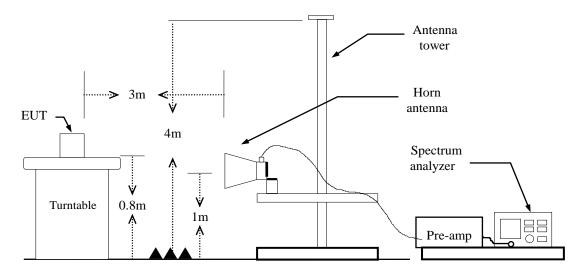

Above 1 GHz

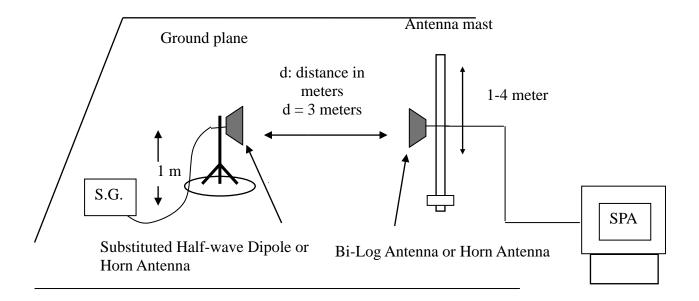

 - (1) Below 1G: 0.8m
 - (2) Above 1G: 0.8m
 - (3) EUT set 3m from the receiving antenna
 - (4) The table was rotated 360 degrees of the highest spurious emission to determine the position.
- 3. Set the spectrum analyzer, RBW=1MHz, VBW=3MHz.
- 4. A horn antenna was driven by a signal generator.
- 5. Tune the output power of signal generator to the same emission level with EUT maximum spurious emission
