Band2-20MHz-16QAM-18700-1RB#0-Range1:30~1000MHz

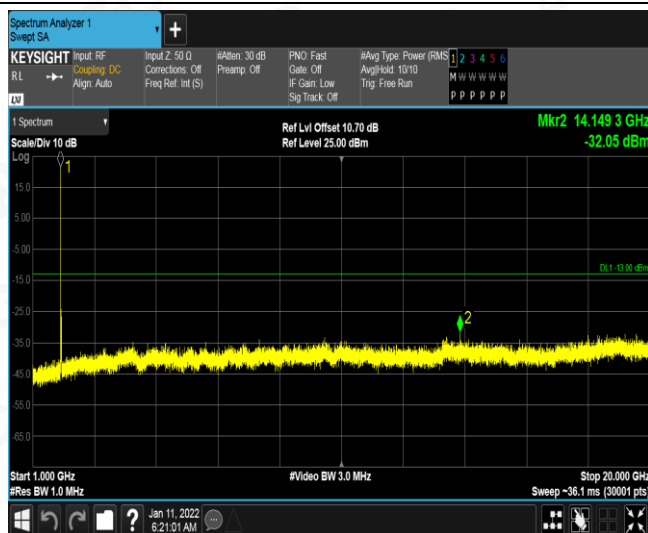

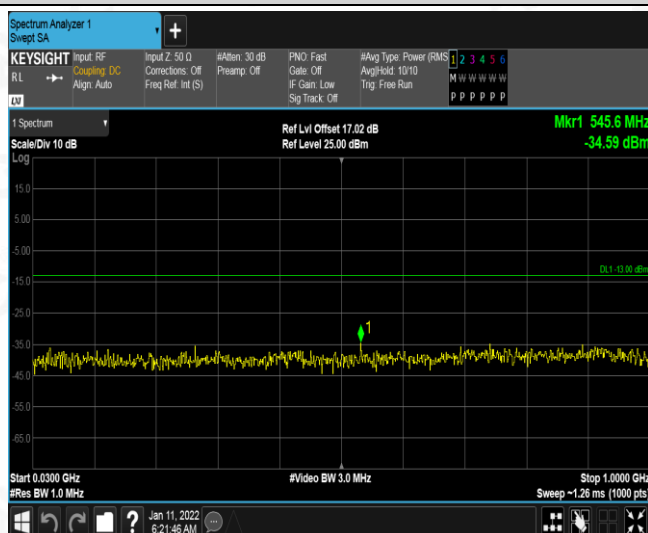

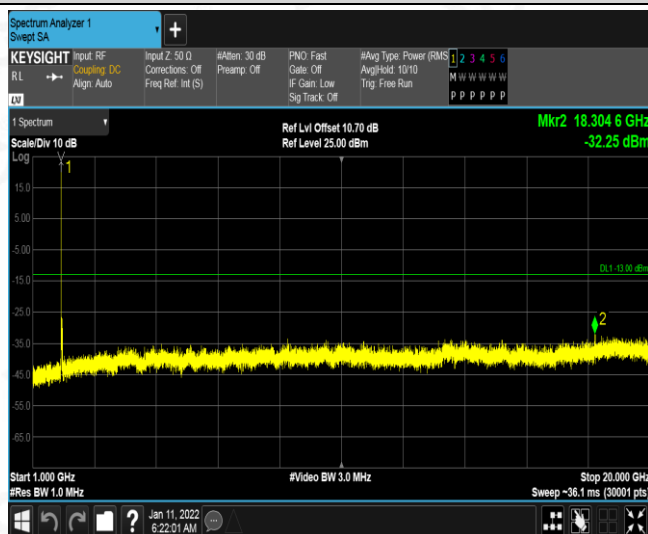




Band2-20MHz-16QAM-18900-1RB#0-Range1:30~1000MHz

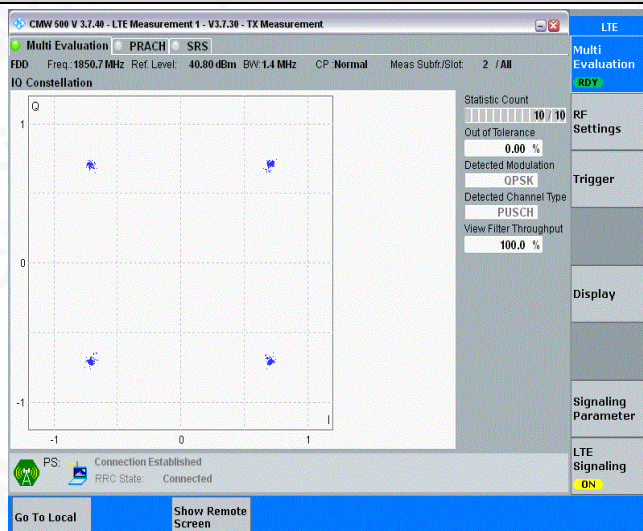

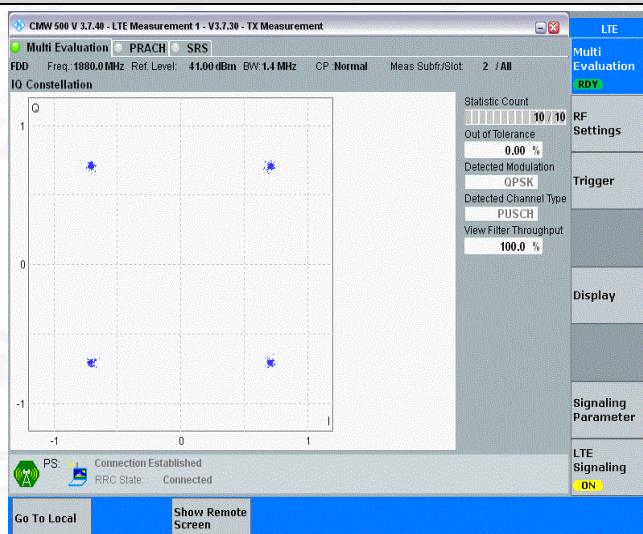
