

Pursuant to CFR§ 2.1043, Panasonic Corporation of North America hereby requests a Class II Permissive Change for its application with FCC ID: ACJFZS1A20A, which was originally granted by UL Verification Services Inc. on 11/18/2020.

This authorization only covers the Class II permissive change application for the following changes:

- Installation into Panasonic Personal Tablet Computer, Model FZ-S1 with FCC ID to be, FCC ID: ACJFZS1A.
- The antenna used with the module complies with the requirements of the original modular grant and the gain does not exceed the maximum allowed gain for each operating band.
- Output power setting was reduced from 23.8 dBm to 23dBm by firmware change in LTE B7 and B41 to be equipped into the host tablet.
- To support compliance this application for a C2PC includes a complete RF exposure report.
- This module used in the host tablet FZ-S1 has the power reduction mode which is specially programmed and tuned by proximity sensor to operate at a lower power setting than the original maximum power to ensure that the output power does not exceed the targets described in the SAR report.
- Collocation with the host tablet FZ-S1, whose SAR test data is included in this application.
- In accordance with FCC KDB 996369 D04 Module Integration Guide we have performed radiated spurious emissions tests to verify that the installation conditions have not impacted compliance with the applicable FCC rule parts and that test data is included with this application.
- The host tablet FZ-S1 doesn't support LTE band 30 and LTE uplink carrier aggregation which are disabled by Software at the factory.
- No other radio parameters have been changed.
- The maximum production power and tolerances are not impacted by this C2PC
