CONNECTING YOUR MOUSE

- Remove the Nano USB Receiver from the base of Mouse and plug into the USB port of your laptop, computer or tablet
- Turn on your PC and start your operating system
- Place your Wireless Optical Mouse within 3 feet of the receiver for optimal communication
- Move the mouse to ensure there is a good connection.

CAUTION: Prolonged use of this mouse may cause a repetitive strain injury. A preventative device, such as a wrist rest is recommended and the wrist should always be kept straight while using. Do not expose mouse to damp or moisture. Batteries Required: 2 x AAA (Not Included). To replace batteries, slide the cover off to open the battery compartment.
