Radiated Emission





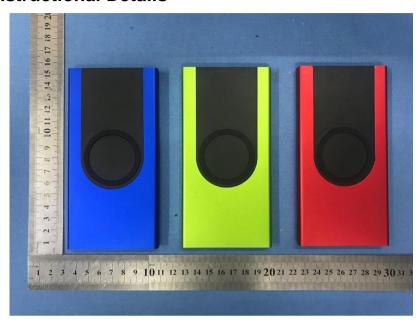
