## 2. RF Exposure evaluation for FCC

### 2.1. Assessment procedure

According to 447498 D01 General RF Exposure Guidance v06

The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz at test separation distances  $\leq 50$  mm are determined by:

$[(\text{max. power of channel, including tune-up tolerance, mW})/(\text{min. test separation distance, mm})] \cdot [\sqrt{f(\text{GHz})}] \leq 3.0$  for 1-g SAR and  $\leq 7.5$  for 10-g extremity SAR, where:

$f(\text{GHz})$  is the RF channel transmit frequency in GHz

Power and distance are rounded to the nearest mW and mm before calculation

The result is rounded to one decimal place for comparison

#### Estimtion Result:

Worse case is as below: [2478 MHz, 2 dBm, (1.58 mW) output power]

$(1.58/5) \cdot [\sqrt{2.478(\text{GHz})}] = 0.499 < 3.0$  for 1-g SAR

Then SAR evaluation is not required.
