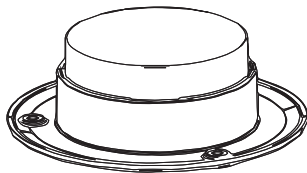

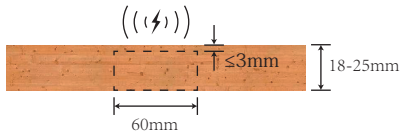
Product specifications:

- 1 Input parameters : 9V 2A
- 2 Output Power : 10W (MAX)
- 3 Rated transmission distance: 3mm (MAX)

Installation Notes:

- 1 The furniture manufacturer pre-made the mounting holes at the bottom of the table, requesting the mounting hole size is $\phi 60\text{mm}$, and the upper plate thickness is no more than 3mm.
- 2 Use a ruler to measure the position of the mounting hole from the edge of the board and on the desktop.
- 3 Mark the position and attach the positioning sticker to the position. Put the product into the mounting hole and install the wireless charger. Screw holes adjusted to a reasonable position.
- 4 Use the screws provided with this product to secure the product to the bottom of the table.

Instructions:

- 1 Connect the power adapter to the mains socket and turn on the power.
- 2 Connect the power adapter to the product power input terminal
- 3 Place the phone on the positioning sticker on the desktop to ensure that the center of the phone and the center of the positioning sticker basically coincide
- 4 The phone can enter the wireless charging state

Precautions:

- 1 Please use a power adapter that meets the requirements of this product.(DC 9V/2A)
- 2 Do not use a phone case with a thickness greater than 3mm.
- 3 Do not use metal phone case
- 4 Do not use this product in a humid environment
- 5 Please use this product indoors
