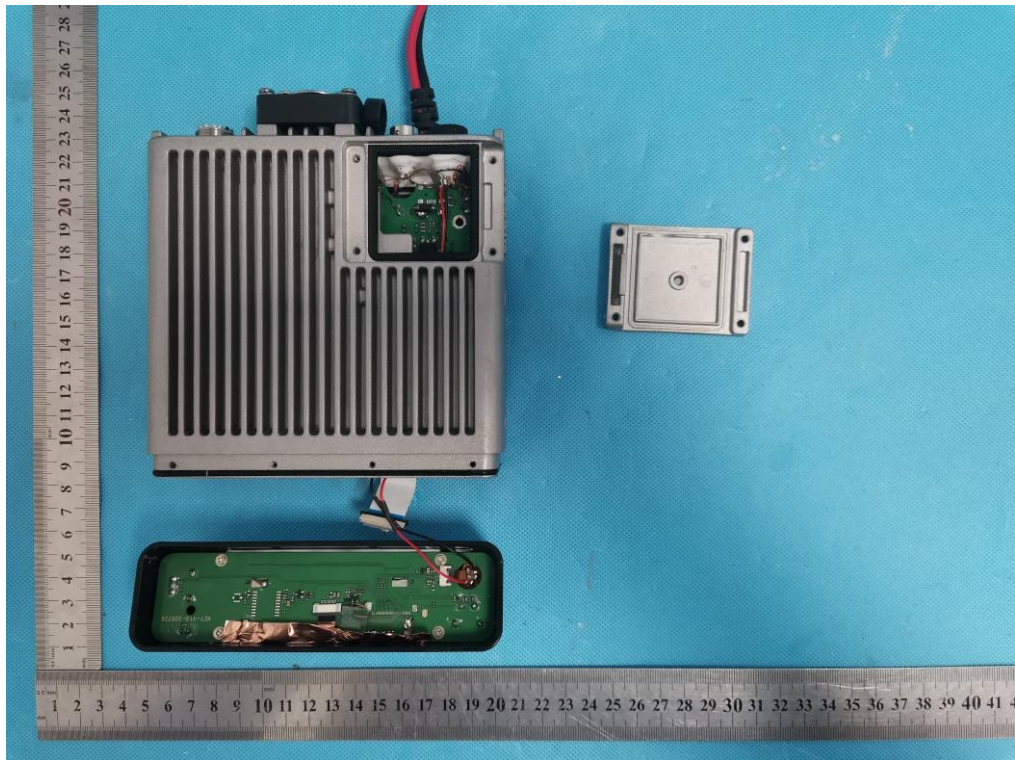
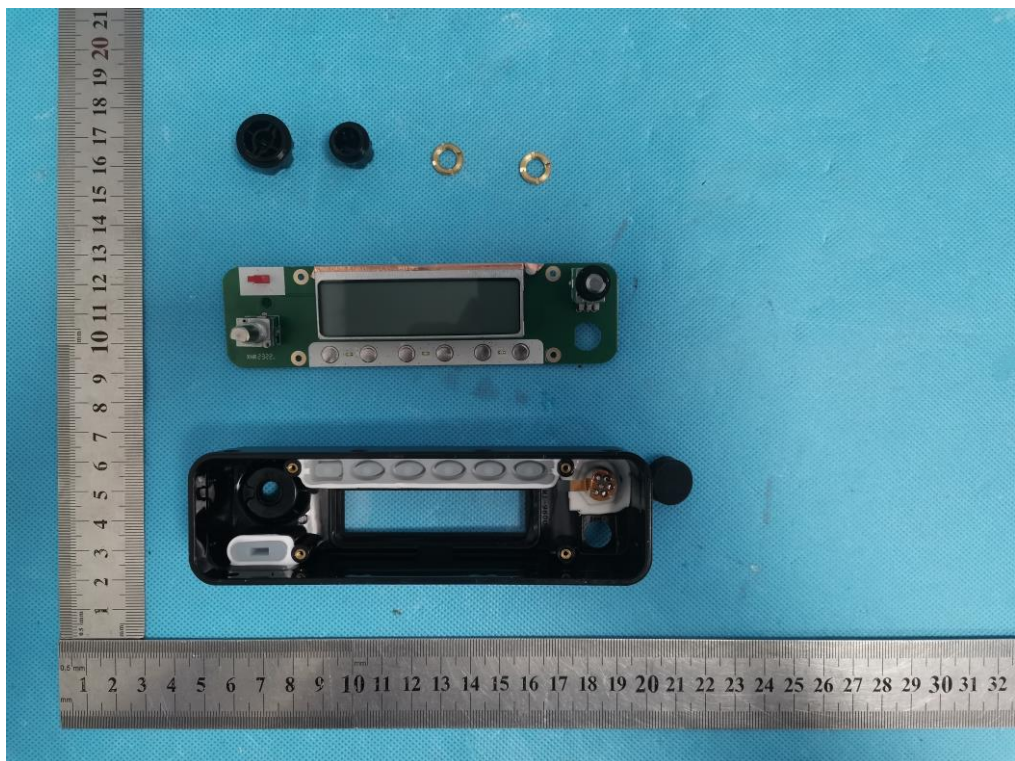

OPEN VIEW OF EUT(FIGURE 1)

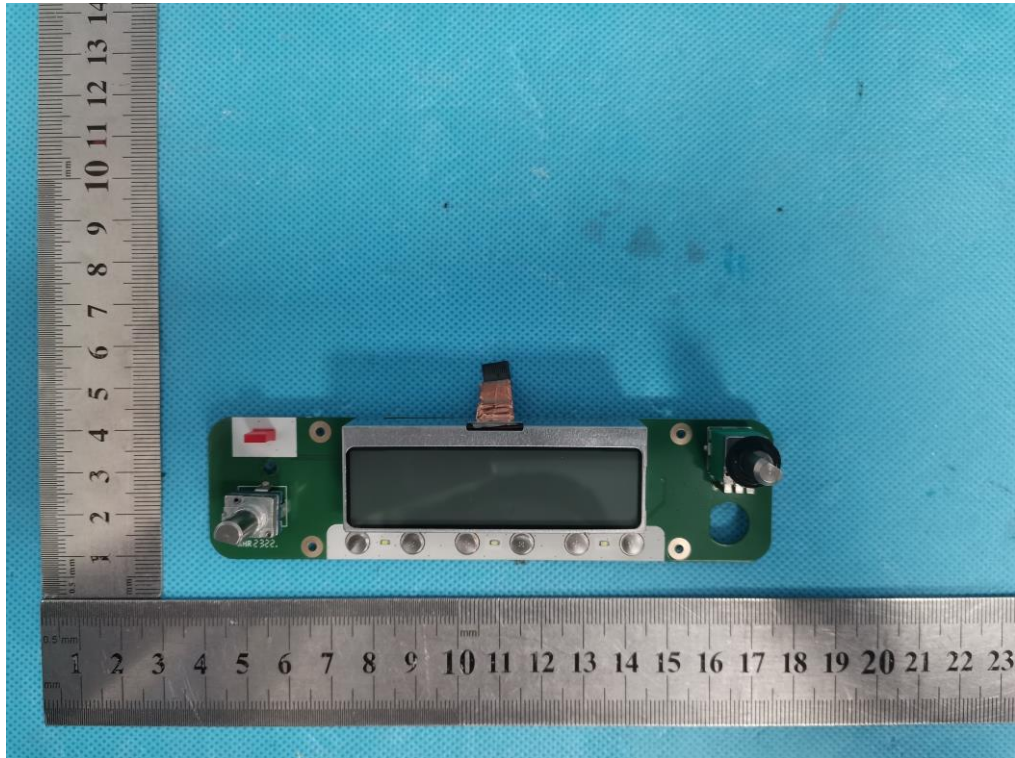


OPEN VIEW OF EUT(FIGURE 2)

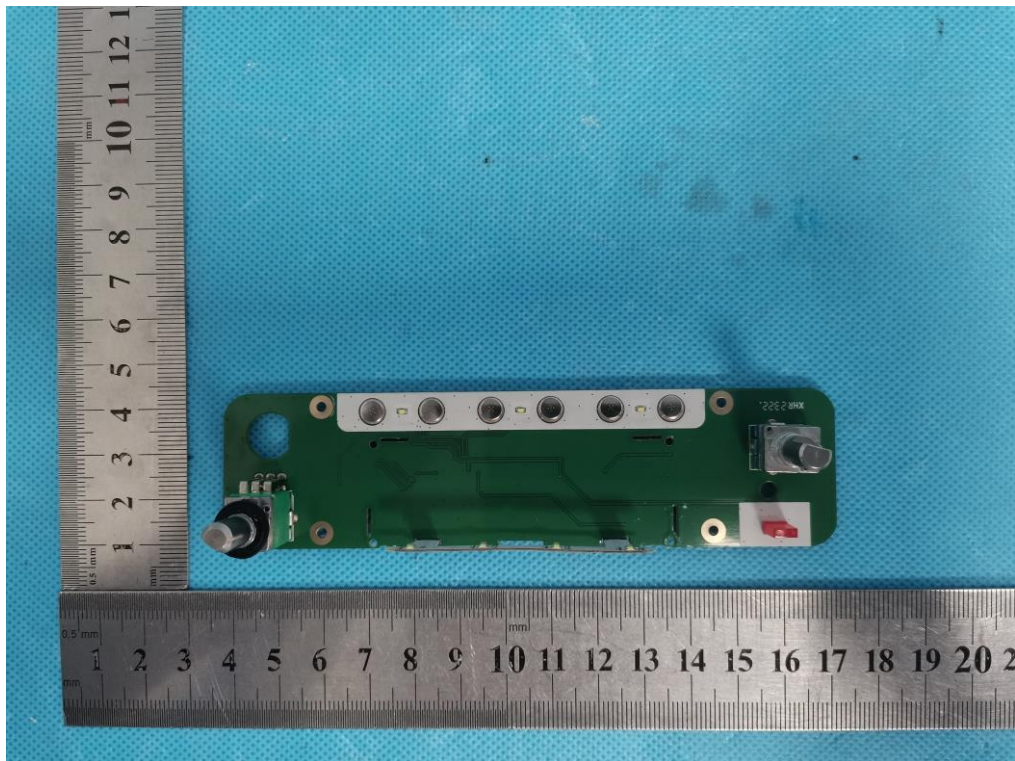

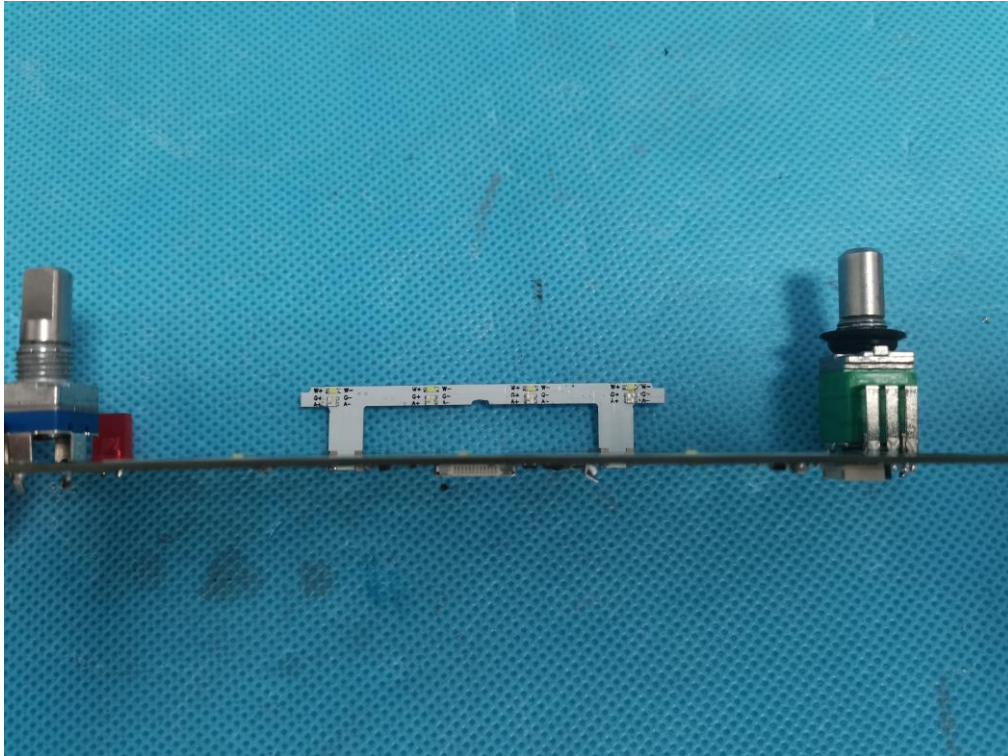

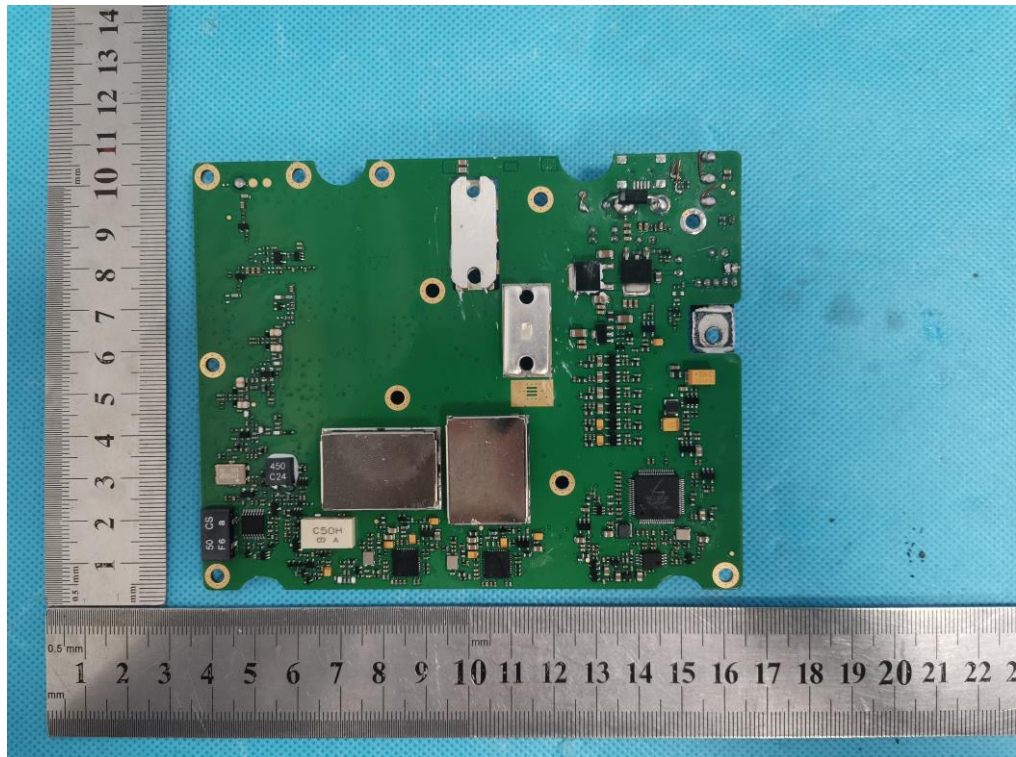

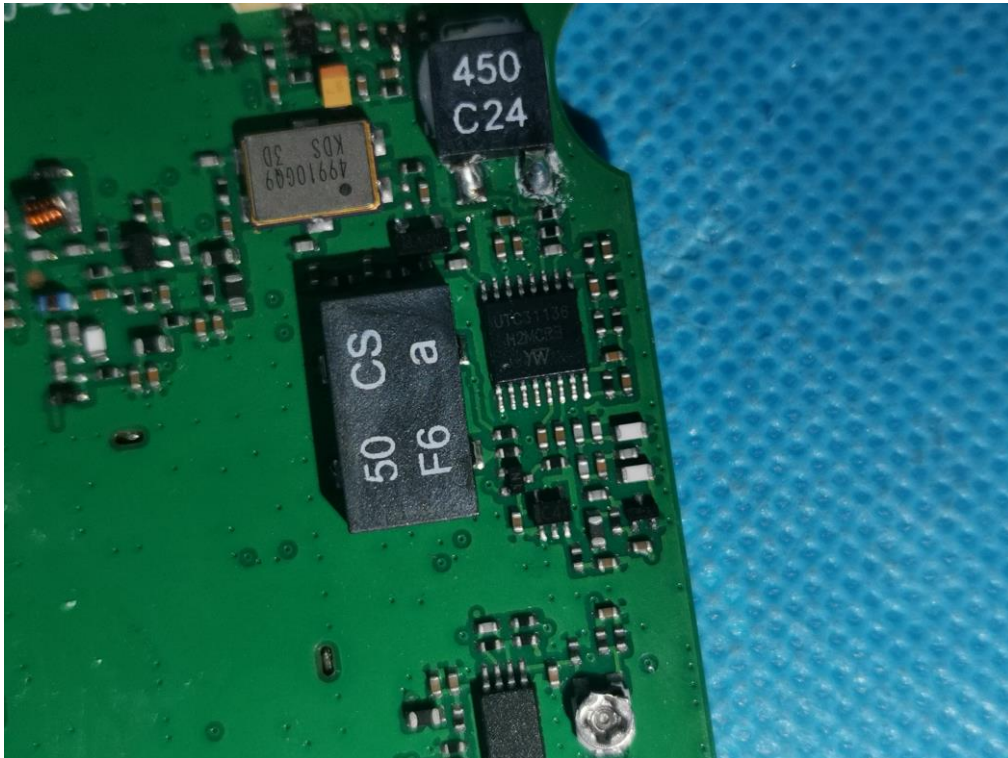

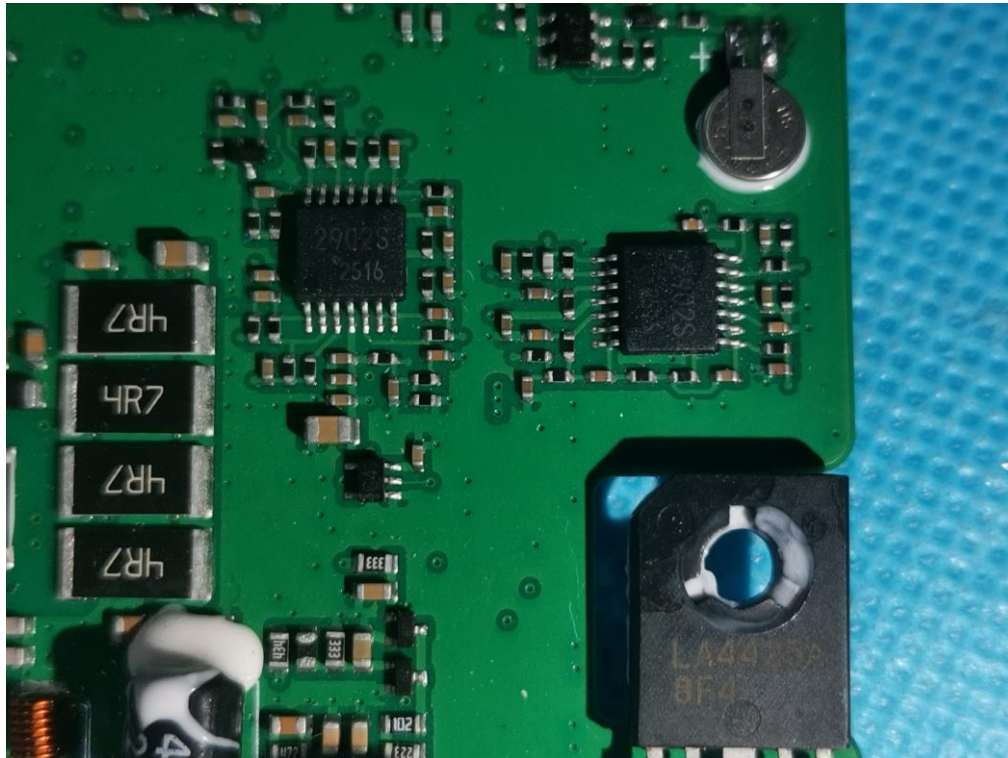

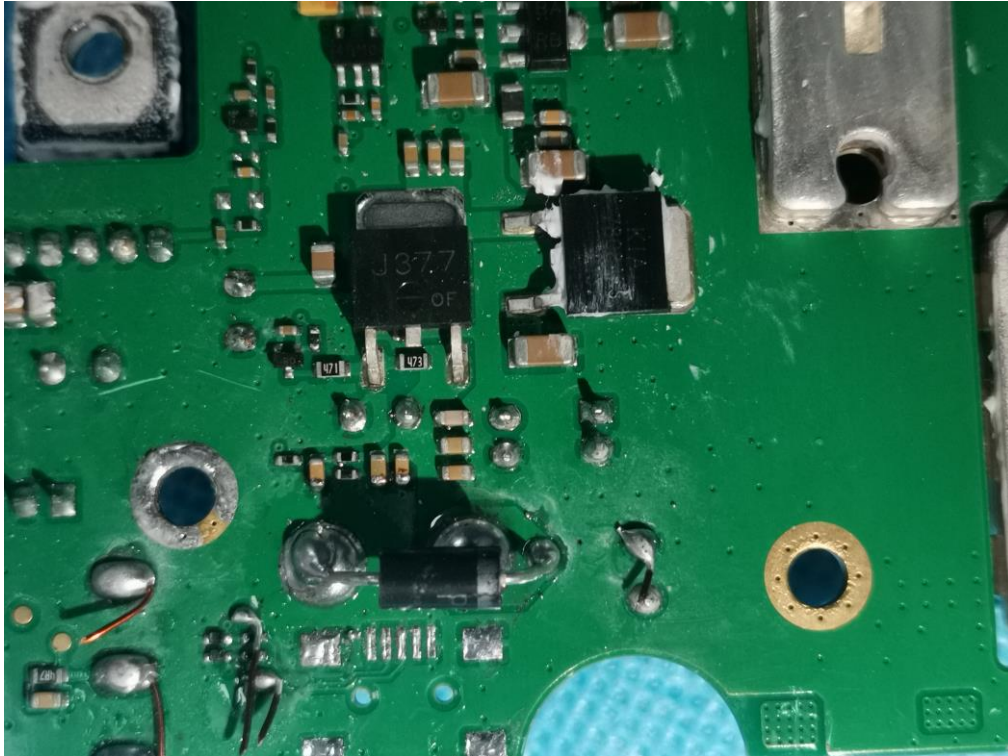

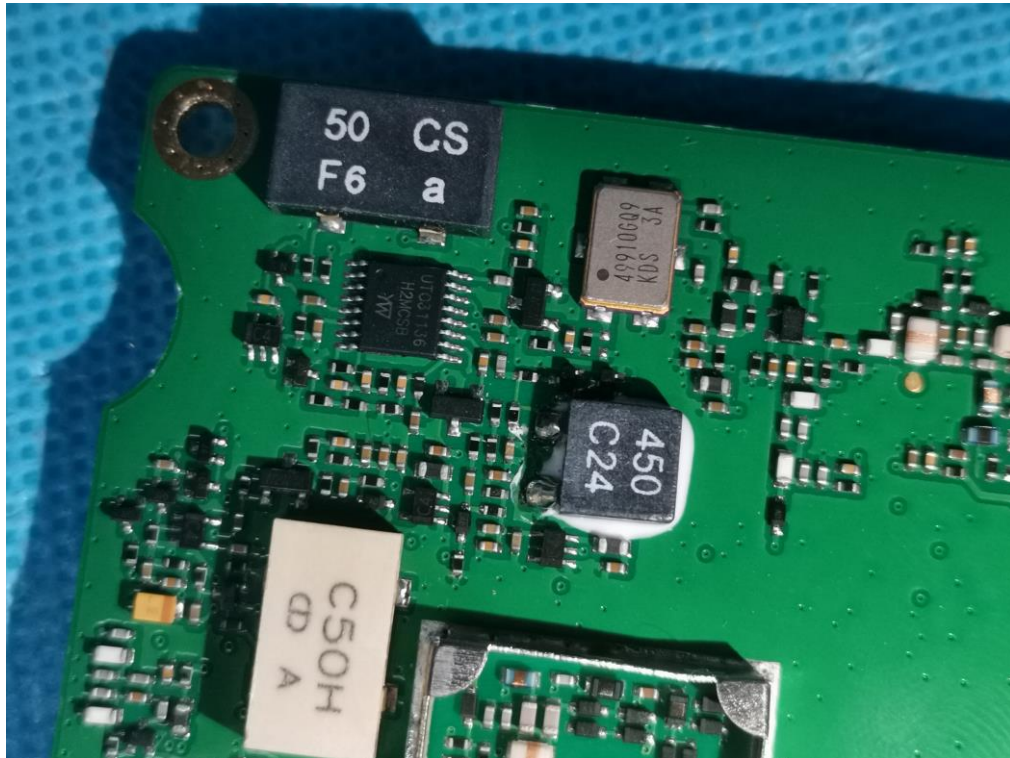

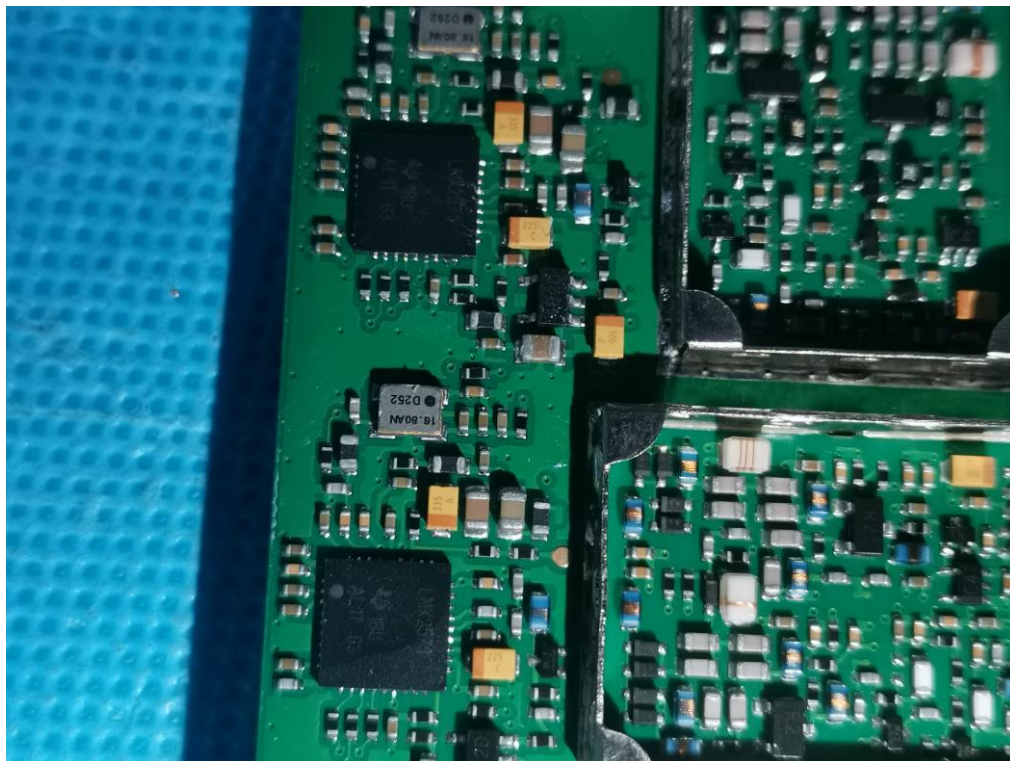

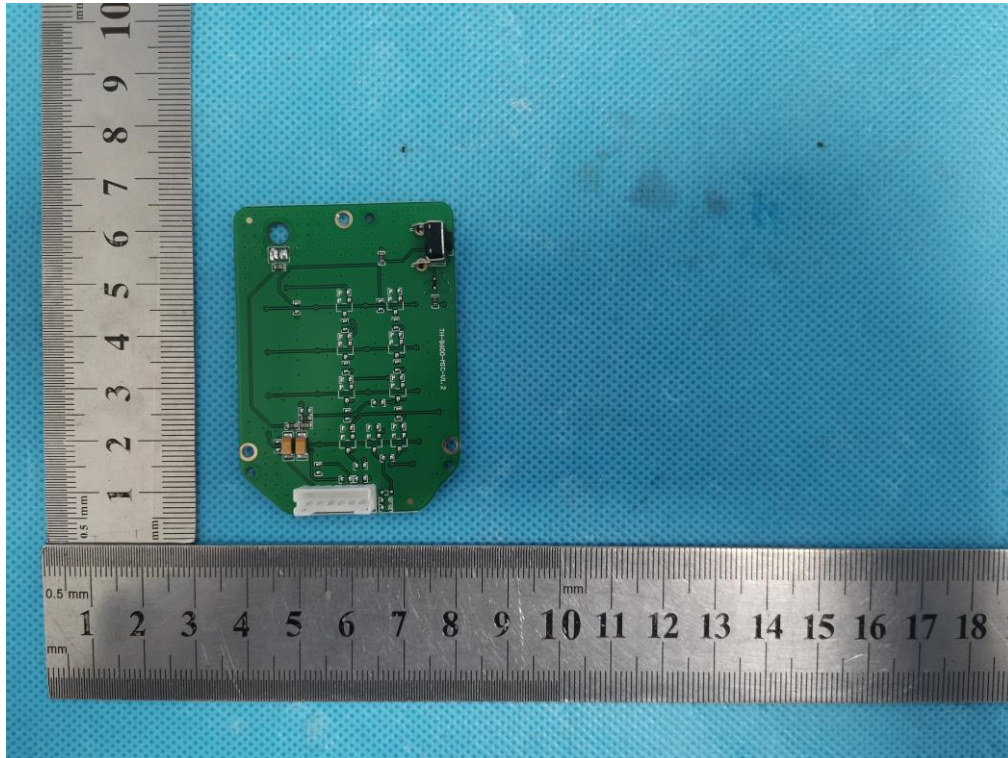
