

HOW TO USE

SOUND MACHINE

Long press the power button " (), "two seconds to turn on the device, it will start playing the first default sound automatically. The ")" Led light has no display; there are 6 optional sounds including sea waves, crackling fire, white noise, lullaby, rain & thunder, and stream.

Press once " \bigcirc " or " \bigcirc " to choose the best sound you like, or long press " \bigcirc " or " \bigcirc " to turn volume down or up. Short press the button " \bigcirc "" to pause the sound machine.

Timer Function:

Short press the timer indicator button " () once for 15 MIN countdown. Short press the timer indicator button " " twice for 30 MIN countdown. Short press the timer indicator button " " three times for 60 MIN countdown.

BLUETOOTH SPEAKER

Short press once the mode button " (\mathbb{M}) " once to switch to Bluetooth mode. Follow the operating instruction of your wireless connection enabled device. Select "Serene Sound" from list. Once you hear the voice prompt "Connected" your device has successfully connected to the sound machine

Short press the button "(⁴/₁)" to pause.

Press the "(-)" or "(-)" to change the tracks, or long press "(-)" or "(+)" to turn the volume down or up.

The blue led indicator will flicker fast while waiting to pair.

- The blue led indicator will be constant when paired.
- The blue led indicator will flicker slowly while playing.

WIRELESS CHARGER

Put the smart phone on the wireless charging area, the phone will start charging automatically, the white led indicator " $\begin{bmatrix} 2 \\ 2 \end{bmatrix}$ will start to blink slowly once the wireless charging begins.

BUILT-IN BATTERY

Please charge this device using the Type-C charging cable provided. It will take approximately 1-2 hours to fully charge. Fully charge before first use.

LOW battery: if the power voltage is lower than 3.2V, the device will alarm every 2 minutes, "Low battery, please charge" total of three times and then power off automatically to protect the battery. Please charge the unit using the Type-C charging cable provided.

The red "[]" charging indicator will be constant while charging, and then turns off once it is fully charged.
