





The TWS will turn on automatically once it is removed from charging case. It will blink alternately red and blue indicates that it is in pairing mode. 2. Power OFF: Long press the Multifunction button for 3 seconds to turn off (both sides of earbuds will turn off simultaneously if they are still paired). 3. Pairing: When the TWS On, both sides of the earbuds will automatically self pair. Once paired, one side of the earbuds will flash blue and not alternately to seek for Bluetooth device. 4. Connect: Once the TWS is successfully connected to your Bluetooth device, the voice will tell you prompt. 5.
