#### **Product Description for Equipment under Test (EUT)**

The Sky Phone LLC's product, model number: SKY 4.0LM (FCC ID: 2ABOSGCSKY40LM) or the "EUT" in this report was a 3G/4G Smart Phone, which was measured approximately: 126 mm (L)  $\times$  65 mm (W)  $\times$  11 mm (H), rated with input voltage: DC 3.7V rechargeable Li-ion battery or DC 5V from adapter. The highest operating frequency is 2690 MHz.

#### **Objective**

This test report is prepared on behalf of *Sky Phone LLC* in accordance with Part 2-Subpart J, Part 15-Subparts A and B of the Federal Communication Commissions rules.

The objective of the manufacturer is to determine the compliance of the EUT with FCC Part 15 B.

#### Related Submittal(s)/Grant(s)

#### **Test Methodology**

All measurements contained in this report were conducted with ANSI C63.4-2014, American National Standard for Methods of Measurement of Radio-Noise Emissions from Low-Voltage Electrical and Electronic Equipment in the range of 9 kHz to 40 GHz.

All emissions measurement was performed at Bay Area Compliance Laboratories Corp. (Shenzhen). The radiated testing was performed at an antenna-to-EUT distance of 3 meters.

Measurement uncertainty with radiated emission is 5.81 dB for 30MHz-1GHz, and 4.88 dB for above 1GHz, 1.95dB for conducted measurement.









The radiated emission tests were performed in the 3 meters chamber test site, using the setup accordance with the ANSI C63.4-2014. The specification used was the FCC Part 15.109 Class B limits.

The external I/O cables were draped along the test table and formed a bundle 30 to 40 cm long in the middle.

The spacing between the peripherals was 10 cm.
