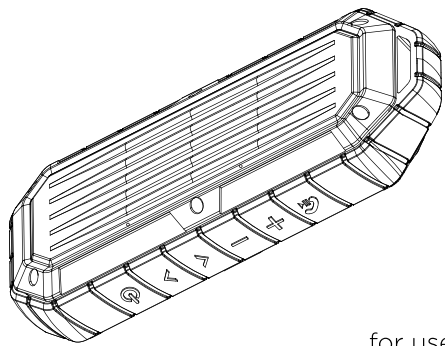

•PAIRING YOUR PRODUCT

1. Place speaker within 30ft of the Bluetooth®-enabled device.
2. Press the ON/OFF button to ON. The blue LED flashes quickly to indicate Bluetooth® pairing mode.
3. Follow the instructions of your device to search for the speaker.
4. The speaker is called "IJOY BEACH BOMB 2.0". If a PIN is required, enter "0000." Select this to pair your device.
5. The blue LED will stay on when pairing is complete.

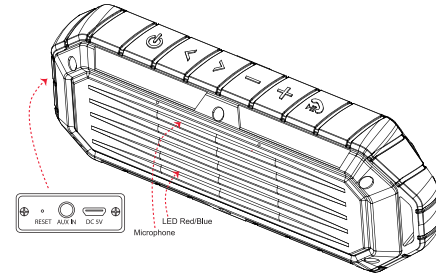
•BATTERY CAUTION

•INSTRUCTIONS

1. To turn the speakers on, press the ON/OFF button and hold for 2-3 seconds.
2. The speaker beeps and a blue LED flashes quickly.
3. The blue LED flash slowly when playing music.
4. To turn the speakers off, press the ON/OFF button and hold for 2-3 seconds.
