




Installation

- 1. 2.4G wireless router is required;
- 2. Support Android 4.44 and above, iOS 9.0 and above;
- 3.Download APP: Please select one of below two methods to download the APP, then complete the installation and account registration,

- 2. Please make sure the camera and smart phone are connecting to the same 2.4GHz band WiFi.



Camera Indicator Instruction

	Red light twinkles slowly	Which means its successfully turned up.
	Red light twinkles fast	Which means its configuring the network.
	Green light flashes.	Which means WiFi or the Internet is linked, in summary, the router is linked.
	Green light is often on.	This indicates that the platform is connected to view remote videos.
