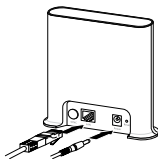




Set up your Arlo Ultra Wire-Free camera

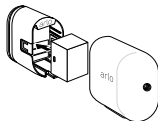
1. Connect the power adapter and the Ethernet cable to your Arlo SmartHub.

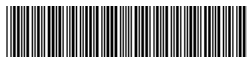

Federal Communication Commission Interference Statement
