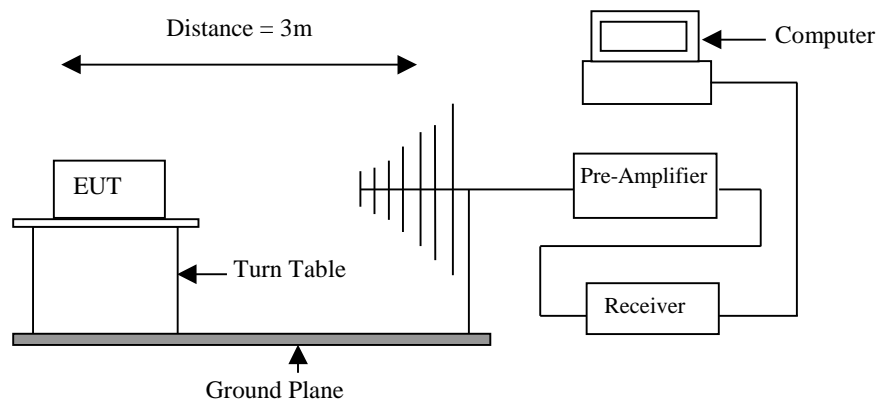

Test Method:

The sample was placed 0.8m above the ground plane on the OATS *. Measurements in both horizontal and vertical polarities were performed. During the test, each emission was maximized by: having the EUT continuously working, investigated all operating modes, rotated about all 3 axis (X, Y & Z) and considered typical configuration to obtain worst position, manipulating interconnecting cables, rotating turntable, varying antenna height from 1m to 4m in both horizontal and vertical polarizations. The emissions worst-case are shown in Test Results of the following pages.

Where F is the frequency in MHz, the formulas for calculating the maximum permitted fundamental field strengths are as follows: for the band 130-174 MHz, $\mu\text{V}/\text{m}$ at 3 meters = $56.81818(F) - 6136.3636$; for the band 260-470 MHz, $\mu\text{V}/\text{m}$ at 3 meters = $41.6667(F) - 7083.3333$. 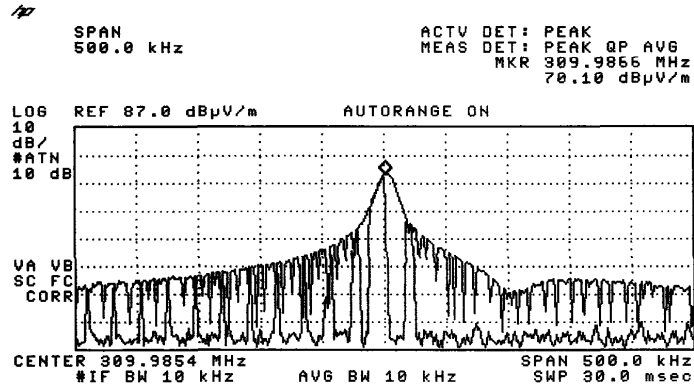

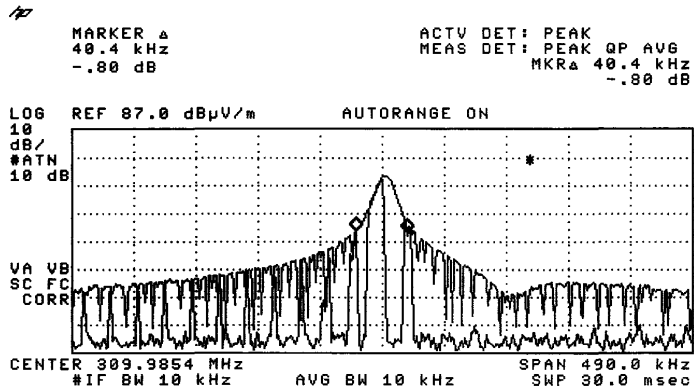

Appendix B

Duty Cycle Correction During 100msec

Each function key sends a different series of characters, but each packet period (31.5msec) never exceeds a series of 5 long (375µsec) and 8 short (300µsec) pulses. Assuming any combination of short and long pulses may be obtained due to encoding the worst case transmit duty cycle would be considered $5 \times 675 \mu\text{sec}$ per 31.5msec = 18.3% duty cycle. Figure A through C show the characteristics of the pulses train for one of these functions.

Remarks:

Duty Cycle Correction = $20\text{Log}(0.183) = -14.7\text{dB}$

Figure A [Pulse Train]

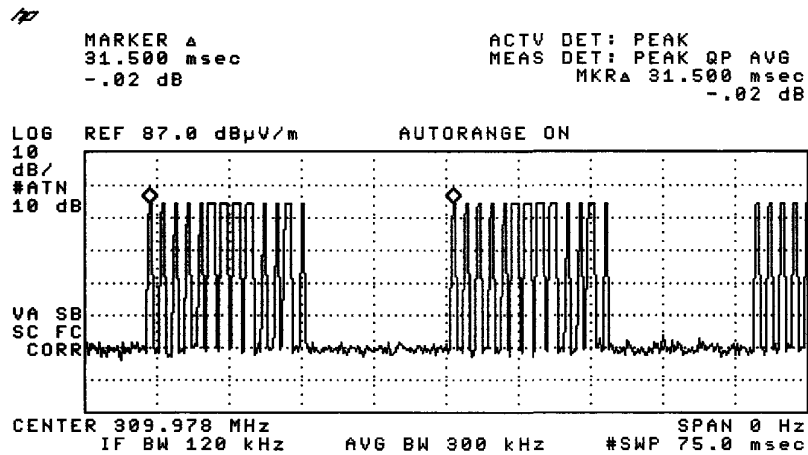


Figure B [Long Pulse]

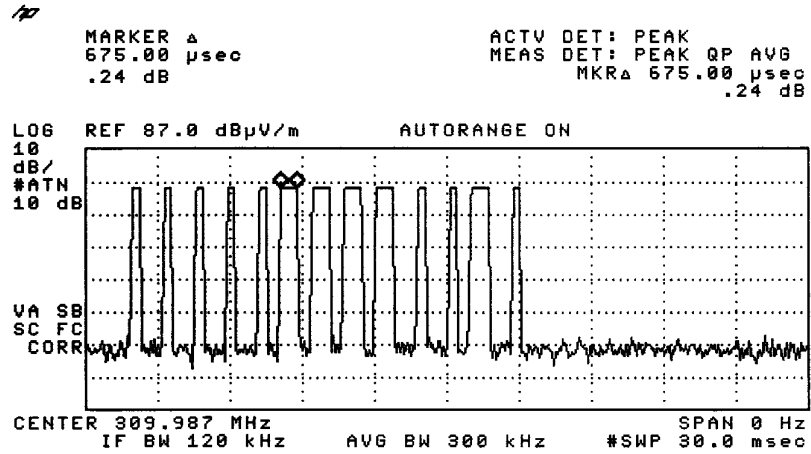
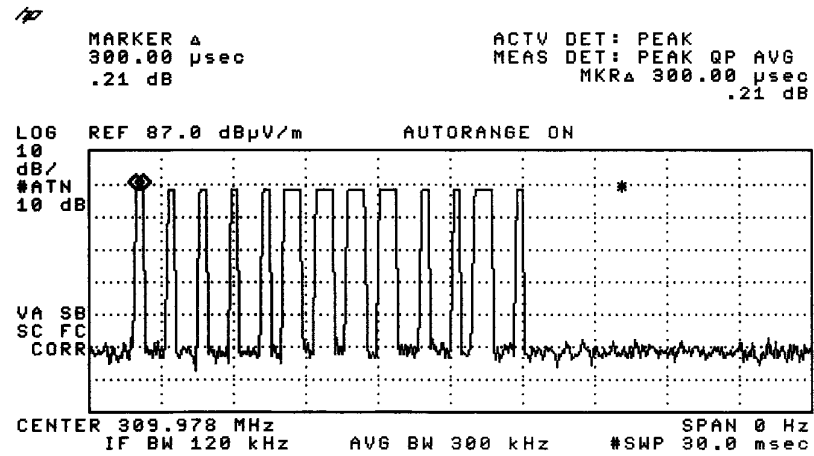


Figure C [Short Pulse]

The EUT continues to transmit while each button is being pressed. The EUT ceases transmission almost immediately upon being released and appears to finish the current packet being transmitted.

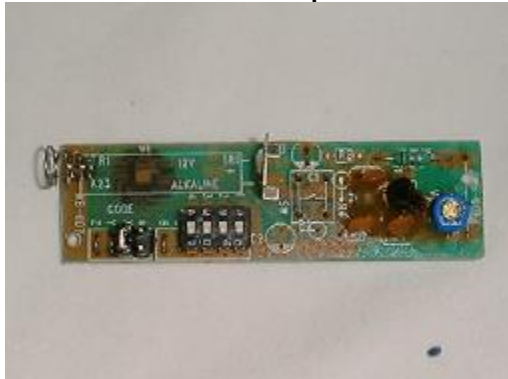
Front View of the product



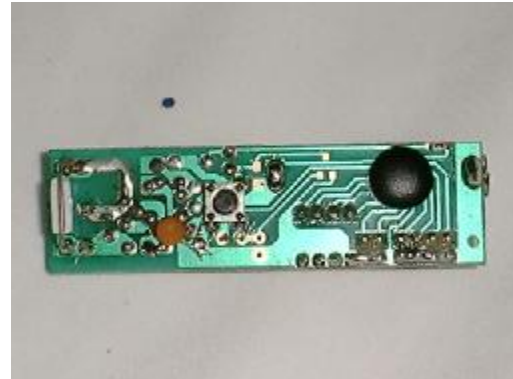
Rear View of the product
