### **GENERAL INFORMATION**

### **Product Description for Equipment under Test (EUT)**

The *Autel Intelligent Tech.Co.*, *Ltd's* product, model number: *X-MEMO (FCC ID: WQ8301SDCHD1)* or the "EUT" in this report was a *Wireless Camera*, which was measured approximately: 63 mm (L)  $\times$  30 mm (W)  $\times$  37 mm (H), rated with input voltage: DC 3.8V rechargeable Li-ion battery. 



Correction Factor = LISN VDF + Cable Loss + Transient Limiter Attenuation







Maximizing procedure was performed on the highest emissions to ensure that the EUT complied with all installation combinations.

All data was recorded in the Quasi-peak detector mode from 30 MHz to 1 GHz and PK and average detector modes for frequencies above 1 GHz.
