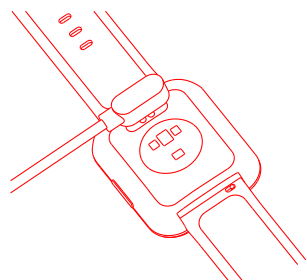

Wyze Watch 47

ACTIVATION

1 Please plug the charger into a standard USB port (5W, 1A) and attach the Wyze Watch 47 with the charging clip.

2 Wyze Watch 47 comes fully charged. Charging it will activate the Watch. Your Wyze Watch 47 screen will light up when it is ready for setup.



SETUP

1 Download the Wyze app by scanning the QR code below.

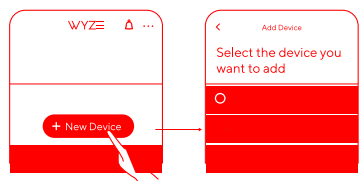


Or download directly from the Apple App Store or Google Play.



2 Sign up or login to your Wyze account. Please make sure that the Bluetooth is turned on for the Wyze app.

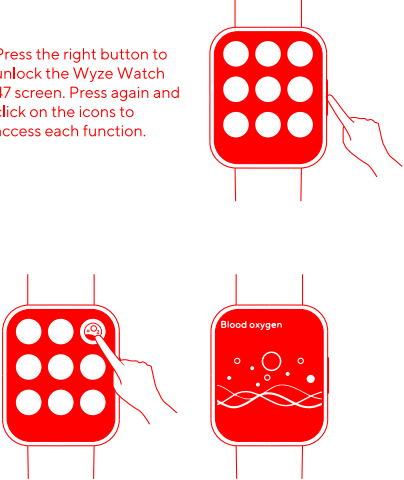


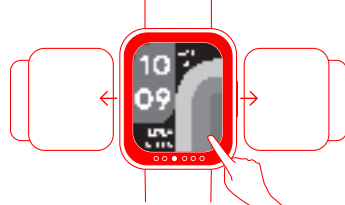
Wait for "Success" to appear on your Wyze Watch 47. When it displays a clock, the setup process is complete. Enjoy your Wyze Watch.

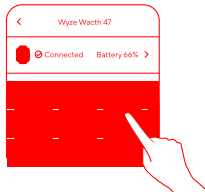
CONTROLS

If you want to change the watch face, press and hold the screen and swipe left and right to select different styles.



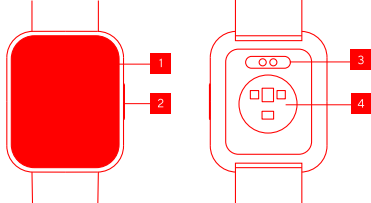
You may also go to the Wyze app to see more designs and sync them with your Wyze Watch 47.
