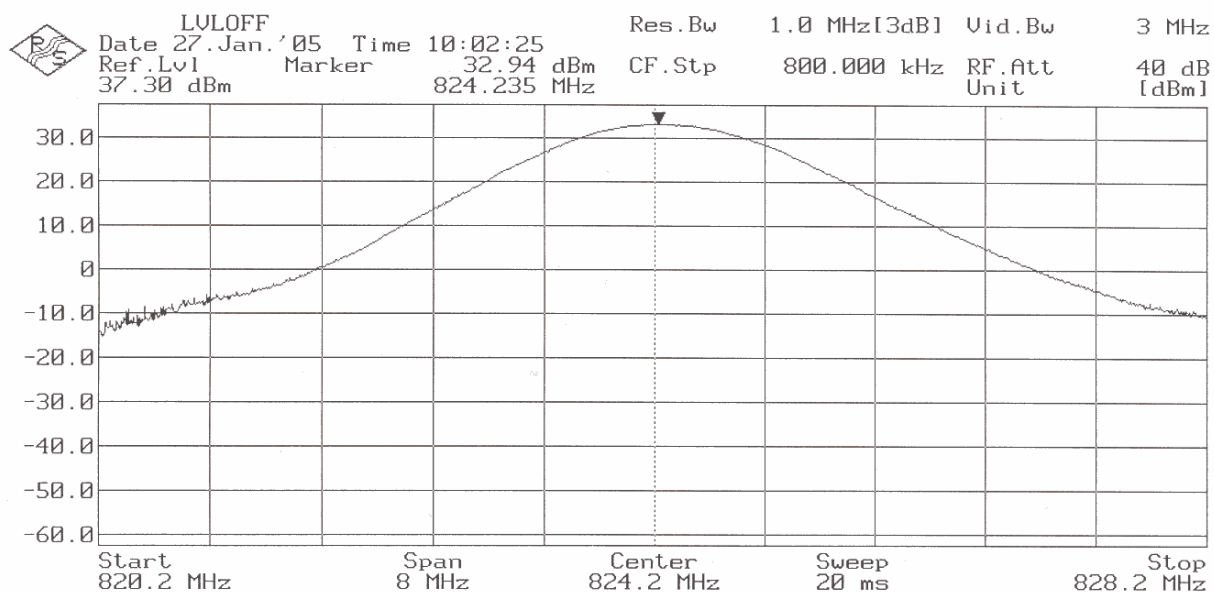

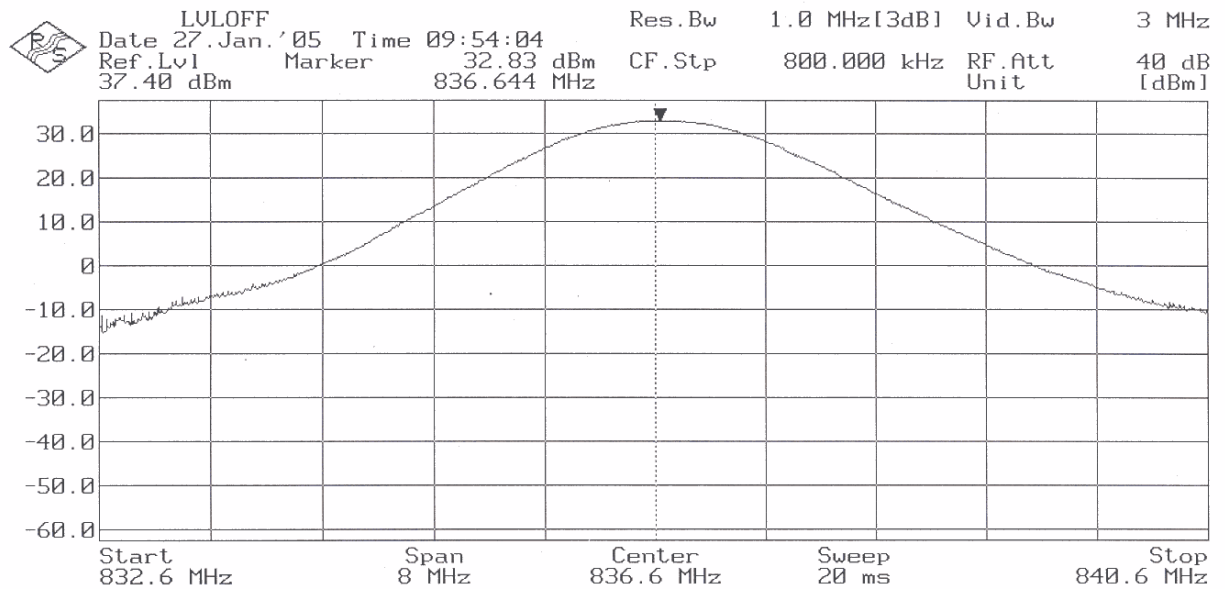

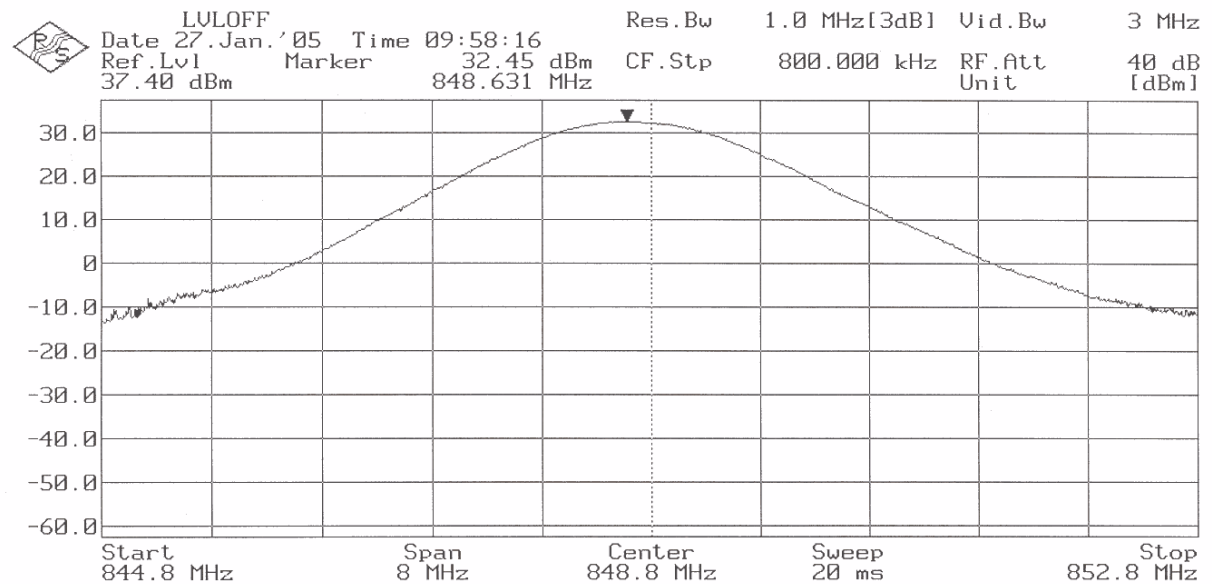

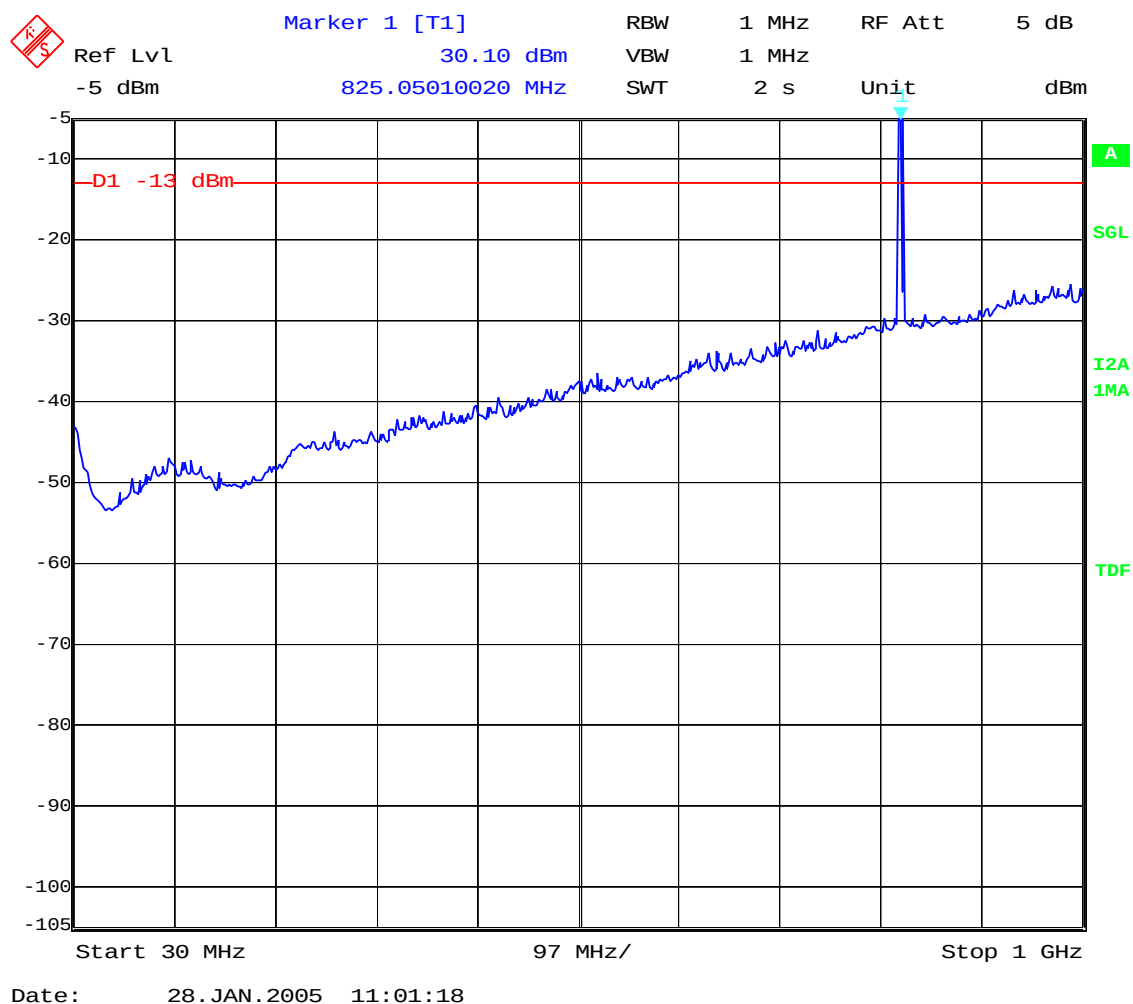

FREQUENCY RANGE 30 MHz-1000 MHz.

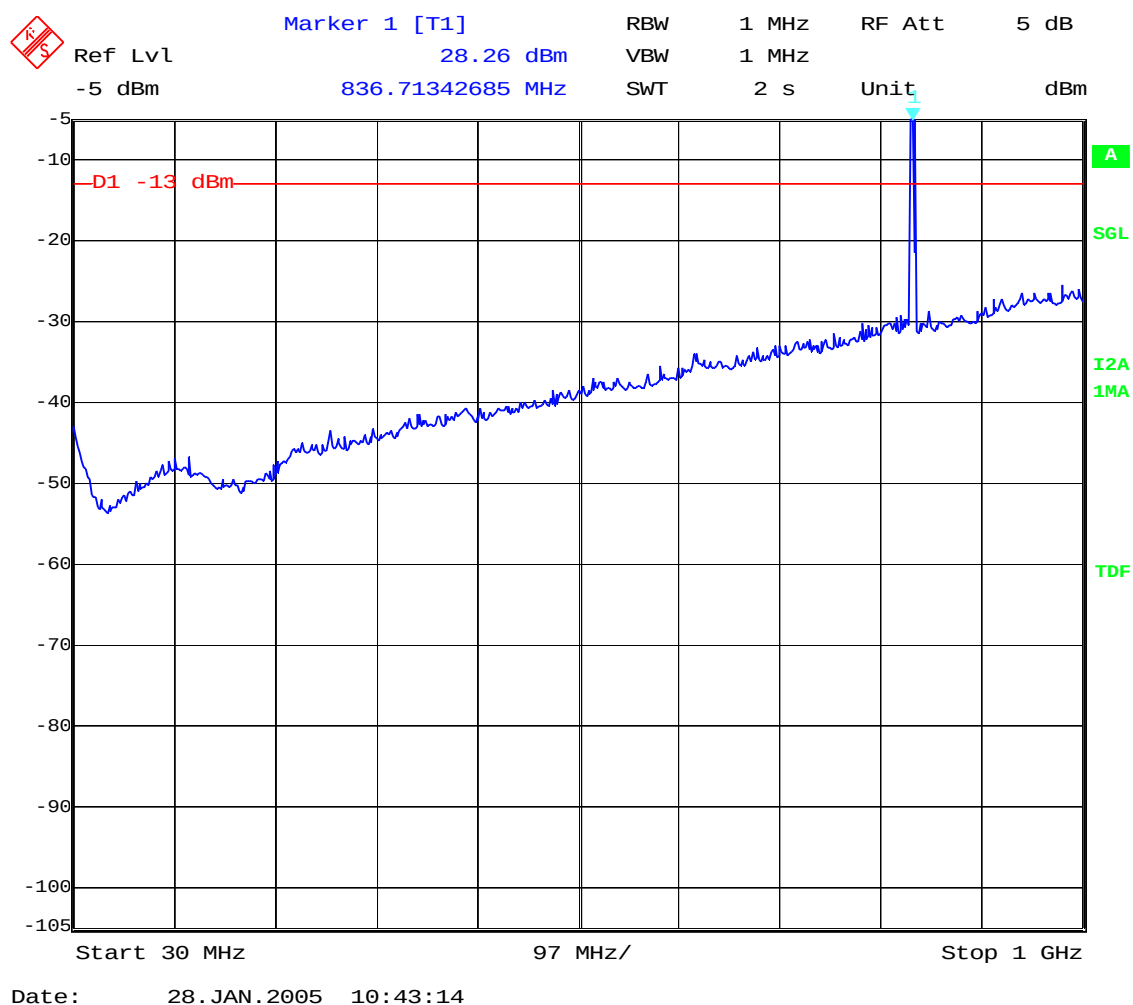
CHANNEL: LOWEST (824.2 MHz)

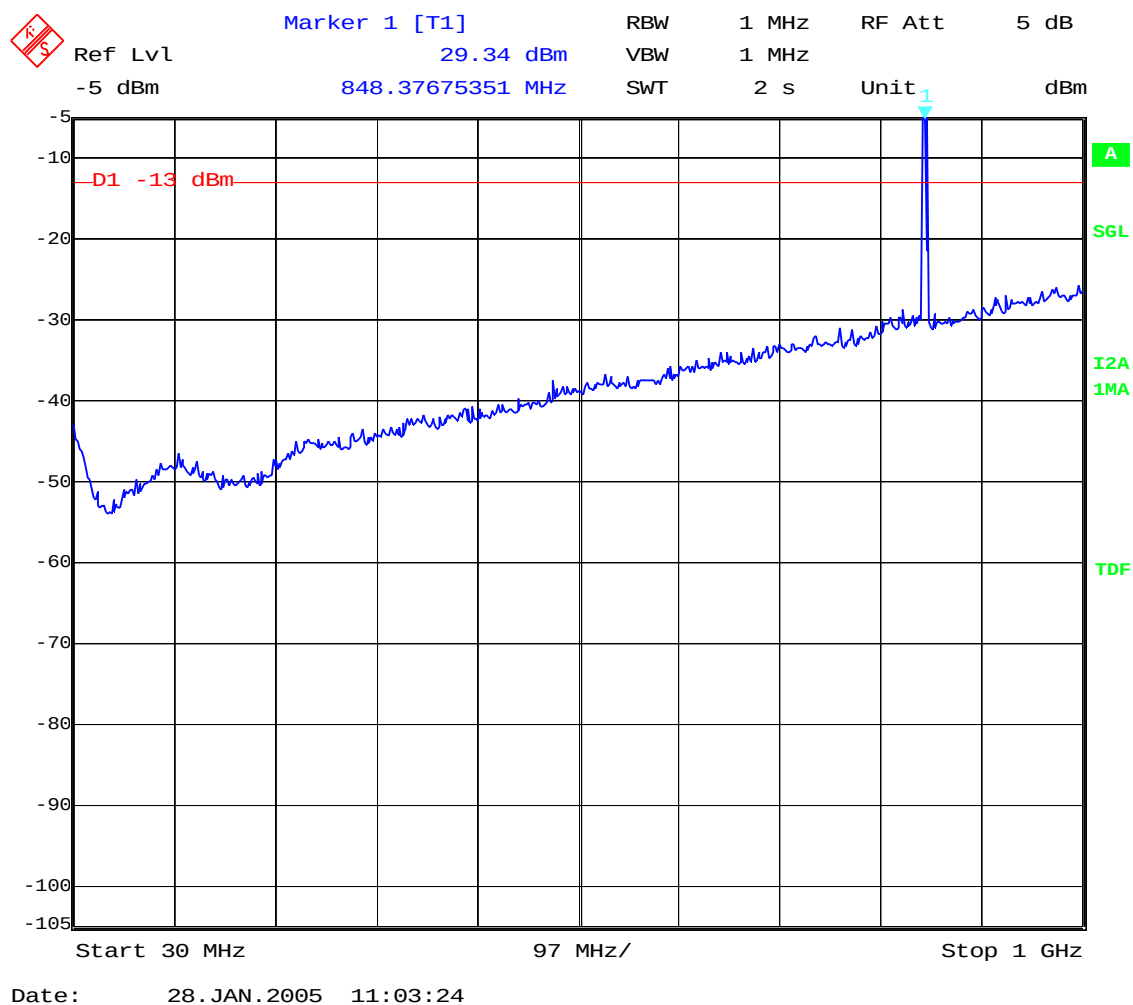
CHANNEL: MIDDLE (836.6 MHz)

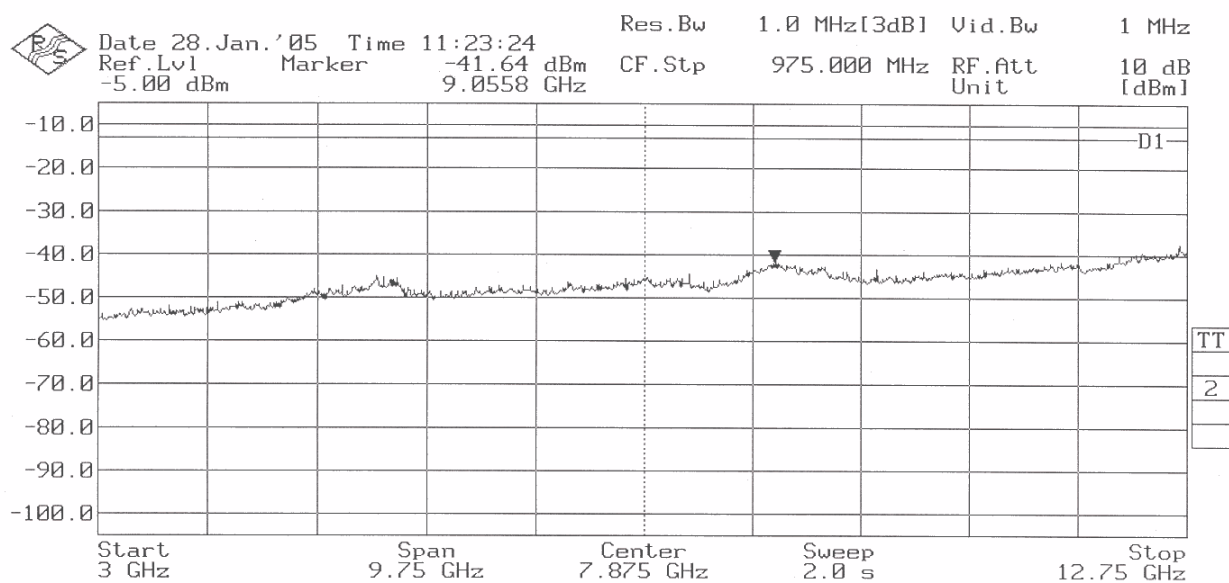
CHANNEL: HIGHEST (848.8 MHz)

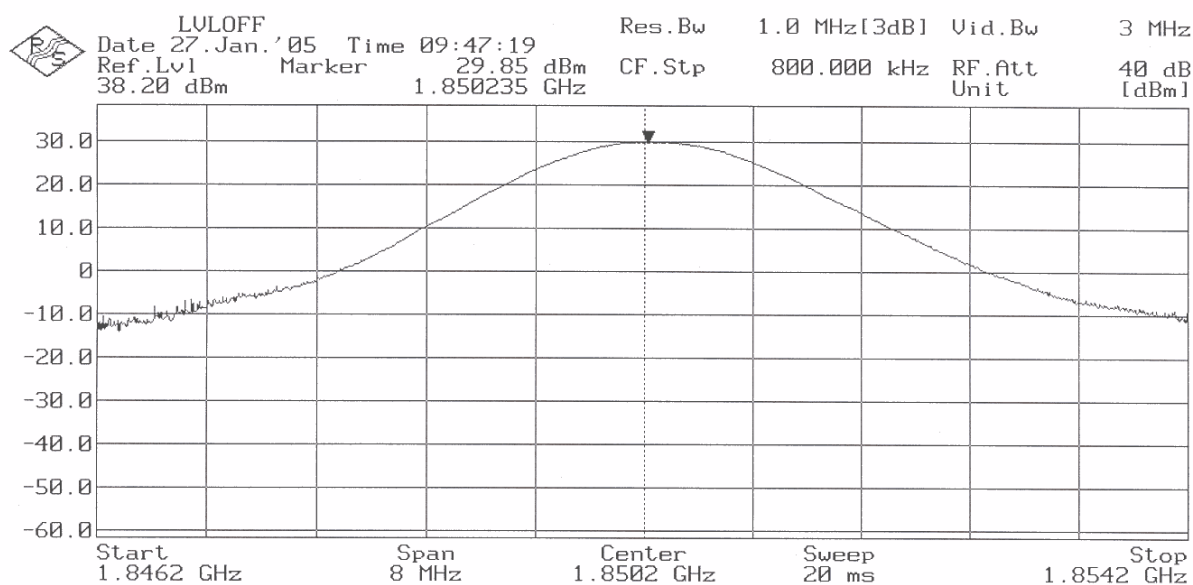

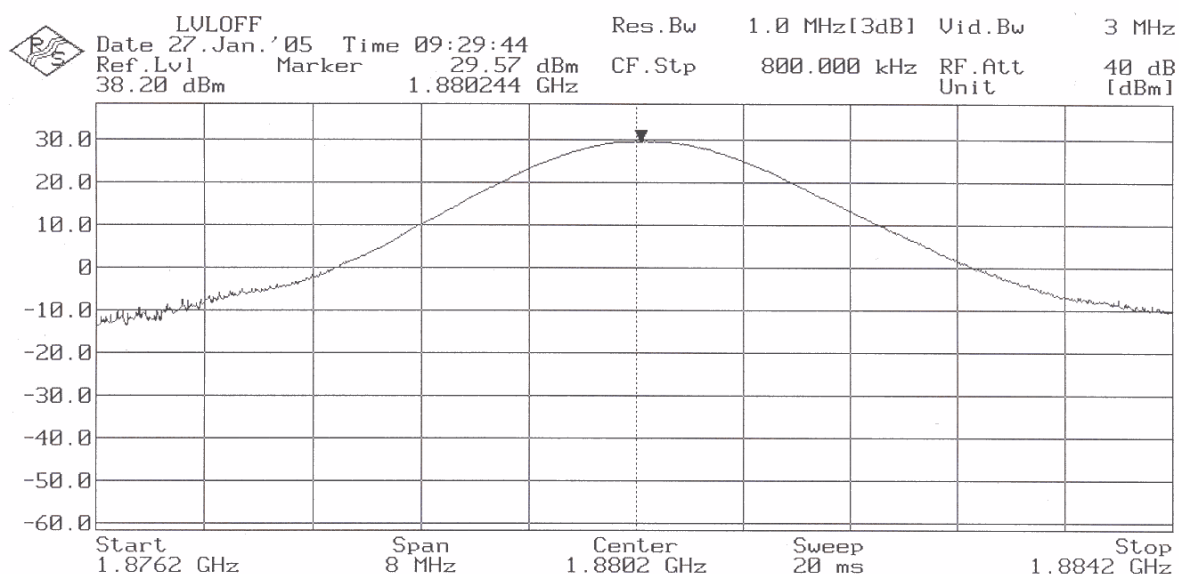

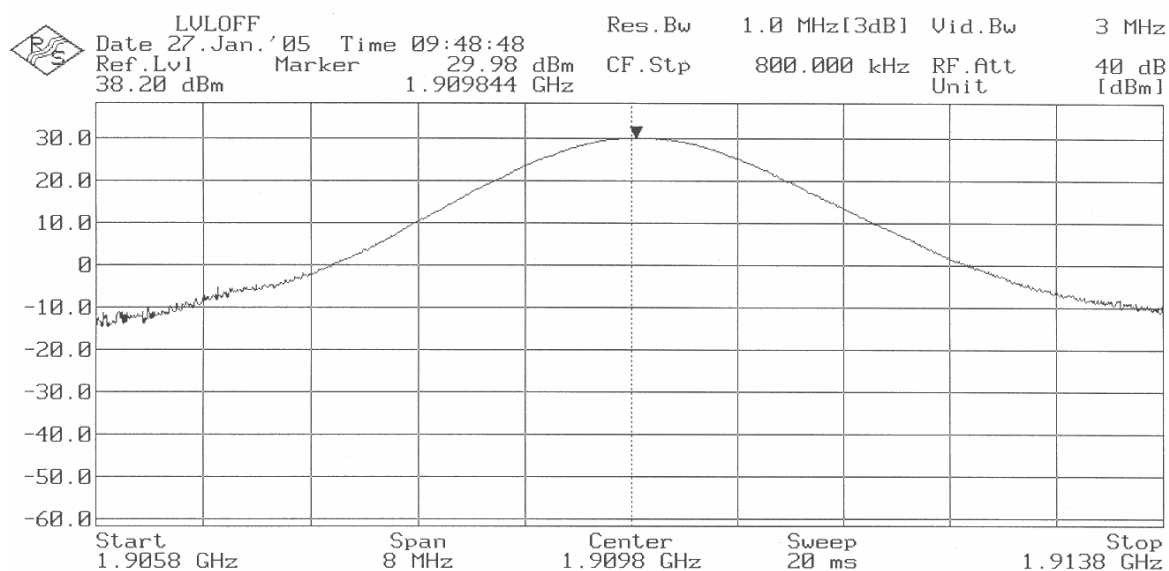

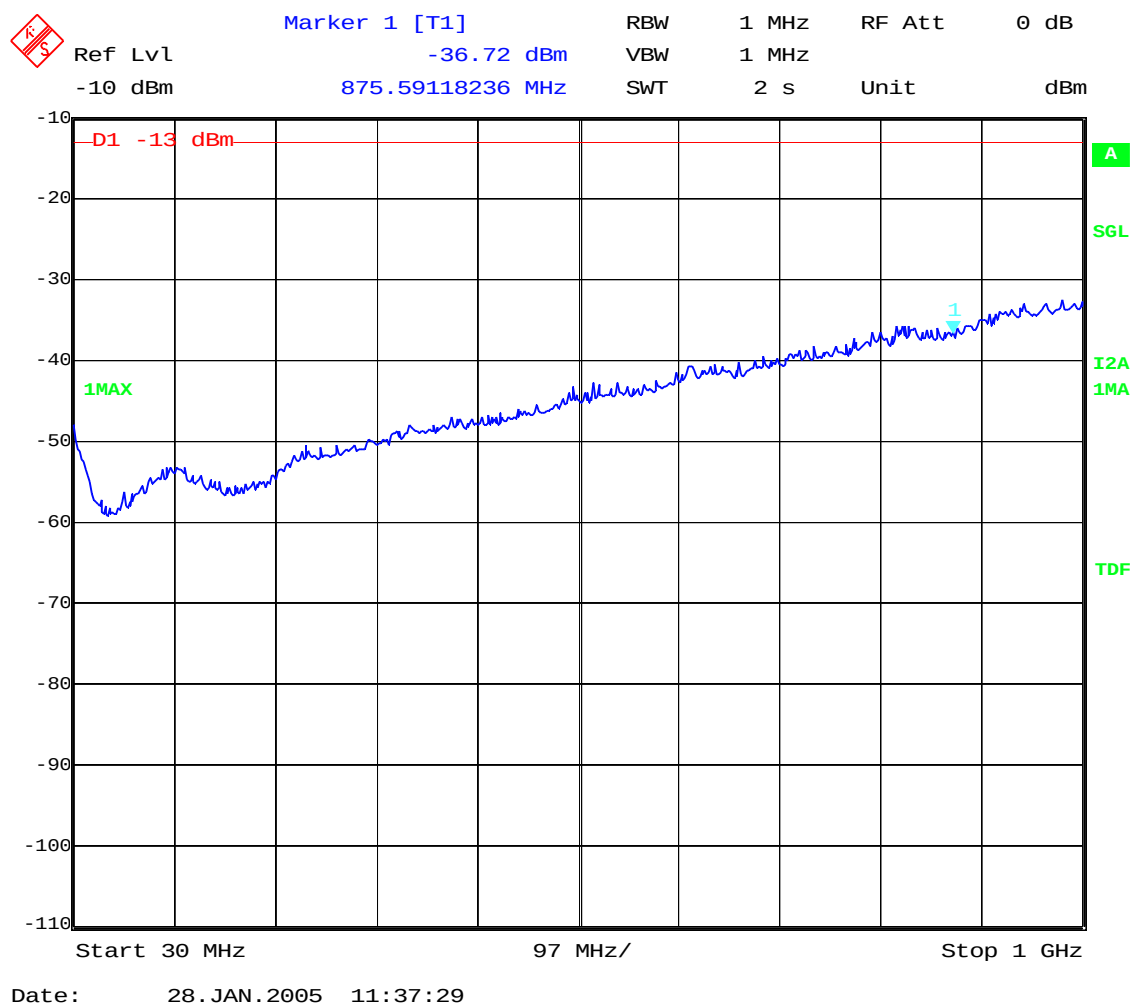

FREQUENCY RANGE 30 MHz-1000 MHz.

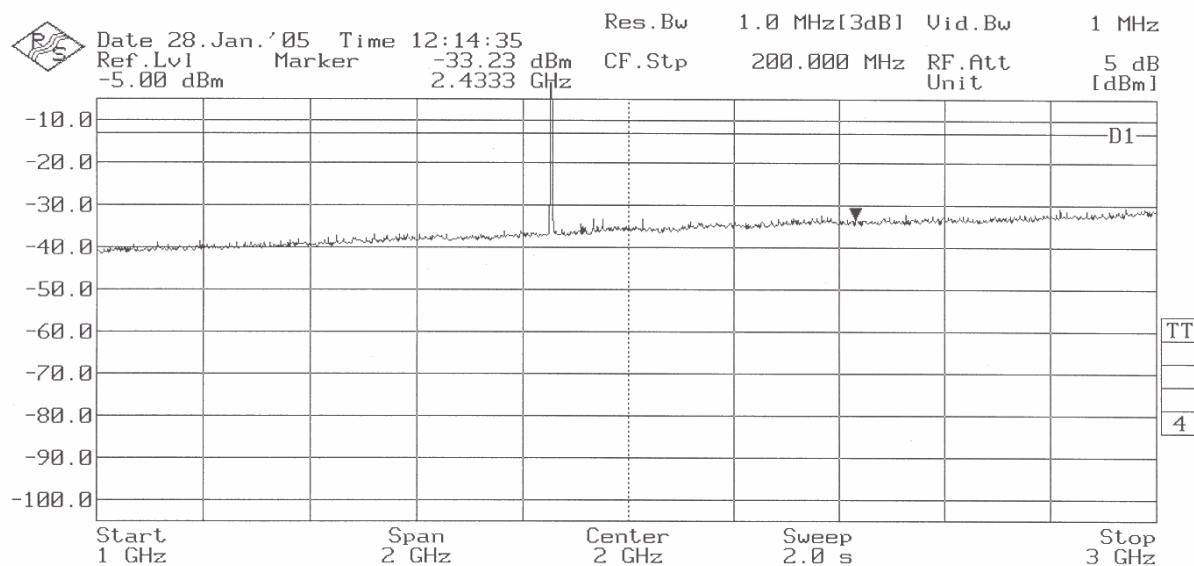

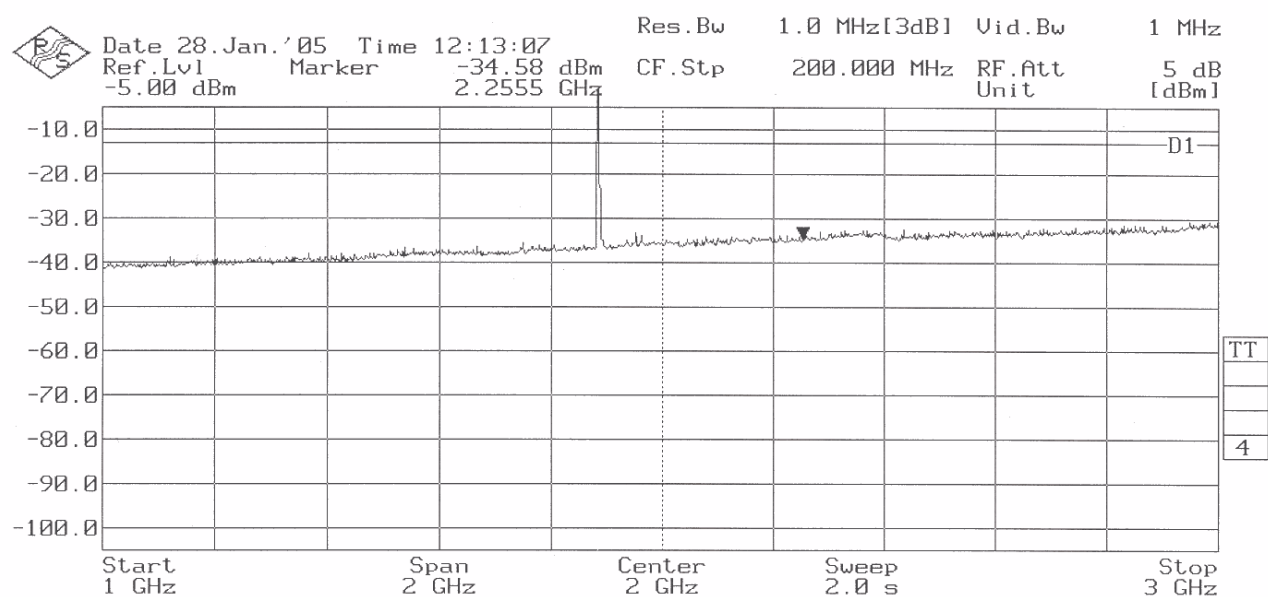

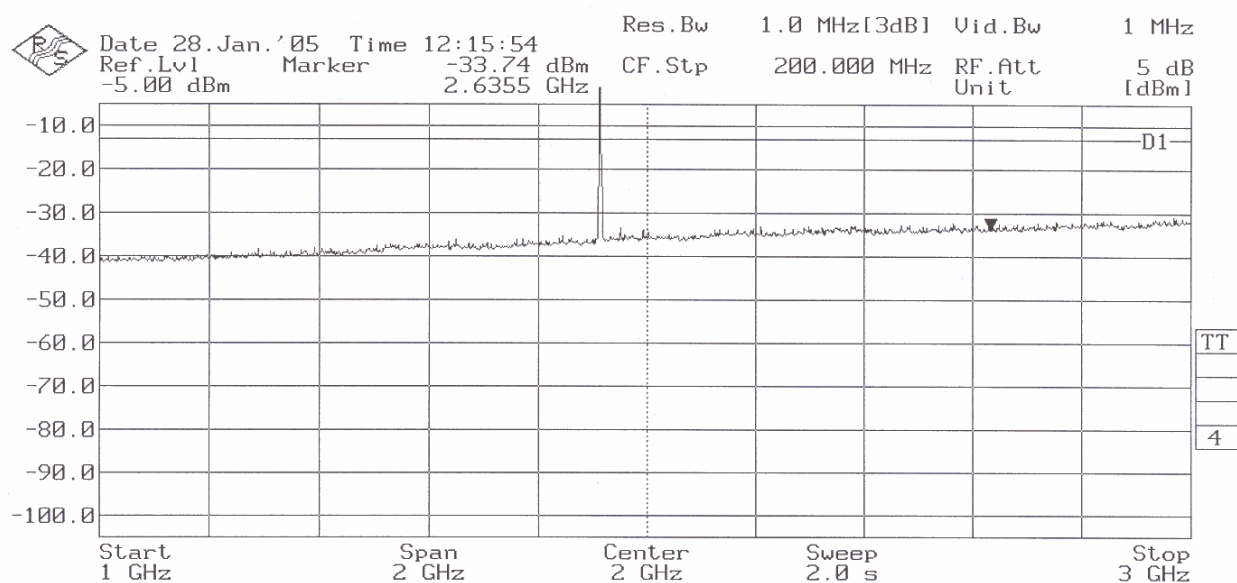

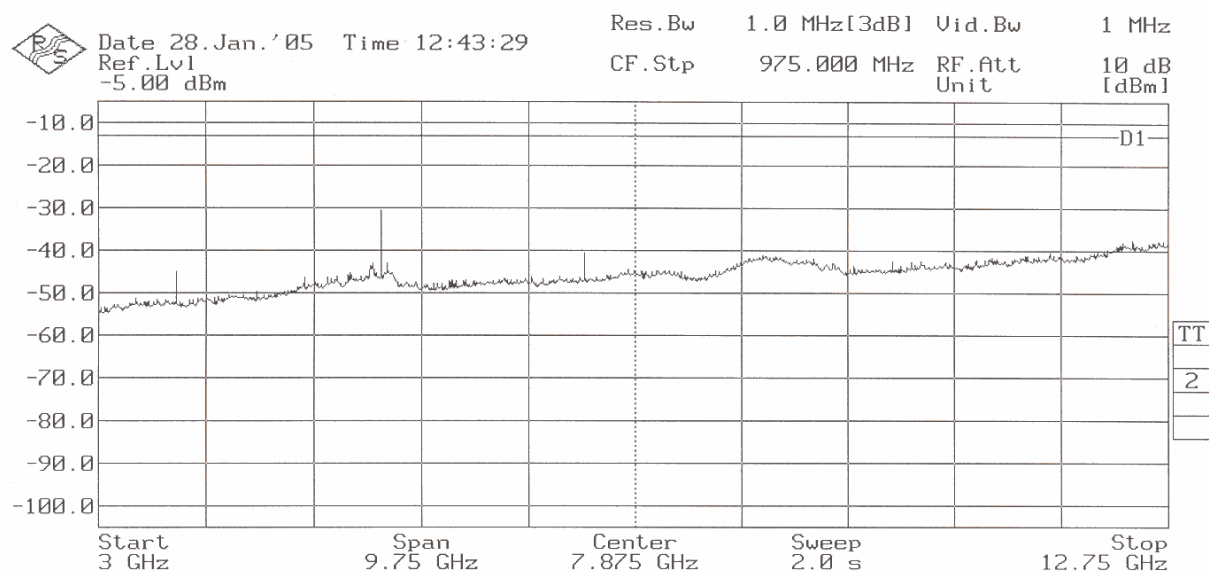

CHANNEL: LOWEST (1850.2MHz)



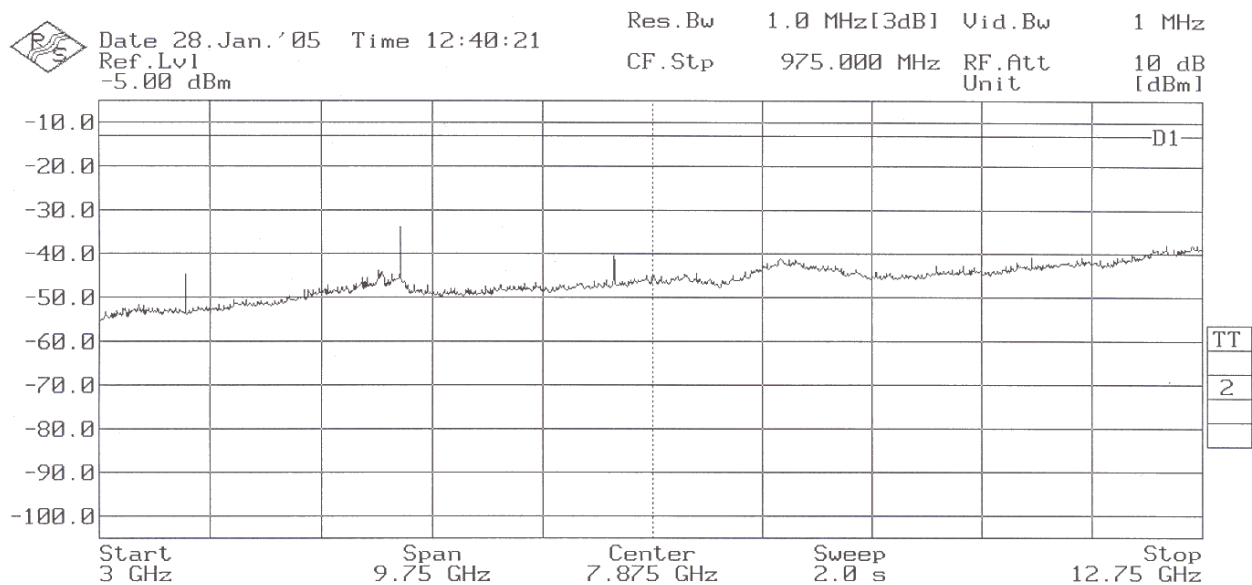

CHANNEL: MIDDLE (1880.2MHz)



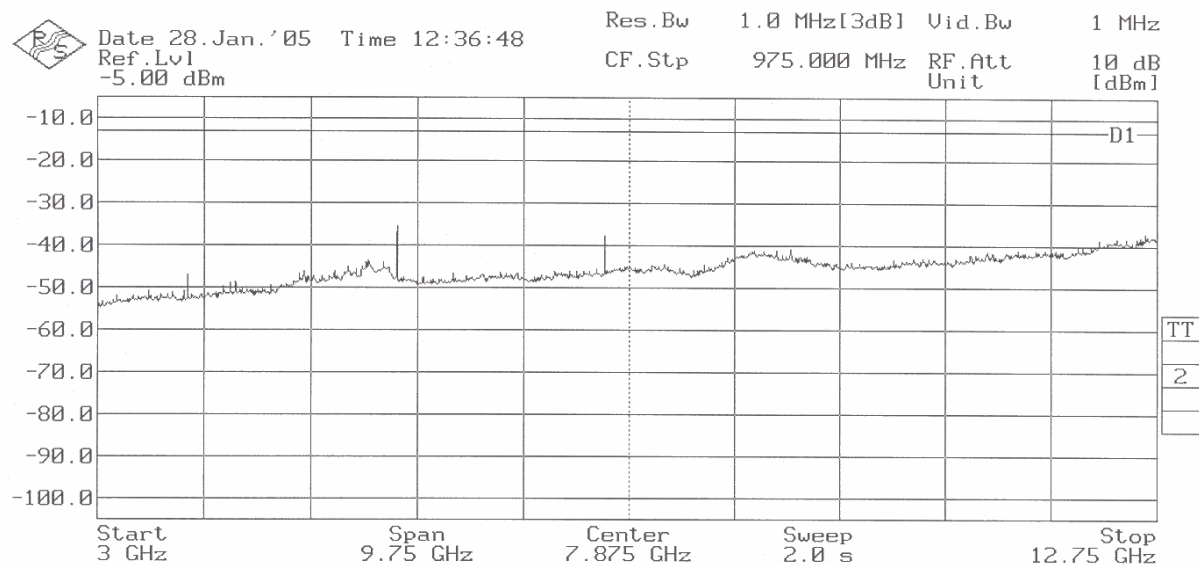

CHANNEL: HIGHEST (1909.8 MHz)



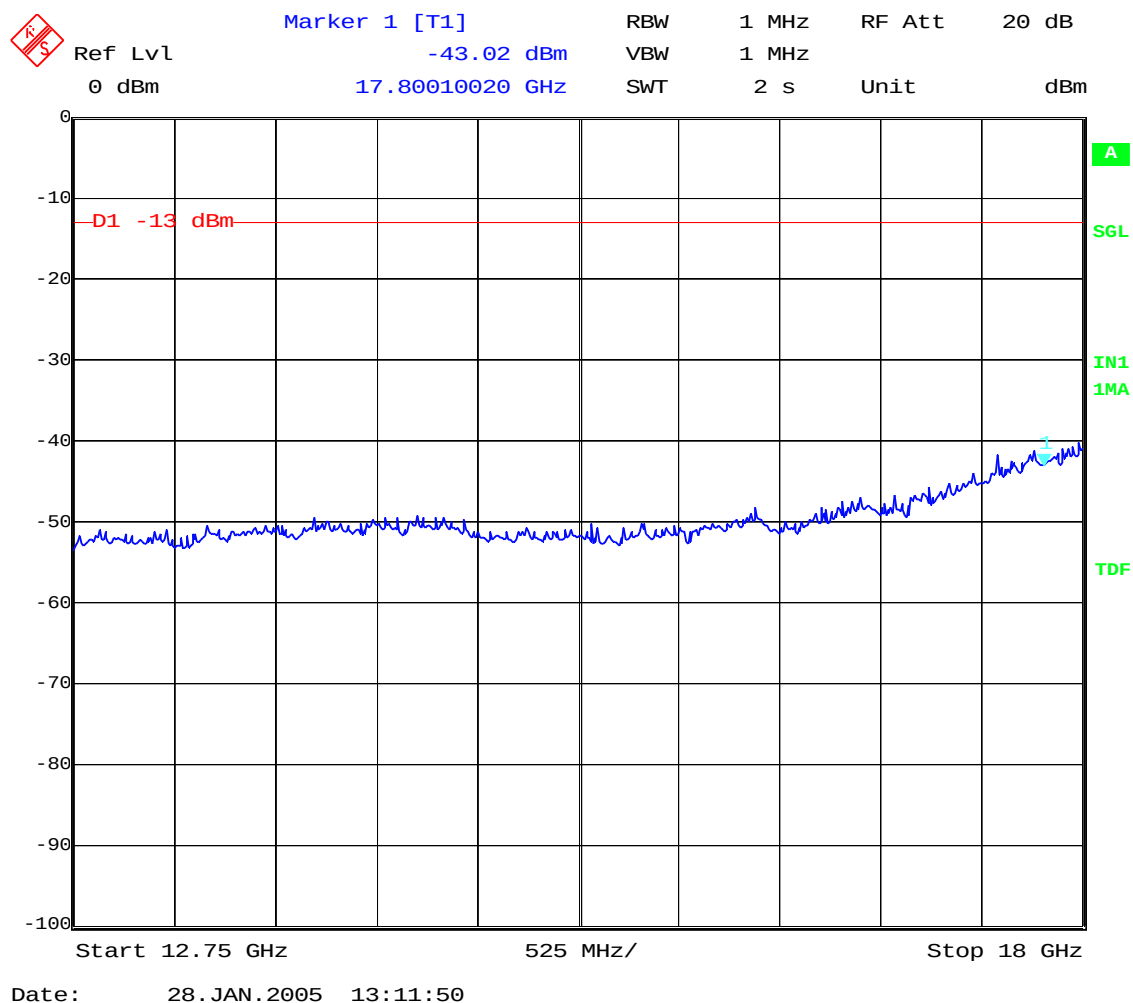

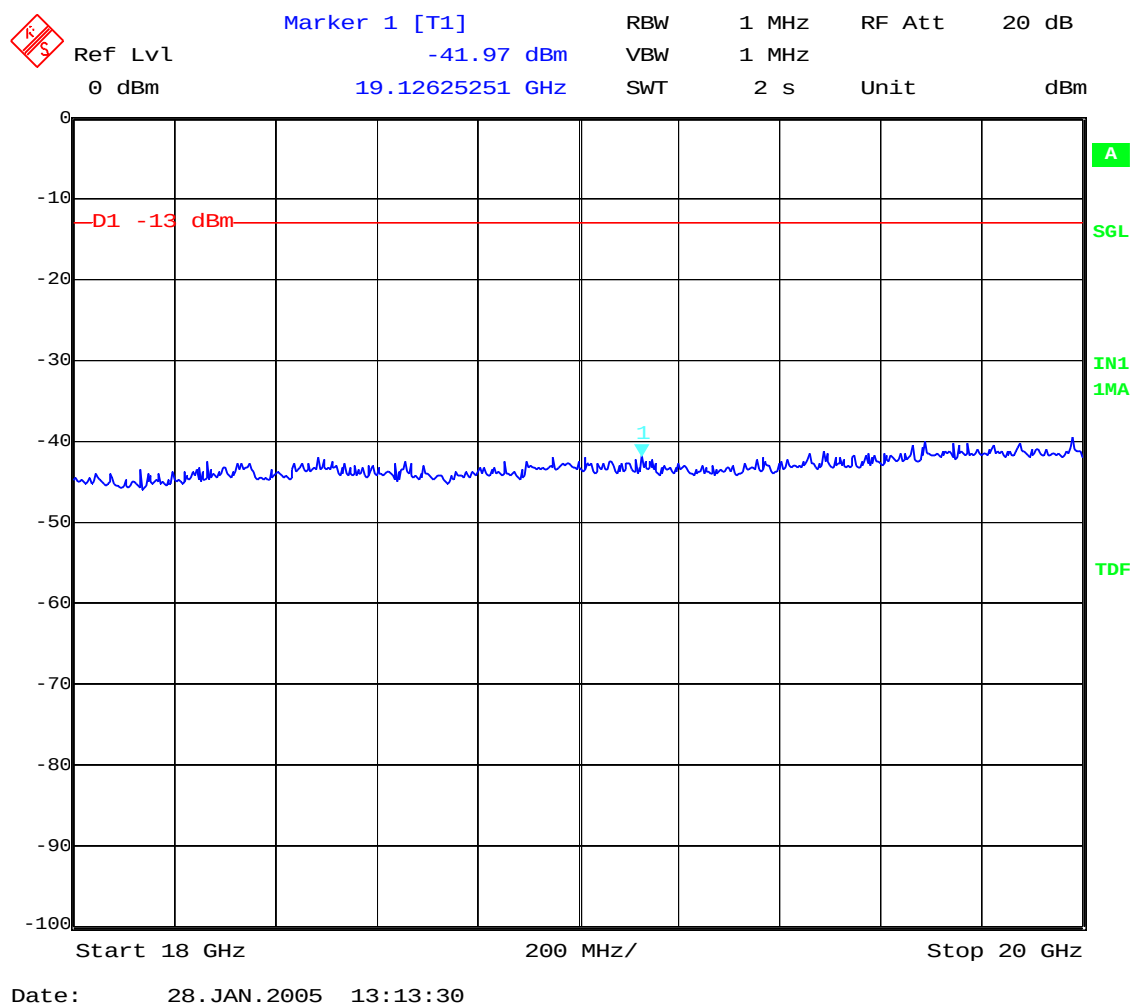
FREQUENCY RANGE 12.75 GHz TO 18 GHz.

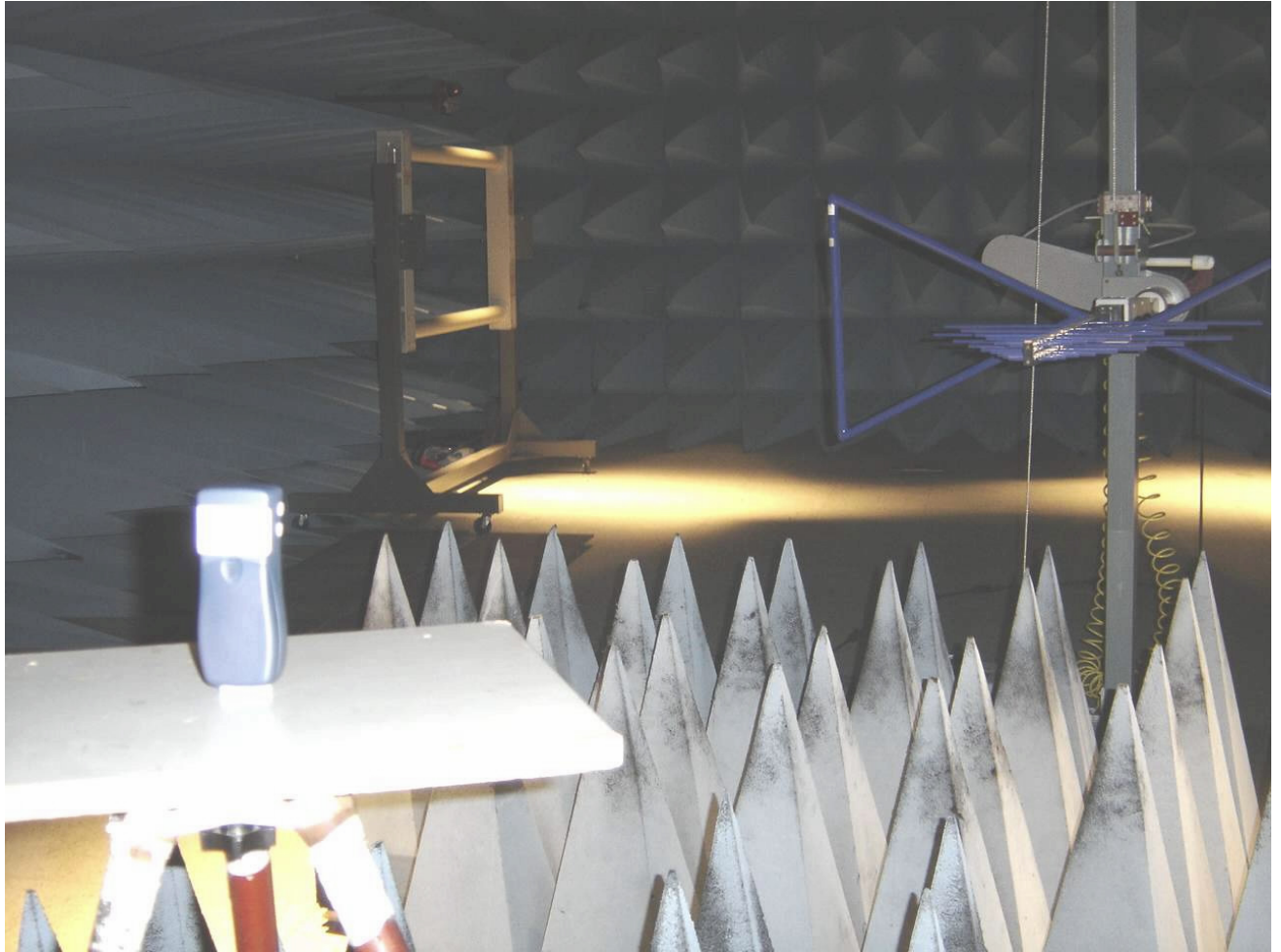

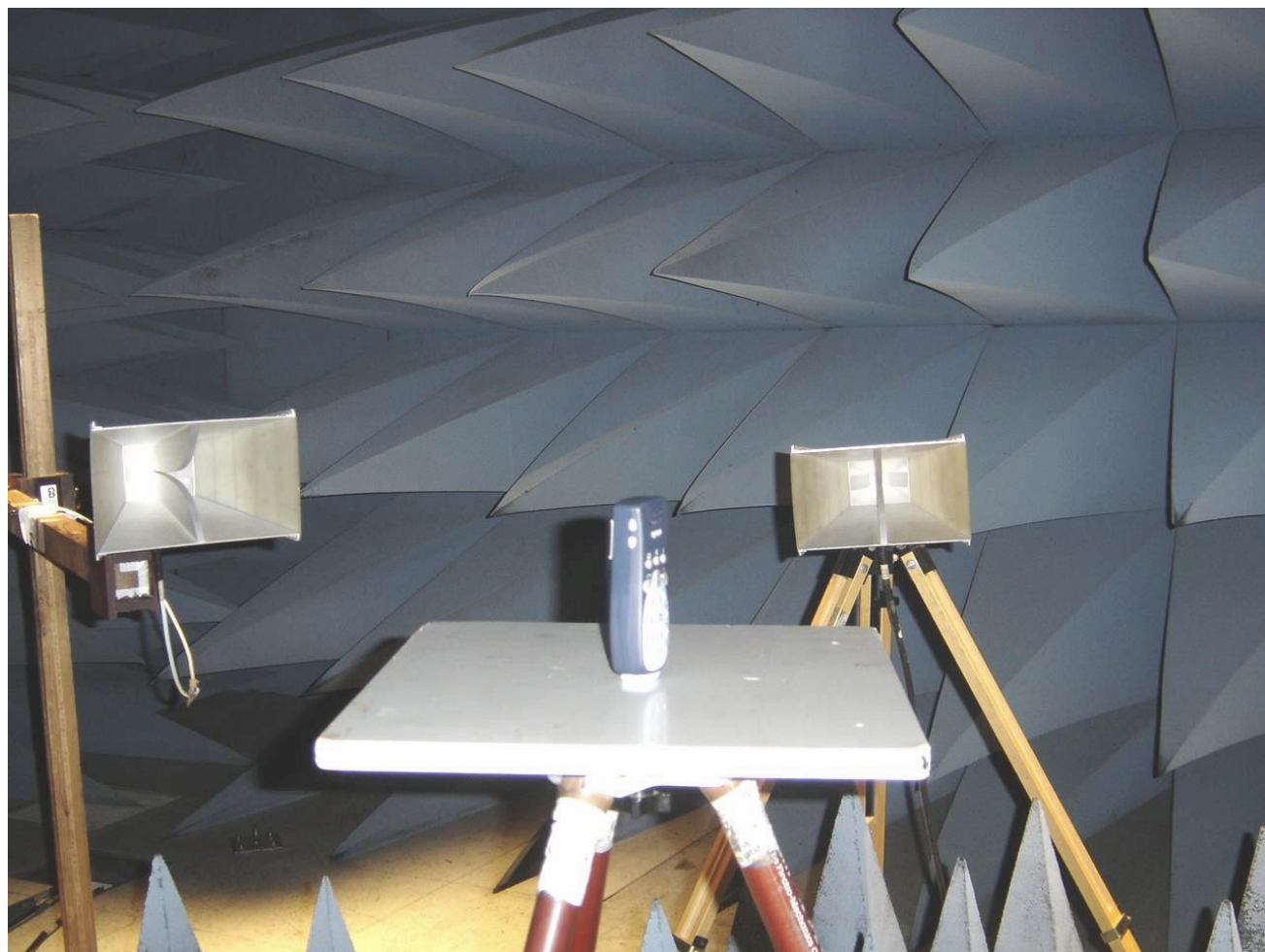
