



# **Sonar SASH and Receiver Operations**

## No auxiliary terminals R-SONR-REC-XA




Illustrated above is showing a receiver with and without wire terminals.

Both the Hook and Receiver run on batteries, which are included.

Hook uses a CR2430 and the receiver uses 3 AAA batteries

#### MODES

Sonar system can be purchased in 3 different frequencies to operate independently in the same area.

The hook has a two position switch on the bottom side setting A and B. The Receiver has corresponding switch A and B on the side.

Operation modes for R-SONR-REC-XA and R-SONR-REC-PXA Audio Beep and Alarm

#### B Mode

The hook will signal (Beep) once everytime the label lid is lifted up. If the label remains up a warming beep will sound once every 2 seconds. The receiver switch should be set to B. The receiver will mimic the hook remotely.

#### A Mode

The hook will alarm if lid opens and closes more than 4 times in 10 seconds. If the label lid is left open for longer than 6 seconds the hook will also alarm for 5 seconds. The Receiver will need to be set in the A mode to correspond with the hook's audio remotely. The receiver has a reset button on the top to turn off the audio, in alarm mode, but the hook will continue to alarm for 5 seconds.

#### Operation modes for R-SONR-REC-PXA with auxiliary ports

#### A Mode

The receiver's audio in A mode will mimic the hook beep and alarm. The output terminals will also activate when in the alarm sequence. The reset button will turn the alarm off on the receiver only. The hook will continue to alarm for 5 seconds.

#### **B** Mode

The receiver audio in B mode will only mimic the hook beep with no alarm sequence at the receiver. The auxiliary ports will still activate when receiving an alarm signal from the hook alarm.





## **INSTALL**

Insert hooks into pegboard of desired location without lower metal lock plate





Allow enough space between the displays so that product does not touch the surface below or obstruct other merchandise.



## **Lock Down**

- Insert the Lock Down Plate into the holes directly below the unit. Rotate up into place, until the screw inserts into back plate.
- Tighten screw with a Phillips Head Screwdriver. Close **Screw** Cover Cap when finished.






# **LOADING MECHANDISE**

Insert the merchandise by following the ramp upwards until product stops, then turn the knob counter clockwise until product catches hook.



WARNING: Do not overturn coil. Product will go all the way off the rear of the coil and become inaccessible.





Turn Knob counter clockwise until supported by the wire hook
