
The device has been evaluated to meet general RF exposure requirement. The device can be used in portable exposure condition without restriction.


COMPLIANCE WITH FCC REGULATIONS




POWER SUPPLY

Plug the included AC/AC power adapter (220V 50Hz 9V/800mA) into the AC Jack on the side of the unit and the other end is plugged into the wall outlet.



BATTERY OPERATION

- 1. Remove the Batteries Compartment Door.
- 2. Install 3 x DC1.5 V "C" Size (UM-2) batteries (not included) according to the polarity diagram inside the battery compartment.
- 3. Replace the Batteries Compartment Door.



LISTENING TO THE RADIO

- 1. Use the Mode Switch to toggle the AM or FM band.
- 2. Use the tuning knob to tune to your desired radio station.
- 3. Adjust the volume level.
- 4. Toggle to OFF when finish.

HINTS FOR BEST RECEPTION:

AM - The AM antenna is located inside the cabinet of the unit. If AM reception is weak, change the position of unit until the internal antenna picks up the strongest signal.

FM - To insure maximum FM tuner reception, fully extend the FM telescopic antenna and rotate it for the best FM radio reception.

LISTENING TO AN AUXILIARY AUDIO SOURCE

This unit provides an auxiliary audio signal input jack for connecting external audio devices like MP3 players, CD players and iPods (except iPod shuffle 3rd generation) and listen to your external source through the speakers of this system.

- 1. You need an audio cable (not included) with one 3.5 mm stereo plug on each end of the cable.
- 2. Plug one end of the cable into the AUX-IN jack located on the right hand side of the unit and the other end of the cable into the Line-out Jack or Headphone Jack of your external audio device.
- 3. Turn on the external audio device.
- 4. Turn on your unit by toggle the Mode to Bluetooth or FM or AM band.
- 5. The volume level can now be controlled through the volume control of your radio. Operate all other functions on the auxiliary device as usual.

Note:

- If you connected the Line-out Jack of your external device then you only need to adjust the • volume control of this system. If you connected the Headphone Jack of your external device then you may need to adjust both the volume control of your external device and the volume control of this system to find the most desirable volume setting.
- Remove the audio cable from AUX IN jack when you finish listening. Don't forget to switch off • the power on your external device as well.

BLUETOOTH OPERATION

If the unit has never been paired with a Bluetooth device before, you need to follow the

pairing instructions below to link the PJR2200BT with your Bluetooth device.

- 1. Use the Mode Switch to choose BT into Bluetooth Mode.
- 2. Bluetooth indicator will light on and flashing.
- 3. The unit will goes into Pairing/Discoverable mode.
- 4. Turn on the Bluetooth function of your Bluetooth device and enable the search or scan function to find the unit.
- 5. Select "PJR2200BT" from the device list when it appears on your device screen. If required, enter the pass code "0000" or "1234" to pair (link) the unit with your device.
- 6. After successfully pairing (linking) the Bluetooth enabled device a short beep will heard. The Bluetooth indicator will light on solid.
- 7. Adjust the volume level to your desire volume level.

Note: If you can't pair the unit with your Bluetooth enabled device, you can try to turn Off & On the power of your unit to solve the problem.
