# 6.2 Antenna Requirement


For intentional device. According to 15.203. an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device.

15.247(c) (1)(i) requirement:

(i) Systems operating in the 2400-2483.5 MHz bands that are used exclusively for fixed. Point-to-point operations may employ transmitting antennas with directional gain greater than 6 dBi provided the maximum conducted output power of the intentional radiator is reduced by 1 dB for every 3 dB that the directional gain of the antenna exceeds 6 dBi.



#### **Test Procedure:**

- 1. Remove the antenna from the EUT and then connect a low RF cable from the antenna port to the spectrum;
- 2. Set the spectrum analyzer: Span = approximately 2 to 3 times the 20dB bandwidth, centring on a hopping channel;
- 3. Set the spectrum analyzer: RBW >= 1% of the 20dB bandwidth VBW >= RBW. Sweep = auto; Detector Function = Peak. Trace = Max Hold.
- 4. Mark the peak frequency and -20 dB points bandwidth.







- 3. Allow the trace to stabilize. Use the marker-delta function to determine the separation between the peaks of the adjacent channels. The limit is specified in one of the subparagraphs of this Section. Submit this plot.





## Middle Channels: Carrier Frequencies Separated



# 6.7 Pseudorandom Frequency Hopping Sequence

## 6.7.1 Standard requirement

15.247(a)(1) requirement:

Frequency hopping systems shall have hopping channel carrier frequencies separated by a minimum of 25 kHz or the 20 dB bandwidth of the hopping channel, whichever is greater.

Alternatively. Frequency hopping systems operating in the 2400-2483.5 MHz band may have hopping channel carrier frequencies that are separated by 25 kHz or two-thirds of the 20 dB bandwidth of the hopping channel, whichever is greater, provided the systems operate with an output power no greater than 125 mW. The system shall hop to channel frequencies that are selected at the system hopping rate from a Pseudorandom ordered list of hopping frequencies. Each frequency must be used equally on the average by each transmitter. The system receivers shall have input bandwidths that match the hopping channel bandwidths of their corresponding transmitters and shall shift frequencies in synchronization with the transmitted signals.



## 6.7.2 EUT Pseudorandom Frequency Hopping Sequence


The pseudorandom sequence may be generated in a nine-stage shift register whose 5th and 9<sup>th</sup> stage outputs are added in a modulo-two addition stage. And the result is fed back to the input of the first stage. The sequence begins with the first ONE of 9 consecutive ONEs; i.e. the shift register is initialized with nine ones.

1) 9 kHz to 30 MHz emissions:





Now set the VBW to 10 Hz, while maintaining all of the other instrument settings. This peak level, once corrected, must comply with the limit specified in Section 15.209. If the dwell time per channel of the hopping signal is less than 100 ms, then the reading obtained with the 10 Hz VBW may be further adjusted by a "duty cycle correction factor", derived from 20log (dwell time/100 ms), in an effort to demonstrate compliance with the 15.209 limit. 





## 6.11 Band Edges Requirement

(d) In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph (b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB. 






