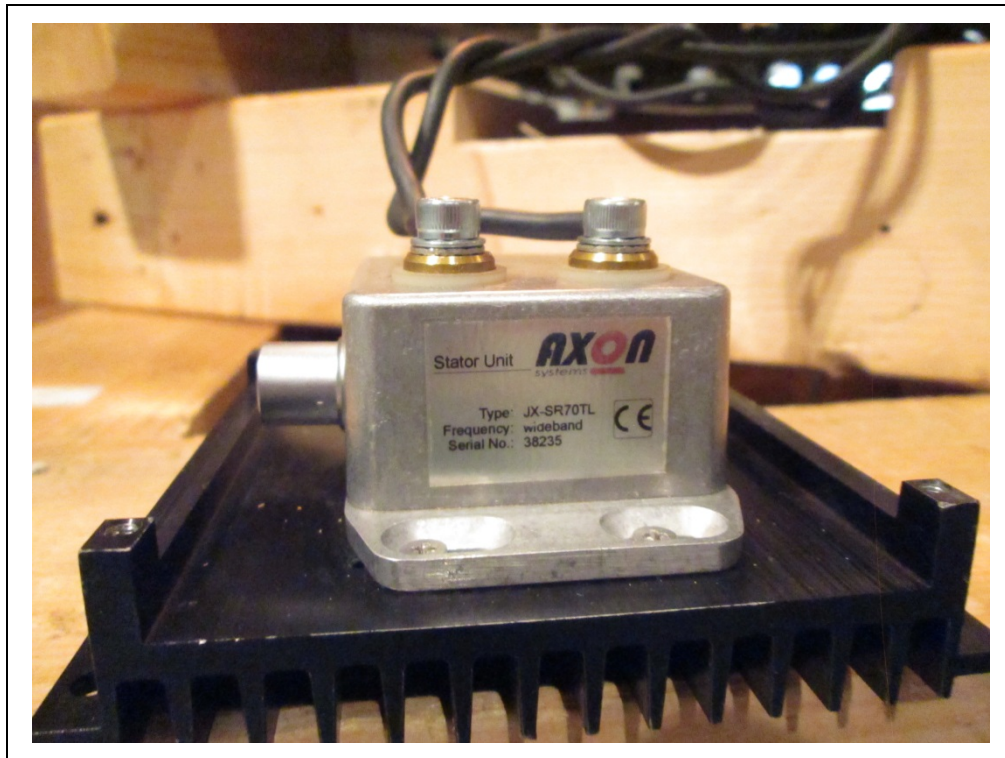


Photograph A3-5: Channel 2 Axon system control unit #41106, label

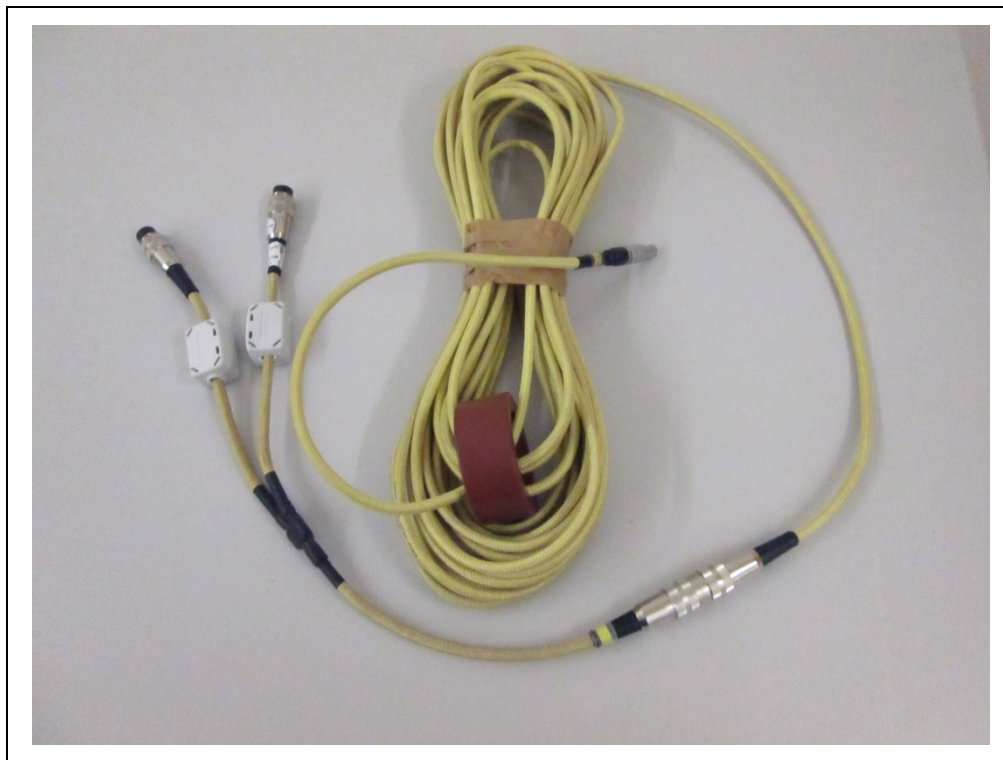


Photograph A3-9: Power supply TRIO-PS/1AC/24DC/5, front

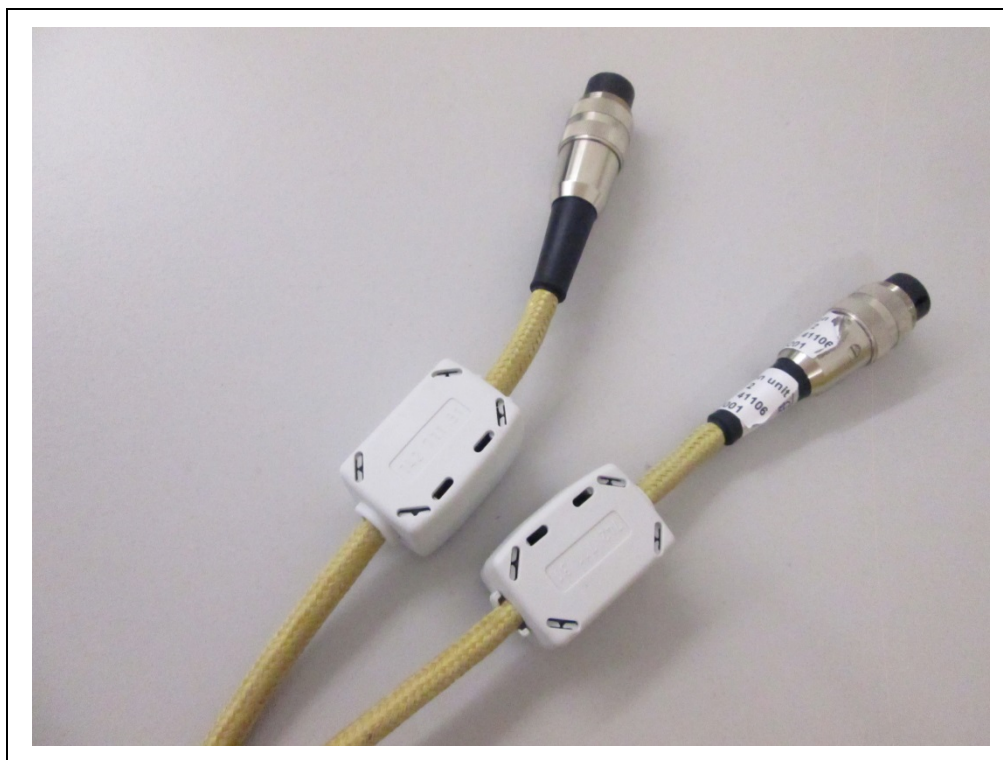


Photograph A3-10: Power supply TRIO-PS/1AC/24DC/5, back

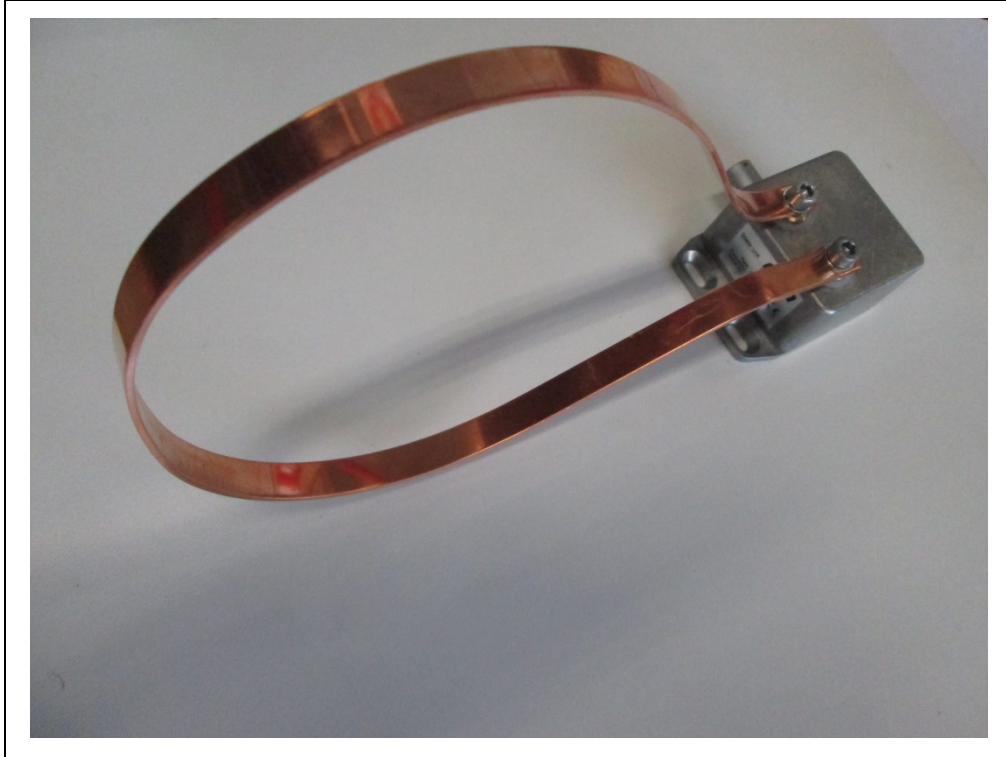


Photograph A3-13: Equipment for frequency stability tests
