WS2G

Programing/Enrolling WS2G

- 1. Program as Day Zone (05) on loop 3
- 2. Takes 3 minutes and 3 seconds to trip and 3 minutes and 3 seconds to reset.
- 3. 2GIG panel firmware must be 1.10.1 or higher.

General information

- 1. Unit made to work with 2GIG wireless alarm panel only.
- 2. Low battery on WS2G will report to 2GIG Panel
- 3. Use only probe that attracted to WS2G
- 4. Transmitter operation temperature 20F to 120F
- 5. In a hot area like an attic remote the probe into hot area but put transmitter in controlled area.
- 6. Unit trips when water covers both metal contact points.

- 1. One complete water sensor
- 2. 4 mounting screws
- 3. Strip of double sided tape.
- 4. 1 Panasonic CR123A 3V lithium battery
