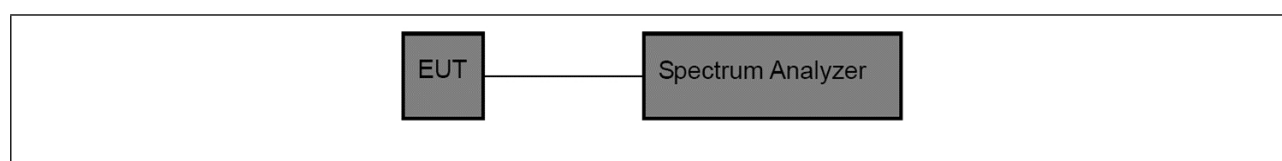
## 6. Channel Separation
